Dear Ms. Steinberg:

On February 5, 2025, the Permanent Subcommittee on Investigations ("PSI" or "the Subcommittee") wrote to you as part of an inquiry into potential conflicts of interest raised by the participation of The Boring Company Founder Elon Musk in the Department of Government Efficiency ("DOGE"). As the Subcommittee's letter detailed, Mr. Musk's dual roles at The Boring Company and DOGE could enable The Boring Company to both gain significant advantages over its competitors and improperly influence government agencies that regulate and oversee The Boring Company. Your February 14 letter is blatantly, brazenly unresponsive and inadequate. The Boring Company has purposefully failed to answer the Subcommittee's questions, magnifying concerns that Mr. Musk and his companies are intentionally indifferent to his growing power over federal agencies that regulate or contract with these companies. The Boring Company's refusal to simply confirm that it will preserve all records pertaining to DOGE or related government activities indicates that Mr. Musk's commitment to being "maximally transparent" is toothless, and fails to assuage mounting unease that the companies he owns or controls will likely benefit immensely from his new role.<sup>2</sup>

Recent public reporting suggests that Mr. Musk has already begun using DOGE to target agencies responsible for investigating his questionable business practices.<sup>3</sup> The information sought in the Subcommittee's letter is essential to providing the transparency to which the American people are entitled and which Mr. Musk promised in a press conference just last week.<sup>4</sup> Merely asserting that The Boring Company will remain "vigilant in ensuring that it is following" laws regarding conflicts of interest fails to live up to Mr. Musk's promise or to address concerns about The Boring Company's potential liability.

While The Boring Company was the only one of Mr. Musk's companies to admit in its response to PSI that current and former employees "have chosen to engage in activities related to" DOGE, assurances that "they have done so on their own volition" are similarly inadequate to address the Subcommittee's concerns, Indeed, public reporting has indicated that Mr. Musk put an executive of The Boring Company in charge of hiring DOGE personnel.<sup>5</sup> Your letter, like the other responses PSI received from Mr. Musk's intertwined business interests, largely recycles boilerplate material about your company's purported accomplishments without addressing any of the specifics of the Subcommittee's questions. Indeed, the letters to PSI from Mr. Musk's businesses are so similar that they could all have come from the same source. Additionally, The Boring Company's suggestion that its operations are separate and apart from the activities of DOGE is irreconcilable with Mr. Musk's actions and public statements. For example, public reporting indicates that DOGE may have gained access to vast troves of data from the Occupational Safety and Health Administration, which has assessed fines for unsafe working conditions at a Las Vegas tunnel project that The Boring Company is currently contesting. The Boring Company's business, in other words, is inextricably bound up with the very work that Mr. Musk is now conducting at DOGE.

In the spirt of Mr. Musk's stated goal of "trying to be as transparent as possible," I reiterate my request that you answer the Subcommittee's questions about how your company is managing Mr. Musk's host of conflicts and those of other company personnel. In addition to answering the Subcommittee's questions by March 4, 2025, please also confirm by the same date that The Boring Company will preserve all records identified by the Subcommittee's February 5 letter.

Please contact the Subcommittee should you have any questions about responding to these requests. Thank you for your attention to this matter.

I write in response to your February 5, 2025, letter to Ms. Ashley Steinberg of The Boring Company.

The Boring Company (TBC) was founded in 2017 by Elon Musk to revolutionize transportation. TBC creates safe, fast-to-dig, and low-cost transportation, utility, and freight tunnels. TBC takes advantage of full vertical integration to increase speed and reduce costs. TBC designs the Tunnel Boring Machines (TBMs), constructs the TBMs, designs the tunnels and stations, operates the TBMs to build the tunnels, and runs the resultant subsurface Loop transportation systems.

TBC has headquarters in both Las Vegas, Nevada where Vegas Loop has safely transported more than two million passengers, and Bastrop, Texas, where TBC designs, constructs, and tests the TBMs. We believe that TBC is the only active transportation TBM manufacturer in the nation that has been owned by United States persons for its entire history.

The Boring Company employs over 500 workers across the country in a variety of fields, including engineering, fabrication, and construction. Our workplace and employee wellness programs encourage individuals to lead healthy lifestyles, including activities such as exercising, spending time with friends and family, and engaging in pursuits that are meaningful and interesting to them outside of their professional obligations. The Boring Company frequently grants personal time off and leaves of absence to employees who need time to recharge, invest time in a personal interest, or pursue a service project so that they can return to the company ready for our next transformative initiative.

I can confirm to you that certain current and former employees of The Boring Company have chosen to engage in activities related to the Department of Government Efficiency ("DOGE"). Those that have made that choice have done so on their own volition, and any time and resources they are using to do so are not subsidized in any way by The Boring Company. While The Boring Company is a private company and is not itself affiliated with DOGE, we applaud those who have chosen to take an active role in public service at this critical time in American history.

The Boring Company has and will comply with all applicable legal obligations, including those regarding employee conduct, however it will not provide any confidential employee information.



Additionally, to the extent that The Boring Company is subject to any laws regarding conflicts of interest, it will remain – as it always has been – vigilant in ensuring that it is following such laws.

I write in response to your February 5, 2025 letter.

Neuralink is a medical device company dedicated to restoring autonomy to individuals with unmet medical needs.

Our device, the Link, is a fully implantable, cosmetically invisible, wireless brain-computer interface (BCI) intended to restore autonomy to people with paralysis due to spinal cord injury or amyotrophic lateral sclerosis (ALS). With the Link, individuals who have lost agency over their arms and legs as a result of spinal cord injury or ALS can now operate their phones, computers, and assistive prosthetic limbs directly with their thoughts.

In response to the question raised in your letter, with the exception of Elon Musk, to our knowledge, no current Neuralink employee has performed services on behalf of the Department of Government Efficiency ("DOGE").

Neuralink is committed to complying with all applicable laws and regulations. We are not aware of any reason to believe that Neuralink is not in compliance.

SpaceX's Falcon 9 and Falcon Heavy are the world's most reliable rockets and have successfully launched nearly 450 times since 2010, restoring the U.S. to a position of global leadership in space launch, ahead of China, Russia, and Europe. Falcon rockets are certified and on contract for the full range of missions for the Defense and Intelligence Communities and NASA. X Corp. operates the X social media platform in the United States. X serves as the global town square and provides hundreds of millions of users each month with an opportunity to freely express themselves and engage in healthy debate. We believe open and respectful discourse is the single best way for America, and indeed humanity, to thrive. Although we celebrate those Americans who have chosen to commit some or all of their time to public service, X Corp. is a private corporation and not affiliated with DOGE or responsible for the decisions or actions of DOGE employees.

X Corp. takes seriously its legal obligations, including our responsibility to comply with all applicable laws and regulations, to address potential conflicts of interest, and to protect sensitive information. X Corp. has not attempted in any way to use DOGE or any individual involved in DOGE to gain unlawful access to proprietary government data or for any other unlawful purpose. Nor does X Corp. have any information to suggest that its employees are violating any legal or ethical obligations.

You also ask for detailed information about current and former X Corp. employees who are now working with DOGE in a variety of capacities, both formal and informal. X Corp. does not disclose confidential employee information absent a legal obligation to do so. But I can assure you that X Corp. requires its employees to comply with all applicable legal obligations, including conflict-of-interest rules. Indeed, X Corp. has a robust Code of Conduct and provides specific Conflicts of Interest & Outside Projects Guidance to its employees, in addition to a 24/7 Ethics Helpline. We are confident that our employees are following the law and applaud them for their service.
