Dear Mr. Zuckerberg:

Pursuant to Senate Resolution 94 (119th Congress), the Permanent Subcommittee on Investigations ("the Subcommittee") is conducting a review of Meta Platforms, Inc.'s alleged work to build censorship tools for the Chinese Communist Party (CCP) as part of its efforts to gain entry in the Chinese market, including its communications with CCP officials.¹

According to recent reports on a book, titled *Careless People*, written by former Facebook executive Sarah Wynn-Williams, in 2014, Facebook allegedly developed a "three-year plan" to gain access to the Chinese market (codenamed "Project Aldrin").² Facebook's plan reportedly included more engagement with the CCP, and later included plans to partner with a Chinese company to build censorship tools and provide the CCP with user data.³ Further, Facebook's censorship efforts on behalf of the CCP allegedly extended to dissidents outside of China, including in the United States.⁴ These accounts are corroborated by internal records documenting these efforts reviewed by the Subcommittee.

To assist the Subcommittee's review, please provide the following by April 21, 2025.

- 1. All records⁵ referring or relating to Facebook/Meta's preparations and operations within China from January 1, 2014, to the present, including but not limited to:
 - a. all communications or records of meetings with Chinese government officials, including but not limited to Lu Wei, Zhao Zeliang, and the Cyberspace Administration of China (CAC);
 - b. all records related to Facebook/Meta's subsidiaries and partners in China, including Hony Capital, IvyCo, Leaplock, Ivy Zhang, or Youge Internet Technology;
 - c. all records related to Pacific Light Data Communication, Dr. Peng Group, and the proposed China or Hong Kong operations of the Pacific Light Cable Network; and
 - d. all records related to Meta's launch of apps in China, including Colorful Balloons, Flash, Boomerang, Layout, Hyperlapse, and MSQRD.
- 2. All records referring or relating to the use of artificial intelligence models developed by or in collaboration with Facebook/Meta, including but not limited to Llama, by the People's Liberation Army, DeepSeek, or any instrument of the CCP.
- 3. All communications referring or relating to "Project Aldrin." 6
- 4. A list of the names and titles of all employees who worked on or participated in Facebook's/Meta's alleged three-year plan for China or "Project Aldrin."
- 5. All records, between Facebook/Meta and any national government entity or representative thereof, from January 1, 2014, to the present, referring or relating to any effort to censor or otherwise remove content at the government's request.
- 6. All communications referring or relating to whether and how to censor or otherwise remove content at the request of a national government entity or representative thereof.
- 7. Please identify all accounts and produce all content that has been removed or restricted by Facebook/Meta related to, or based on, a request from Chinese officials or entities, as well as who at Facebook/Meta was responsible for final approval of the removal or restriction.
