#### 1 PROCEEDINGS

- 2 HSGAC Majority Good afternoon. This is a transcribed
- 3 interview of Senior Special Agent Witness , being
- 4 conducted by the Senate Committee on Homeland Security and
- 5 Governmental Affairs and the Senate Permanent Subcommittee
- 6 on Investigations.
- 7 This interview was requested by Committee Chairman
- 8 Gary Peters, Ranking Member Rand Paul, Subcommittee
- 9 Chairman Richard Blumenthal, and Ranking Member Ron
- 10 Johnson. This is a part of the Committee's investigation
- of the July 13th, 2024, assassination attempt on former
- 12 President Trump, and the U.S. Secret Service planning in
- 13 advance of and response related to the events in Butler,
- 14 Pennsylvania, on July 13th, 2024. This interview is being
- 15 conducted in the Pittsburgh field offices for the Secret
- 16 Service.
- 17 At the outset, I want to note that 22 minutes prior to
- 18 the beginning of this interview, we were provided 4 pages
- of handwritten notes and 9 pages of typewritten notes,
- 20 specifically relevant and in response to the July 24th
- 21 document requests these four officers had made to the
- 22 Secret Service. These are, we understand, notes of Senior
- 23 Special Agent Witness.
- We are grateful to counsel for identifying them and
- 25 ensuring that Secret Service provided them to us. However,



- our offices are extremely disturbed at the hour in which
- they were provided and want to ensure that we will receive
- 3 all responsive records, including notes and information of
- 4 the individuals we have requested to interview. Should
- 5 this continue, we will consult with the chairman about
- 6 additional steps we feel are necessary
- 7 On July 25th, 2024, Chairman Peters, Blumenthal, and
- 8 Ranking Members, Paul and Johnson requested voluntary
- 9 transcribed interviews with U.S. Secret Service personnel,
- 10 including Witness Today, we are going to provide
- 11 introductions of the offices and their staffs involved so
- 12 that you know who you are speaking with, and talk through
- 13 how we intend to proceed today. First, can you please
- 14 state your name and title for the record?
- 15 Witness Senior Special Agent Witness .
- 16 HSGAC Majority And Witness I'd ask that your counsel
- 17 take a moment to introduce themselves.
- MR. Witness Counsel Good afternoon. This is Witness Counsel along
- 19 with me, my law partner, Witness Counsel We appreciate the
- opportunity to be able to appear virtually and any
- 21 accommodation that obviously might need to be made, which
- 22 hopefully will be none, during the course of this if agent
- Witness wishes to talk to us and to take a break. But we're
- 24 grateful to that, and with that, I'll let you get on with
- 25 it.



- 1 HSGAC Majority And we ask now the agency counsel
- 2 introduce themselves.
- MS. Agency Counsel Thank you. This is Agency Counsel from
- 4 the Chief Counsel's Office from the Secret Service. If
- 5 it's appropriate, I'll go ahead and read the statement to
- 6 the group from the Secret Service and the Department
- 7 regarding privileges.
- 8 "The Secret Service and the Department of Homeland
- 9 Security have made available to the Committee, consistent
- with requests from the chairman, information and records
- 11 that would not be publicly released. This includes
- 12 information and records covered under the Privacy Act,
- 13 personnel, and other personal privacy information, for
- 14 official use only information, intelligence and law
- enforcement-sensitive records, and raw intelligence
- 16 information.
- While the Secret Service and the Department have made
- 18 this information and these records available to the
- 19 Committee, we continue to assert that such information and
- 20 any discussion of such information is not intended for
- 21 public disclosure. The Secret Service and the Department
- 22 are not waiving any protections and for the purposes of
- 23 administrative efficiency and to promote constructive
- 24 dialogue during the transcribed interview, are making this
- assertion at the outset to preserve all assertions of



- 1 protection from public release, or disclosure of
- 2 information or records used during the transcribed
- 3 interview.
- 4 The transcript and any attachments are protected from
- 5 dissemination to the same extent as the documents and
- 6 information they're based on. We would ask that you please
- 7 consult with the Secret Service and the Department prior to
- 8 any public release or disclosure."
- 9 The Secret Service and the Department have not
- 10 consented to, and we were assured that there will not be
- any video recording of the interview."
- I would just note for the record for purposes of
- 13 clarity that we have instead of a stenographer here, we
- 14 have an audio recording being made prior to a
- 15 transcriptionist taking that recording. So I just wanted
- 16 to note that we are all in the same understanding that the
- 17 interview will be transcribed at the at the end of this
- 18 process, and we'll end up with a hard copy transcript.
- 19 Thank you.
- 20 HSGAC Majority And our understanding as well is that the
- 21 sole recording here today will be for the purposes of
- 22 transcription only for a record. That record will be the
- 23 property of the Committee. It will be considered a
- 24 Committee record. The Committee will provide opportunities
- 25 for counsel to provide factual corrections to that record



- with respect to any non-classified, but non-public
- 2 information produced or discussed today, including
- 3 information that may implicate business-sensitive, law
- 4 enforcement-sensitive, FOUO, or other sensitivities.
- 5 We would invite the agency to make any notifications
- 6 it wishes us to consider. We are happy to consider them.
- 7 However, the Committee will only be bound by Senate and
- 8 Committee rules in how it chooses to use this information.
- 9 I will note that the Committee's practice and what we
- intend to follow here is that for any public-facing
- information, including reports that we intend to produce as
- 12 a result of our investigative work here, our practice has
- 13 been to provide excerpts of non-public information we
- intend to use in those reports to the individuals impacted,
- and to offer an opportunity to provide any factual
- 16 corrections in advance of publication. We intend for there
- to be a public report here, and we intend to honor that
- 18 practice as well.
- MS. Agency Counsel Thank you.
- 20 HSGAC Majority As I mentioned, there are four different
- offices conducting this interview today. We are doing so
- jointly in the interest of a bipartisan investigation, and
- 23 are going to introduce ourselves so that you understand who
- 24 you're talking to Witness
- I will start with myself and our office. My name is



- 1 HSGAC Majority . I am the Chief Investigative Counsel for the
- 2 majority staff for Senator Gary Peters, the chairman of the
- 3 full Committee, the Homeland Security and Governmental
- 4 Affairs Committee. I'm joined by my colleague HSGAC Majority,
- 5 Senior Investigative Counsel, and my colleague HSGAC MAJORY
- 6 HSGAC Majority Senior Investigator, both with the majority staff.
- 7 And for PSI majority, who I believe is appearing remote.
- PSI Majority on behalf of the Majority,
- 9 and I'm here with Senior Counsel PSI Majority .
- HSGAC Minority My name HSGAC Minority , Chief Counsel
- 11 for Minority Ranking Member Paul. I have with me here my
- 12 colleague HSGAC Minority .
- PSI Minority Good afternoon. My name is PSI Minority
- 14 PSI Minority I'm the Deputy Staff Director for Ranking Member
- 15 Ron Johnson on the Permanent Subcommittee on
- 16 Investigations. I'm joined here with my colleague, PSI Minority
- 17 PSI Minority He's the Chief Counsel.
- 18 HSGAC Majority And if at any time during our interview you
- 19 want clarification both on who is asking a question or a
- 20 clearer question, if we ask a compound question, or
- 21 something that's difficult to understand, we are happy to
- 22 rephrase our questions, and happy to provide any contextual
- 23 information that will be helpful to you in answering our
- 24 questions.
- We will do our best as well during the interview to



- 1 limit the number of people asking a question at a given
- time so that you don't have to hop around to who you're
- 3 speaking to. And we're going to try and be efficient at
- 4 our time and divide on the hour a short break in between.
- 5 Should you need any breaks in addition to that, please just
- 6 let us know.
- 7 The reporter is going to create a verbatim record of
- 8 what we have discussed today. With that in mind, as I'm
- 9 sure you're familiar, please respond verbally to the
- 10 questions as the reporter cannot properly record nonverbal
- 11 responses. Do you understand?
- Witness Yes.
- 13 HSGAC Majority This interview is unclassified. If the
- questions we've asked call for any information that you
- 15 know to part of classified information, please state for
- 16 the record as well as the reason you understand the
- 17 information request to be classified. Once you have
- 18 clarified and delineated what portion of the question
- 19 implicates classified information, please respond with as
- 20 much unclassified public information as you are able to do
- 21 so, to be responsive to the question. If the need arises,
- 22 and should there be a need to ask classified-related
- 23 questions in a setting, we can accommodate that and do so
- 24 should the need arise.
- It is the Committee's practice to honor valid common



- 1 law privileges and claims as an accommodation to the
- 2 witness when those claims are made in good faith and
- 3 accompanied by a sufficient explanation so that the
- 4 Committee can evaluate those claims. When deciding whether
- 5 to honor that privilege, the Committee will weigh its need
- 6 for the information against any legitimate basis for
- 7 withholding
- 8 This interview today is occurring without prejudice to
- 9 any future discussions of the Committee, and we reserve the
- 10 right to request your participation in a future interview
- if necessary. If you have any questions about what I have
- 12 said or how we intend to proceed today, I'm happy to
- 13 elaborate more. Is everything I've said to your
- 14 understanding so far?
- Witness Yes.
- 16 HSGAC Majority You are required to answer questions before
- 17 Congress truthfully. Do you understand?
- Witness Yes.
- 19 HSGAC Majority This applies to questions posed by
- 20 Congressional staffing interviews as well. Specifically,
- 21 18 U.S.C. Section 1001 makes it a crime to make any
- 22 materially false, fictitious, or fraudulent statement, or
- 23 representations in the course of a congressional
- 24 investigation -- sorry, statements or representations in
- 25 the course of a congressional investigation. The statute



- 1 18 U.S.C. 1001 applies to your statements in this
- 2 interview today. Do you understand?
- Witness Yes.
- 4 HSGAC Majority Is there any reason that you are unable to
- 5 provide us today with truthful answers to our questions?
- 6 Witness No.
- 7 HSGAC Majority Finally, we would ask that you not speak
- 8 about what we have discussed in this interview with anyone
- 9 outside of who is in the room today, or your counsel, in
- 10 order to preserve the integrity of our investigation. We
- 11 also ask that you not remove or make any copies of
- 12 photographs or exhibits that you'll be shown today. Do you
- 13 understand?
- Witness Yes.
- HSGAC Majority With that, we will begin and I will turn it
- over to my colleague, HSGAC Majority.
- 17 HSGAC Majority Good afternoon, Witness Thank you
- 18 very much for being here today. We appreciate it. I want
- 19 to start with the notes my colleague start just referenced,
- 20 which we recently received. I know when all of our offices
- 21 just spoke a moment ago, you mentioned these are your
- 22 notes. Is that correct?
- Witness Correct.
- HSGAC Majority And there appears to be pages 1 through
- 4, and I'm marking the notes as Exhibit 1. Witness has



- 1 a copy, and I believe HSGAC Majority will be putting those
- 2 notes up on the screen for anyone remote. Pages 1 through
- 3 -- or Bates stamp 790 through 793 are handwritten notes.
- 4 When did you write these notes?
- 5 [Exhibit No. 1 was
- 6 marked for identification.]
- 7 Witness It was after everything happened. After
- 8 the event, probably a couple weeks after the event.
- 9 HSGAC Majority Was it before you had any interviews?
- 10 Witness The timeline was before so that I could
- 11 have like a memory of, you know, kind of assuming that
- 12 everybody, that they're going to want to know each
- 13 everything I did each day.
- 14 HSGAC Majority If I could focus first just on the
- 15 handwritten notes.
- 16 Witness The handwritten notes, I believe, was
- 17 when I went into -- when I was in DC for the inspections
- 18 interview.
- 19 HSGAC Majority Do you recall approximately when that
- 20 was?
- 21 Witness Could I look at a calendar? I quess it
- 22 was, let's say -- I guess it was -- last Wednesday?
- HSGAC Majority If I could just note for the record as,
- 24 if your counsel is willing to share the date of the
- 25 interview with -- did you mention it was the IG or with



- 1 Professional Responsibility?
- Witness Yes.
- 3 HSGAC Majority And you drafted these notes before that
- 4 interview?
- 5 Witness I drafted them -- I think it was after
- 6 the interview, and I knew that I was going to have --
- 7 **HSGAC Majority** Why did you draft the notes?
- 8 Witness Because I had two interviews.
- 9 HSGAC Majority Do you recall who you interviewed with?
- 10 Witness The agency, Secret Service.
- 11 HSGAC Majority Secret Service. And what Division?
- 12 Witness Inspections Division.
- 13 **HSGAC Majority** Inspections Division. And then
- who was the other interview with?
- 15 Witness Inspections Division
- 16 HSGAC Majority Two interviews with Inspections Division
- 17 of the Secret Service.
- Witness Yeah.
- 19 HSGAC Majority So, these notes were after the first
- 20 interview, before the second interview. Did anyone ask you
- 21 to take these notes?
- Witness No, I was just taking them just from my
- own knowledge of, you know, things to address, or kind of
- 24 the things that they were asking me. I was like, okay, let
- 25 me write down like -- so that I can answer their questions



- 1 to the best of my ability.
- 2 HSGAC Majority And, and turning to Bates stamp 794
- 3 within Exhibit 1, these are the typed notes. Are these
- 4 also your notes?
- 5 Witness Yes.
- 6 HSGAC Majority And when do you recall draft taking
- 7 these notes?
- 8 Witness Probably the week after everything
- 9 happened.
- 10 HSGAC Majority So you took down the typed notes before
- 11 you wrote the handwritten notes?
- 12 Witness Correct.
- 13 **HSGAC Majority** And why did you take these notes?
- 14 Witness I just figured that, you know, I'm going
- to be asked a lot of questions, and I wanted to try to keep
- 16 my memory fresh. I wasn't sure what was going to happen,
- 17 and so I was just trying to keep my memory fresh as to what
- 18 I did each day because I knew as the time went, on and more
- 19 conversations would be had, I may forget.
- 20 HSGAC Majority When did you provide these notes to
- 21 Secret Service?
- 22 Witness I brought them with me to the inspections
- interview and then they took them from me. I didn't know,
- 24 like -- I didn't know that they were part of, you know --
- 25 because it wasn't notes that happened during the week of.



- 1 So, I didn't -- you know, it was just my own personal
- 2 notes, my own memory. I didn't know that they were going
- 3 to take them, but they said, yeah, they can. And I said,
- 4 oh, okay.
- 5 HSGAC Majority So the inspections division within
- 6 Secret Service took your notes during the interview?
- 7 Witness Correct.
- 8 HSGAC Majority And if we can follow up on when those
- 9 two interviews were -- we'll follow up separately with
- 10 counsel.
- 11 Witness Okay.
- 12 HSGAC Majority It's clear based on your notes, you have
- 13 a number of concerns. There's a number of issues and, and
- 14 concerns you raised here that we would like to ask you
- 15 about. So I'll reference this exhibit as we go through
- 16 questions.
- Witness Okay.
- 18 **HSGAC Majority** Our office for Chair Peters will ask you
- 19 questions for about an hour. We will take a break, and
- then Senator Paul's office, as well as Senator Johnson's
- 21 office will then ask questions. So first, how long have
- 22 you been with the Secret Service?
- Witness 17 years.
- HSGAC Majority 17?
- Witness Yes.



- 1 **HSGAC Majority** And in what position?
- Witness I've always been a special agent.
- 3 HSGAC Majority Were you part of the regular detail for
- 4 POTUS Trump or were you assigned specifically for this
- 5 rally?
- 6 Witness I was assigned site counterpart for the
- 7 rally.
- 8 HSGAC Majority How many events have you secured before?
- 9 And apologies if that's not the correct term. How many
- 10 events have you worked as a site agent before?
- 11 Witness Dozens.
- HSGAC Majority Over 40, over 50?
- Witness I don't know. 20, 30.
- 14 **HSGAC Majority** How many events have you led before?
- Witness As like the lead agent?
- 16 **HSGAC Majority** Yes.
- 17 Witness Only a handful.
- 18 HSGAC Majority What's the difference between working an
- 19 event as a site agent and leading the event?
- 20 Witness So, a site agent would be in charge of
- 21 the entire security of that particular site, and the lead
- 22 agent would be basically in charge of the entire visit for
- 23 the day.
- HSGAC Majority And at the July 13th rally, there were
- 25 two site agents. Is that common?



- 1 Witness I don't -- who were the two site
- 2 agents?
- 3 HSGAC Majority Our understanding is for the July 13th
- 4 rally, you were one of the site agents. Is that correct?
- Witness I was not a site agent. I was a site
- 6 counterpart.
- 7 HSGAC Majority And can you talk to me about the
- 8 difference between a site agent and a site counterpart?
- 9 Witness So, a site agent -- the site agent came
- 10 from the detail. So out of town. And the site
- 11 counterpart's role, which would be me, from the local field
- office, is basically there to kind of coordinate liaison
- 13 between the local entities and, you know, her requests or
- 14 what she's requiring for her security of her site.
- And as well as, you know, from a local field office
- 16 aspect where, you know, you're staying in a hotel when
- 17 you're out of town. We have a lot of problems with our
- 18 computers sometimes. You're not really supposed to log
- into the internet services of hotels, so you have to work
- off your hotspot on your phone. A lot of times you can be
- 21 constantly kicked off the internet, it's hard to do
- 22 paperwork.
- 23 So I'm really there as well to help her get into the
- local field office. If she wants to do any paperwork here,
- 25 I'm here to escort, show her work settings, connect her to,



- 1 you know, the internet, the blue line. She could print
- 2 documents that she needs to print. A lot of times
- 3 sometimes they don't have rental cars, so I'm also there to
- 4 provide her ride back and forth to wherever she needs to
- 5 go.
- 6 **HSGAC Majority** Who was the site agent for the July 13th
- 7 rally event?
- 8 Witness Site agent? Site Agent I don't know if
- 9 I'm pronouncing her name right. We called her Site Agent.
- 10 **HSGAC Majority** Special Agent Site Agent ?
- 11 Witness Correct.
- 12 **HSGAC Majority** And then you were her site counterpart.
- 13 Is that correct?
- 14 Witness Correct.
- 15 **HSGAC Majority** And who was the lead agent for that
- 16 event?
- Witness Lead Agent .
- 18 HSGAC Majority And in terms of chain of command, do you
- 19 report to, just for purposes of this event, Special Agent
- 20 Site Agent ?
- 21 Witness I mean, I would say, yeah. I mean, it is
- 22 -- a lead is kind of -- I guess like not far really from a
- 23 field office perspective. But yeah, I guess in terms of
- 24 how, you know, a protective amount would go, yeah, the lead
- would be in charge. So, yeah, I guess you could say that I



- 1 would report to her.
- 2 HSGAC Majority So, Special Agent Site Agent was in charge of
- 3 security of the site?
- 4 Witness Correct.
- 5 HSGAC Majority And as a site agent, you've staffed
- 6 events, secured events as a site agent before. Correct?
- 7 Witness Correct.
- 8 HSGAC Majority And as part as a site agent, you would
- 9 create a threat assessment. Is that correct?
- 10 Witness I mean, in your mind or on paper?
- 11 HSGAC Majority Generally. I guess, generally, when
- 12 you're planning for an event as a site agent, what
- documents do you prepare as part of your advanced planning
- 14 work?
- 15 Witness As the site agent, you typically are
- 16 going to do your site diagram. And you're going to plan,
- 17 you're going to coordinate with the locals on, you know,
- 18 how you want them as in your plan, you know, and work with
- 19 them together to make one plan.
- HSGAC Majority And as a site agent, does the site agent
- 21 determine the event location?
- Witness No.
- HSGAC Majority Whose job is that?
- Witness The staff.
- 25 HSGAC Majority When you say staff?



- 1 Witness The campaign staff.
- 2 **HSGAC Majority** Campaign staff.
- Witness Yeah.
- 4 HSGAC Majority Does the site agent determine the event
- 5 timing?
- 6 Witness No.
- 7 **HSGAC Majority** Whose job is that?
- 8 Witness Campaign staff?
- 9 HSGAC Majority Does the site agent determine event
- 10 transportation?
- 11 Witness Event transportation of?
- 12 **HSGAC Majority** Motorcades, securely transporting the
- 13 dignitary?
- Witness No.
- HSGAC Majority Whose job is that?
- 16 Witness The transportation agent.
- 17 HSGAC Majority Does the site agent determine the number
- 18 of magnetometers needed for the security checkpoints at the
- 19 event?
- Witness The site agent could have some say in
- 21 that. The lead sends the requests.
- HSGAC Majority So it is the lead agent?
- 23 Witness So the lead agent is the one that sends
- 24 all the manpower requests. And that is part of like the
- 25 manpower request, magnetometers.



- 1 HSGAC Majority Is the manpower request, does that
- 2 also include the amount of support needed from state and
- 3 local law enforcement?
- 4 Witness No.
- 5 HSGAC Majority Who determines the amount of support
- 6 needed from state and local law enforcement? Is that the
- 7 lead?
- 8 Witness It would be the state and local law
- 9 enforcement to deciding how many bodies that they're
- 10 willing to provide to you.
- 11 HSGAC Majority So Secret Service did not determine or
- 12 request assets from state and local law enforcement?
- 13 Witness So, you know, SAIC Pittsburgh would make a
- 14 phone call to the chiefs of the different departments. And
- 15 that would be a conversation we had between them. And
- 16 then, they would I guess provide -- I don't know how they
- 17 determine how many bodies did they have available. But,
- 18 you know, they'll come back and say this is what we have
- 19 available.
- It's not up to the field office or the Secret Service
- 21 to tell them how many. You know, I guess they could ask
- for what they're looking for, and they could come back and
- 23 say, you know, we have this or we don't have this.
- HSGAC Majority So ultimately, the resources needed from
- 25 state and local law enforcement are determined by the



- 1 special agent in charge?
- Witness Well, it's the locals that are going to
- determine how many bodies they're willing to provide to you
- 4 or what they have.
- 5 **HSGAC Majority** I understand it is up to the locals to
- 6 determine what their capacity is and what they're able to
- 7 provide. But in terms of what support is needed and
- 8 requested for a specific event, whose job is that within
- 9 Secret Service?
- Witness Well, I guess there's different layers.
- 11 I mean, you might start with the site agents. They might
- do a walkthrough with the locals and determine, you know,
- what the vulnerabilities are or how many posts they think
- 14 need manned. And then, it might go to the lead for review
- and then it might go to -- so there might be multiple
- 16 layers of reviews.
- 17 HSGAC Majority Understood. So, it could start with the
- 18 site agent through walkthroughs with locals. It might then
- 19 go up to the lead. The lead in this case, Lead Agent?
- Witness Correct.
- 21 HSGAC Majority And then who would it go up to from
- 22 there?
- 23 Witness I guess whoever is doing like the final
- 24 walkthrough. In this case it, for this event, it was the
- 25 second supervisor of the detail.



- 1 **HSGAC Majority** Who was that?
- Witness There was two of them that came out.
- There was DTD 2nd Sup. and DTD Campaign Sup. .
- 4 HSGAC Majority How do you spell his last name?
- 5 Witness DTD Campaign Sup., maybe. Might be
- 6 somewhere.
- 7 HSGAC Majority And when was the final walkthrough
- 8 performed?
- 9 Witness It was performed -- well, there was a
- 10 walkthrough. They did a walk the site agent Site Agent did a
- 11 walkthrough with her supervisors at noon on Friday. And
- 12 then they had another, like, team briefing at 5:30 p.m. on
- 13 Friday.
- 14 **HSGAC Majority** Were you in that briefing?
- 15 Witness So Site Agent used my computer to
- 16 log into the Teams. I was in and out. I was dealing with
- 17 conflicts outside. So I was walking in and out, so I heard
- 18 some of it, but.
- 19 HSGAC Majority Were you at that walkthrough?
- Witness I was.
- 21 HSGAC Majority And we have questions on that, but I'll
- 22 table them until we get there.
- Witness Okay.
- HSGAC Majority Have you been to Butler, Pennsylvania
- 25 before?



- 1 I'm sure I've driven through. Witness 2 HSGAC Majority If you recall? I ask, I'm curious have 3 you worked an event there? Have you secured an event 4 there? 5 Witness No. 6 HSGAC Majority So on the day of the event, which 7 supervisors and leads were present at the event? Special Agent in Charge processing, was he present? 8 9 He eventually got there. But he starts Witness at the airport and you know, he's -- so LES 10 LES 11 12 HSGAC Majority LES So he arrived 13 Mm-hmm. Witness 14 HSGAC Majority How about Special Agent Lead Agent? LES 15 Witness Again, yes, she arrived 16 HSGAC Majority Special Agent Site Agent 17 Witness She was present. HSGAC Majority And what time did you arrive at the 18 19 site?
- Witness Around 8 o'clock or so.
- 21 HSGAC Majority And Special Agent Intel Advance Agent ?
- Witness He was LES .
- HSGAC Majority Special or Assistant Special Agent in
- 24 Charge, ATSAIC
- Witness He was at the site.



1 Any other supervisors or leads from HSGAC Majority 2 the Secret Service that were at the site that day? 3 Witness Like they came LES or were 4 there? 5 **HSGAC** Majority That were present at the site. Whether 6 they arrived LES and stayed at the site, or 7 whether they were present the entire day. 8 So, yeah, I mean there would've been a Witness 9 lot of supervisors that arrived LES 10 LES 11 HSGAC Majority Special Agent in Charge DTD 2nd Sup. there? 12 Well, he's an assistant special agent. Witness 13 Yeah, I quess he would've arrived DTD Campaign Sup. ? 14 HSGAC Majority 15 With LES as well. The SAC, Witness LES 16 obviously, arrives 17 HSGAC Majority And you touched on this. I want to make 18 sure I have it accurate. So let me know. But it sounds 19 like in terms of who is responsible for requesting assets 20 for the event, and by assets, I mean state and local 21 support as well as resources through the Secret Service, 22 does that start with the site agent? 23 Witness It's kind of -- I mean, it's a little bit

24

25

tricky because you are kind of -- details are already kind

of given assets. You know what I mean? You know, a lot of

- 1 times, like, the President's going to get full
- 2 protection. So these are the assets that comes with, with,
- 3 with the President. The First Lady gets, you know, these
- 4 particular assets. You know, a former President usually
- 5 gets very limited assets. So, again, you could say like,
- 6 yeah, it starts with the site agent, but there's already
- 7 assets in place.
- 8 HSGAC Majority So putting aside there's already assets
- 9 in place, who is responsible for requesting the additional
- 10 assets needed to secure an event like Butler, the rally on
- 11 July 13th?
- 12 Witness So the lead is the person that send out
- 13 the manpower request for the assets.
- 14 HSGAC Majority But who is responsible for determining
- 15 the resources that are needed? Is that also the lead?
- 16 Witness I think it would just -- it could be --
- 17 you could say everybody maybe would be responsible for
- 18 determining resources.
- 19 HSGAC Majority Who is the one actually making the
- 20 decisions? Is it Special Agent Site Agent ? Is it Lead Agent ?
- 21 Witness I would say it'd probably be a
- 22 combination of the two of them, I would think. And it's
- only a request, and then, you know, ultimately, it's going
- 24 to trickle down. I don't know who makes the final decision
- on whether a request gets granted or not.



- 1 HSGAC Majority What were the resource needs for the
- 2 July 13th rally and who determined the those needs? So
- 3 let's start with Secret Service. What were the needs, the
- 4 resource needs to secure that event?
- 5 Witness I mean the event was secured with the
- 6 assets that were given, right? So, I mean, again, like
- 7 they could request additional assets, but I think they kind
- 8 of already know what's going to be granted or what's not.
- 9 HSGAC Majority So when you say the event was secured by
- 10 the assets that were given, who gives the assets? Is it
- 11 that they're already in place as part of POTUS' detail?
- 12 Witness Pretty much.
- 13 **HSGAC Majority** Okay. What are those assets that are
- 14 already in place?
- Witness So, I guess technical security division
- is an asset that they're given?
- 17 **HSGAC Majority** CUAS?
- 18 Witness Yeah. CUAS was an asset that they were
- 19 given. I guess it sounds like, and I don't know how long
- 20 they've been operating like this, right? So I'm not part
- of the detail, but they had LES CAT bodies LES
- 22 LES , so that would've been their asset. And then
- 23 ultimately, CS was given midweek. Counter sniper was given
- 24 midweek to them. So that was another asset.
- 25 HSGAC Majority And when you say given, who gave the



- 1 asset, do you know? Where did it come from?
- Witness I know DTD ops requested it.
- 3 **HSGAC Majority** Who's in charge of DTD ops?
- 4 Witness I don't know who's in charge of DTD ops.
- 5 HSGAC Majority Do you know who made the request?
- 6 Witness I was just told -- I mean, I'm sure
- 7 there's an email of who made it.
- 8 HSGAC Majority I'd like to draw your attention to
- 9 exhibit 1. Your notes on page 2, the third paragraph where
- 10 you reference CSU. Is that counter surveillance unit?
- 11 Witness Yes.
- 12 HSGAC Majority And you write, "I'm a huge advocate of
- 13 CSU, and I was surprised when I was told that's not an
- 14 asset requested." What did you mean by that?
- 15 Witness So, you know, I had asked Lead Agent, "Hey, we
- 16 don't have CSU for this." Like, I was surprised that we
- 17 don't have CSU for an outdoor event. That would be
- 18 something that I would think we would want. She just
- 19 basically said, yeah, it's not an asset that they're given.
- 20 HSGAC Majority When did you ask her that?
- 21 Witness I don't recall.
- HSGAC Majority Before the event? After the event?
- Witness Yeah, the beginning of the week.
- HSGAC Majority Is there an option to request that
- 25 asset?



- 1 Witness That's why I asked her. She's more
- 2 familiar with me about the request because she sat in
- 3 SynOps for three weeks before she was assigned the lead of
- 4 this. So sitting in SynOps with the DTD detail, I would
- 5 think that she kind of knows how things are run, and what's
- 6 given and what's not, and how assets are requested, and.
- 7 So that's why I asked her, you know, is CSU not something
- 8 that they typically use? And she said no.
- 9 HSGAC Majority Is it the lead agent's responsibility to
- 10 determine what assets are needed and request those assets?
- 11 Witness Again, I guess you could say that, but a
- 12 lot of times I think it is like, you know what, you can
- 13 make the request, but you know what you're going to get.
- 14 So maybe that. You know, I can't speak for whether that's
- 15 the case, you know, she already knows what's going to be
- 16 given. You know, just because she's familiar with that.
- 17 HSGAC Majority And when you say she already knows
- what's going to be given, I mean, is that a resourcing
- 19 issue?
- Witness Well, yeah. I mean, we have limited, you
- 21 know, manpower, limited resources. Especially during a
- 22 campaign, is it's always an issue; resources and manpower.
- HSGAC Majority And what capabilities would CSU have
- 24 provided at that event? And in your view, would having a
- 25 CSU asset present have been helpful?



- 1 Witness Yeah, absolutely. I think it's always
- 2 helpful. The more assets you have, the more helpful it is.
- 3 HSGAC Majority What specific capabilities would a CSU
- 4 asset provide and how would it have been helpful at the
- 5 July 13th rally?
- 6 Witness So they do vulnerability assessments. So
- 7 they're basically on the a perimeter. They are LES
- 8 LES , whether it
- 9 be, you know, LES . But they're in LES
- 10 **LES** . So, you know, they can operate in a multitude of
- 11 different ways.
- 12 They can, you know, circle the perimeters to see if
- they're coming across anybody trying to exhibit odd
- 14 behavior, whether they're looking for people that might be
- 15 hiding out in areas of concern. They could become **LES**
- 16 LES If there's a LES , they
- 17 can get out of their vehicles, they can become just like,
- 18 you know, in a **LES** or they could just interact
- 19 with LES So, there's a multitude of different
- 20 ways just kind of based on what their concerns are.
- 21 **HSGAC Majority** But generally, how big is a CSU unit
- 22 asset?
- Witness Usually, LES teams. I mean, if
- 24 you're getting the whole package. And, you know, like the
- 25 would get -- there'd be a LES too that



- 1 would, you know, be an asset. But typically, that's just
- 2 for the LES
- 3 HSGAC Majority So generally, LES teams for CSU?
- 4 Witness Typically, any other assets that you were
- 5 surprised they were not requested or available on July
- 6 13th?
- Witness Yes. I was very surprised that we didn't
- 8 have CAT, what they call an LNO. So, somebody who
- 9 basically comes out in advance and is coordinating the
- 10 tactical assets.
- 11 HSGAC Majority LNO?
- 12 Witness Yeah. Like, a liaison. It's basically
- 13 like a CAT liaison. They call it an LNO.
- 14 HSGAC Majority And can you talk more about that? What
- 15 would be their role?
- 16 Witness So we had the LES CAT element coming
- 17 LES , right? So their role would just be the
- 18 personnel on the ground coordinating with the local
- 19 tactical teams. You know, where they want them, kind of
- 20 their -- how we operate, how the Secret Service CAT team
- operates, and you know, what they would like them as local
- 22 tech to do in the support role. They talk about
- 23 communications. They typically have like a SOD, special
- 24 operations division. They usually have like an ops plan
- 25 that they put together. So it's very helpful. But we



- 1 didn't have anybody on the ground to do that.
- 2 HSGAC Majority Do you know why
- Witness I asked Lead Agent at the beginning of the
- 4 week, who's our CAT, LNO, just assuming that we had that
- 5 because I've never heard of not having a CAT, LNO. And she
- 6 just said, you know, we're not getting one. They're not
- 7 providing one, and I'm going to be the CAT, LNO. And I was
- 8 like, it doesn't sound right. You're not -- it's tactical,
- 9 you know. How can you be a CAT, LNO? She just said, I
- 10 don't know.
- HSGAC Majority Do you know if she requested that asset?
- 12 Witness I believe from my recollection, she said
- 13 that she did and they told her no. That she wasn't going
- 14 to get it because I don't know if they didn't have it
- 15 available, or.
- 16 HSGAC Majority When you -- not you, in general, when a
- 17 lead requests an asset, what is the process in doing? So,
- is it a form you enter and submit? Is it an email you
- 19 send? How is that request communicated?
- 20 Witness So I think there probably could be a
- 21 number of ways, but usually it's like a manpower request
- 22 and it's just like a checklist of -- you know, it's just
- 23 like a one sheet of like things that we're requesting. But
- 24 I mean, I quess you could send an email. Maybe there was
- 25 an email communication between them, or maybe there could



- 1 be a phone call. So I don't know if there's other means
- 2 that get approved or not.
- 3 HSGAC Majority Do you know whether the CSU request the
- 4 CAT, LNO requests were memorialized in any way?
- 5 Witness Just speaking with Special Agent Lead Agent,
- 6 she just told me that she was not getting the CAT and LNO.
- 7 That CSU is not part of their assets that they're allotted.
- 8 HSGAC Majority Did Special Agent Lead Agent mention any
- 9 other assets she requested and didn't receive for the July
- 10 13th rally?
- 11 Witness Not to me. I know that she requested 13
- 12 magnetometers and we received 10.
- HSGAC Majority Were there any other assets in addition
- 14 to CSU, CAT, LNOs, any other assets that you mentioned or
- 15 you thought should be requested and weren't?
- 16 Witness I mean, I guess in hindsight you could
- 17 say --
- 18 **HSGAC Majority** Oh, I'm, sorry. I'm talking about that
- 19 week. I mean, you mentioned that week that you both raised
- 20 a lack of CSU assets and a lack of CAT, LNO assets in
- 21 advance, earlier in the week. Anything else?
- 22 Witness I mean, that's the two that really stood
- out to me. And again, like, like CS, I absolutely would
- 24 want CS, but it was given to us few days later, later.
- 25 HSGAC Majority Later. Understood. We'd like to better



- 1 understand and hoping you can help us understand kind of
- 2 roles and responsibilities for planning. And I know you
- 3 mentioned there's a number of layers, so if you can, you
- 4 know, tell us in as much detail as possible what those are.
- 5 But we'll start with the perimeter. Who was responsible
- 6 for determining the perimeter of the July 13th event?
- Witness When you say perimeter, I mean the
- 8 perimeter really is the site. So the perimeter is going to
- 9 be the fencing along the site. You know, you're in charge
- 10 of the site. So that's kind of what is the perimeter. And
- 11 your perimeter is really going to be -- Secret services is
- 12 usually in the innermost perimeter. So, your perimeter's
- 13 going to be as big as what the bodies that you're, that you
- 14 have to secure that perimeter.
- And then depending on how many, you know, police
- 16 assets you're given, you could try to expand your
- 17 perimeter. Maybe make a middle perimeter, and then, you
- 18 know, you have an outermost perimeter. Again, if you have
- 19 the assets to produce an outermost perimeter and that, you
- 20 know, typically becomes like your counter surveillance unit
- 21 or posts and vehicles that are roving the perimeter.
- HSGAC Majority How many perimeters were there for the
- 23 July 13th event?
- 24 Witness So I would say there was probably three.
- 25 **HSGAC Majority** Three perimeters?



- 1 Witness Yeah. The inner most, the middle, and
- then, you know, an outer most perimeter.
- 3 HSGAC Majority Who determined these three perimeters.
- 4 Witness I mean, it's just a standard kind of
- 5 procedure when you're doing your plan. I mean, the
- 6 innermost perimeter's -- again, just based on manpower and
- 7 how many bodies that you're given. And I guess it's the
- 8 Secret Service's way of like limiting resources, right?
- 9 They want a Secret Service body to have a role where it is
- 10 either, like, you know, the President, or former President,
- or whoever your protectee is, is either, going through that
- 12 area, walking through that area, or whether the motorcade
- is going to go through that area, or whether they have to -
- 14 somebody, you know, a congressman's going through that
- 15 post, they want Secret Service posts to be people that have
- 16 a role.
- 17 Like, whereas a non-discretionary post, a general
- observation post, somebody, you know, on the outer
- 19 perimeter is always, they always want to be a police post.
- HSGAC Majority So it's standard procedure, as you
- 21 mentioned, but it differs based on the site. The site is
- 22 different, and so the threats are different, the
- 23 vulnerabilities are different. Who determined these three
- 24 perimeter layers for the July 13th event? Was it the lead
- 25 agent?



1 Well, when you say determined -- I Witness 2 mean, it is just the way that the security is -- I mean, 3 you have your Secret Service posts, and then you have your 4 police posts, and then you have your vehicle posts on the 5 outside. I guess it was just a -- it is just a security 6 plan of everybody involved. 7 So I'm showing you an aerial diagram, HSGAC Majority there's no Bates stamp, the parties Exhibit 2. And this is 8 9 an overview of the site for the rally. So looking at this, 10 are you able to draw circles around where the innermost 11 perimeter was, the middle perimeter, and the outer 12 perimeter? 13 [Exhibit No. 2 was 14 marked for identification. 15 I mean, I could try, but again, these are Witness 16 generic terms that I'm using as innermost -- you know, I don't know that it is like a defined --17 18 HSGAC Majority Understood. It is fluid, but trying to 19 understand the scope of these different variances, and 20 perimeter, and who is making these decisions. So who is in 21 charge? Is it the lead agent? Is it the site agent? 22 So, the site agent is in charge of the Witness 23 site. But again, like, I'm just using these perimeters as



use these perimeters.

24

25

just to my own knowledge, but maybe somebody else might not

So it's not like a standard, oh,

- 1 this is our perimeter, this is our perimeter, this is our
- 2 perimeter. Like, where, you know, you're asking me to
- 3 draw.
- 4 HSGAC Majority Understood. I guess let's start with
- 5 the outermost perimeter.
- 6 Witness Okay. So it would go off of the page. I
- 7 mean, it would be, you know -- well, I guess the -- I
- 8 believe that the lane, there's like a lane down here, and
- 9 then it would go up here to the city. So, it would be --
- 10 HSGAC Majority And just, we'll pass this around for
- 11 everyone in the room. The outer perimeter, and let me know
- 12 if this is incorrect, basically wraps around the entirety
- of Exhibit 2 and includes the AGR building. Is that
- 14 correct?
- Witness Correct.
- 16 **HSGAC Majority** And where is the middle perimeter?
- 17 Witness So what I would say like the middle
- 18 perimeter would be the fence line that goes the whole way
- 19 around the site. So, it would basically be like the side
- 20 itself from the fence line that's surrounds it.
- 21 **HSGAC Majority** And we will pass this around as well.
- 22 But for the record, the middle perimeter roughly includes
- the Beaver ESU site, the pond, the grandstand, the stage
- 24 Hercules 1 and 2, but does not include the AGR building.
- 25 Is that correct?



- 1 Witness Correct.
- 2 HSGAC Majority And was there an actual fence around the
- 3 middle perimeter?
- 4 Witness Yeah. This is all -- this is the fence.
- 5 And then there's a double fence.
- 6 HSGAC Majority Is this the fence Secret Service put up
- 7 or is this a fence that was already there?
- 8 Witness No, the fence was there.
- 9 HSGAC Majority There's a fence that was already there.
- 10 Did secret server put up another fence?
- 11 Witness No.
- 12 **HSGAC Majority** Okay. It was a double fence. And then
- can you draw roughly where the inner perimeter would be?
- Witness So the inner perimeter is really like,
- 15 you know, where our posts -- you know, what I'm saying is
- 16 the inner parameter is really where our posts are located.
- 17 So they are scattered though, but the majority of the posts
- 18 would be here and where he's coming through. So it's kind
- of scattered for me to draw, but I would say -- it's really
- 20 --
- 21 HSGAC Majority Feel free to draw a rough estimate or if
- 22 you want to draw a dash line to show that it might be you
- 23 know scattered a little bit. And I'm seeing you circle
- 24 different areas, is it accurate to say the inner perimeter
- 25 could include a bunch of different areas?



- 1 Witness Right. And yeah, I mean, you're
- 2 basically -- it's hard to --
- 3 **HSGAC Majority** So looking at this, are the
- 4 magnetometers, do they are they within the middle
- 5 perimeter?
- 6 Witness So they're all right here, yeah, I think.
- 7 **HSGAC Majority** So are there any magnetometers outside
- 8 the middle perimeter?
- 9 Witness No, because the middle perimeter is
- 10 within our site, so the magnetometers are within the site.
- 11 HSGAC Majority Thank you. We'll pass this around if
- 12 that's okay for everyone to take a look.
- 13 **HSGAC Majority** And I'll just ask a clarifying question
- 14 while she does. It's very important to know the location
- of the magnetometers because anybody on the inside of the
- 16 magnetometers has presumably been swept for weapons and is
- 17 therefore less of a security risk. Is that an accurate
- 18 statement to say?
- 19 Witness Yeah, I would say so.
- HSGAC Majority So you had mentioned earlier that it is
- 21 kind of a fluid term, but it is a very important thing for
- 22 all security personnel to know exactly where the perimeter
- that includes magnetometers is. Isn't that right?
- Witness Correct.
- 25 HSGAC Majority So outside of where those magnetometers



- 1 are, is by definition going to be less secured than
- 2 inside. Is that right?
- Witness I would say so, yes.
- 4 HSGAC Majority And so outside of where those
- 5 magnetometers are, additional decisions will be need to be
- 6 made to address those security issues, including location
- 7 and placement of assets, be they local or otherwise. Is
- 8 that a fair statement?
- 9 Witness Yes.
- 10 HSGAC Majority So outside of where those magnetometers
- 11 are, includes among other parts of Exhibit 2, the AGR
- 12 building, is that correct?
- Witness Correct.
- 14 HSGAC Majority And so, determinations on how to secure
- that in other areas outside where the magnetometers were,
- 16 were part of the decision-making process that whoever is in
- 17 charge of deciding the security needs must take into
- 18 consideration. Is that an accurate statement?
- Witness Yes.
- 20 **HSGAC Majority** So the three areas; the innermost
- 21 perimeter, the middle, and the outer, who decides the -- I
- 22 understand they're fluid lines, but they vary based on the
- 23 different sites and the varying threats posed. Who
- 24 determines these perimeters for the July 13th rally? Is it
- 25 the lead agent? Is it Special Agent Witness -- sorry,



- 1 excuse me. Is it Special Agent Site Agent? Is it the special
- 2 agent in charge?
- Witness Yeah. So it would start with Special
- 4 Agent Site Agent would be the first line to put the plan
- 5 together and then --
- 6 HSGAC Majority You've done this before, is do you draw
- 7 out the perimeter? Would there be diagrams with circles of
- 8 proposed perimeters?
- 9 Witness I think most people would just do like an
- 10 overview diagram and then put the police post where
- 11 they're, and I think the perimeter was just like, it was
- 12 easy. It was already established as a fence line, so it
- 13 was easy to just use that as the perimeter because it was
- 14 already something that was in place. So it wasn't
- 15 something that you had to like decide.
- 16 HSGAC Majority Were you involved when Special Agent
- 17 Site Agent made the determinations about the perimeter?
- 18 Witness So I was there for the meetings, I was
- 19 there for the walkthroughs with the locals.
- 20 HSGAC Majority Do you know when Special Agent Site Agent
- 21 initially drafted the perimeter?
- 22 Witness I don't -- like we keep talking about the
- 23 perimeter. I don't know that we were talking about it.
- 24 Like, you are talking about it.
- HSGAC Majority Understood.



- 1 Witness Yeah. So I don't know that there were
- 2 conversations., talk saying this is our going to be our
- 3 internal perimeter, and this is going to be our --
- 4 HSGAC Majority I see.
- 5 Witness -- middle perimeter, and this is going to
- 6 be -- you know, it was just the security plan and also
- 7 discuss it.
- 8 HSGAC Majority How did you discuss it? Talk to me
- 9 about how you discussed it with the Special Agent Site Agent?
- 10 Witness So the way that you discussed it is more
- 11 along the lines of, you know, the site posts, USS site
- 12 posts, and then your police posts, and then your outermost
- 13 perimeter posts. I guess more along the lines of -- or
- 14 just Secret Service posts and police posts. It may just be
- 15 as simple as that.
- 16 HSGAC Majority And both the Secret Service posts and
- 17 police posts were within this perimeter, this middle
- 18 perimeter?
- Witness Well, no, there was a police posts on the
- 20 exterior perimeter. The outer, this perimeter, is also
- 21 police.
- HSGAC Majority Oh, I see. And so looking back at
- 23 Exhibit 2, when you roughly drew these three perimeters,
- 24 did you do the walkthrough with Special Agent Site Agent before
- 25 assessing the perimeter?



- 1 Witness So, on Tuesday, we went to the police
- 2 barracks and we pulled up like an overview diagram and we
- 3 just discussed, you know, how large the space is. And we
- 4 said, you know, we discussed like where's the fence line,
- 5 right? So, let's draw the fence line and then let's try to
- 6 determine how to secure the area, what assets are going to
- 7 go where.
- 8 And then, you know, obviously you don't -- you can't
- 9 see all the holes, you know, just by looking at an overview
- 10 map. So then, you know, we further said, okay, well, we're
- 11 going to have to obviously walk every ounce of the fence
- 12 line. So, we set up a walkthrough with all the police and
- 13 fire on Thursday morning to do that.
- 14 **HSGAC Majority** And after you did the walkthrough, and I
- want to get to the walkthrough and questions specifically
- 16 with that, but after you did the walkthrough on July 11th,
- 17 did the perimeter change at all?
- 18 Witness Not to my knowledge.
- 19 HSGAC Majority And looking at the Exhibit 2 and the
- 20 middle perimeter which you mentioned has the fence around
- 21 it that does not include the AGR building, who was
- 22 responsible for securing the AGR building during the event?
- Witness So the Lieutenant, PSP Officer in Charge, was kind
- of the main police counterpart that was working with the
- 25 Secret Service. So, he was like the main entity from PSP



- 1 that was kind of in charge of the site. And so, on
- 2 Tuesday he said, you know, after we're talking about the
- 3 site and putting assets in different places, he said -- you
- 4 know, and he also lives like in one of the neighboring
- 5 houses, so he is very familiar with the grounds.
- 6 And he said, you know, and, obviously, we all agreed,
- 7 that the AGR building is closed, it's going to be a
- 8 concern. And he talked to the owner. He said that they
- 9 were willing to close the business for the day, and that
- 10 the doors would be locked, and it would be secured and
- 11 posted.
- HSGAC Majority So when did PSP Officer in Charge say this?
- 13 Witness Tuesday at the barracks?
- 14 HSGAC Majority Who were you with when you had this
- 15 conversation?
- 16 Witness From the Secret Service side?
- 17 HSGAC Majority Yes.
- Witness Agent Site Agent was there in Agent Lead Agent.
- 19 HSGAC Majority And when PSP Officer in Charge said the
- 20 doors would be locked and the building would be secured,
- 21 did you ask how it would be secured?
- Witness No.
- HSGAC Majority Who was responsible for determining
- 24 where the post standards would be stationed?
- 25 Witness The USS post standards?



1	HSGAC Majority Or state and local?
2	Witness Well, I mean, ultimately the site agent's
3	responsible for everything about the site.
4	HSGAC Majority So that would be Special Agent Site Agent?
5	Witness Correct.
6	HSGAC Majority Did you work with Special Agent Site Agent on
7	determining where Secret Service Post standards should be?
8	Witness Yeah.
9	HSGAC Majority And did you work with Special Agent
10	Site Agent on determining where state and local post standards
11	should be?
12	Witness I mean, we all did the walkthroughs
13	together. All the meetings that were set up, we were all
14	together.
15	HSGAC Majority Did the stationing of post standards
16	which did not include any around, on, or near the AGR
17	building that day
18	Witness Wait, say that again.
19	HSGAC Majority So, I'm marking this as Exhibit 3, and
20	this is a Pennsylvania State Police Operations Plan.
21	[Exhibit No. 3 was
22	marked for identification.]
23	HSGAC Majority Have you seen this document before?
24	Witness



25

HSGAC Majority

Did you see it before the site?

- 1 Witness I believe it was emailed prior to the
- 2 event, but I didn't see it.
- 3 HSGAC Majority And turn to Bate stamp 47, which you are
- 4 on. This is a diagram of where the Pennsylvania State
- 5 Police post standards are. And if you look, 4 and 5 appear
- 6 to be within the fence. So there are no post standards
- 7 around or on the AGR building. Did that concern you?
- Witness So the posts, you know, 3, 4, 5, 6, those
- 9 posts, they're posts that are facing the AGR building and
- 10 it's actually very close, and you can see the whole one
- 11 side of the AGR building. Again, we were told that the AGR
- 12 building was going to be secured and posted as well. I
- 13 didn't ask which agency was posting there.
- So, to my knowledge, the parking lot would've been in
- 15 -- nobody's there, you know, supposed to be in that parking
- 16 lot and it was posted. So, people were making sure that
- 17 nobody was in that parking lot along that Whitestown Road.
- 18 There was outer roving posts from Butler Township, we were
- 19 told, along --
- 20 **HSGAC Majority** When you say, "we were told," who told
- 21 you?
- Witness This is Lieutenant PSP Officer in Charge.
- HSGAC Majority So, Lieutenant PSP Officer in Charge told you the
- 24 AGR building would be secured and posted?
- Witness Correct.



- 1 HSGAC Majority Did you or anyone from Secret Service
- 2 ask how?
- Witness Posted to me means, you know, with
- 4 bodies. I didn't specifically go into detail about how it
- 5 was posted.
- 6 HSGAC Majority Did you know there would be snipers in
- 7 the building behind guns that were behind windows?
- 8 Witness I did not. I know that there was -- so
- 9 my understanding, I asked our USS counters sniper
- 10 technician, C/S Team Lead -- and I don't recall which day, I
- 11 want to say it was Thursday. I asked him, you know, after
- 12 talking with PSP Officer in Charge about the AGR building and
- our concerns with the AGR building and the water tower, I
- reiterated this to Technician C/S Team Lead.
- And I said, you know, what are you concerned with? I
- 16 don't know exact words how I put it. I basically asked him
- do you have any concerns at the 3 o'clock? That's our 3
- 18 o'clock. Our 12 o'clock would've been off the stage. And
- 19 he said that it would be covered with CS, with the team.
- 20 He said it would be covered with the team. And again, I
- 21 don't know exact, you know, guotes, but he said that he
- 22 wasn't concerned. It's going to be covered. And I asked,
- you know, what about the water tower? Are you concerned
- 24 about something climbing up there? And he said that
- 25 there's trees in the way of line of sight, so it's not a



- 1 concern of his.
- 2 So, yeah, it was at that point where I knew that those
- 3 buildings were to be covered. And you're asking me did I
- 4 know specifics about how they were being covered? No, I
- 5 did not know. I didn't go into his plan or, you know,
- 6 planning, or what was discussed between the two teams?
- 7 HSGAC Majority When was this conversation with
- 8 C/S Team Lead?
- 9 Witness Again, my days are all kind of running
- 10 together, but I want to say it was possibly on Thursday.
- 11 It was at the site.
- 12 **HSGAC Majority** And just referring you to Exhibit 1,
- 13 your notes, on the second page. You write, "CS million-
- 14 dollar question. Why wasn't anyone on the roof?" Was that
- the roof at the AGR building?
- Witness Yes.
- 17 HSGAC Majority Did you know that no one was going to be
- 18 on the roof prior to the event?
- 19 Witness So, I assumed when I was told that there
- 20 was going to be a sniper team, I assumed that it would be
- on the roof. That's the way I've always seen it in all of
- 22 my years, that the sniper teams are on the roof. But it
- was when I copied and pasted his email showing where the
- 24 teams were that I saw that it did say that they would be in
- 25 the windows or in the AGR, but I think it just said in the



- 1 AGR building on the -- maybe the second floor.
- 2 So, I mean, yeah, at that time I knew that they were
- 3 going to be in the AGR building, but I just assumed there
- 4 was a good reason, and that they had their plan, and that
- 5 that it was still covered.
- 6 HSGAC Majority And I'd like to ask about
- 7 communications. In the last paragraph on that same page,
- 8 Base 791 of your notes. Under "Threats" you write, "Why am
- 9 I hearing that there were threats to the site on TV? How
- 10 can the special agent in charge of our field office not
- 11 know about any threats? And why did they feel that only
- 12 one part of the special operations division was sufficient
- to cover it instead of the entire package?"
- 14 Can you talk about that and the problems with the
- 15 communications that occurred that day?
- 16 Witness Yeah. So, again, like we were told that
- 17 we were getting CS, and I just assumed it was because, you
- 18 know, of the event and the venue, and it's a large rally
- 19 and it makes sense because there's, you know, rooftop
- 20 buildings surrounding us. I was never made aware that
- 21 there was any type of threat to the former President. It
- 22 wasn't until --
- HSGAC Majority I'm sorry, when you say you, "were never
- 24 made aware that there was any type of threat to the former
- 25 President," are you referring to the suspicious individual



- 1 with a range finder?
- Witness No. I'm referring to like these Iranian
- 3 threats that I heard about.
- 4 HSGAC Majority Okay. Sorry, please go ahead.
- Witness Yeah. So, I heard about these, you know,
- 6 just from the news, and I asked Lead Agent I said, you
- 7 know, I didn't know. Did you know about any threats? I
- 8 didn't know about threats. And she said she didn't know
- 9 specifics, but, yeah, she knew that there was threats and
- 10 that's why we were given the CS team.
- But I asked the staff of the field office, did you
- 12 know there was threats? And he told me no, he didn't know.
- 13 And I just thought that that would've been something that
- 14 you would really want to pass down to somebody, especially
- in charge of the field office and trickle it down to the
- 16 site agent. I don't know whether the site agent knew from
- 17 her detail, but I thought that was very strange that I
- 18 didn't hear anything about the threats.
- 19 And, and the SAIC of the field office doesn't know
- 20 anything about the threats because, you know, maybe he
- 21 could have strong armed for more assets. Had you known,
- 22 maybe he could have talked to the locals, maybe, you know -
- 23 I don't know if that would've changed anything, but I
- 24 thought that that would've been very important to know.
- 25 HSGAC Majority On the local communication system, at



- 1 5:42 p.m., on the local system that they announced there
- 2 was a suspicious individual with a rangefinder that was
- 3 identified and they had lost track of them. Did you hear
- 4 about this in real time?
- 5 Witness No. I never heard at all about any
- 6 suspicious individuals.
- 7 **HSGAC Majority** So, at the time of the event, from 5:42
- 8 p.m. to when shots were fired, did you receive any
- 9 communications about a suspicious individual with a range
- 10 finder that they could not find?
- 11 Witness No. I received one phone call, and that
- 12 was at 6:11 from Agent Site Agent And she called me, and at
- 13 the time that she called me, I was in the security room
- 14 getting a drink. And she said, what's going on at the 3
- o'clock? And I put down the phone, turned to the SAIC Buffalo
- 16 who was in charge of the security room, and I said, what's
- 17 going on at the 3 o'clock? And moments later, shots were
- 18 fired. And that was the only communications I've ever
- 19 heard of any suspicious person, anything.
- 20 HSGAC Majority Special Agent Witness my name is HSGAC Majority
- 21 HSGAC Majority . I'm a senior investigator for Senator Peters. I
- just have a couple follow-up questions.
- In terms of covering a vulnerability. So, if a
- 24 building is identified as a potential vulnerability that
- 25 needs to be covered and it's going to be covered by local



- 1 assets, how much involvement does the Secret Service have
- 2 in determining how specifically that vulnerability will be
- 3 covered?
- 4 Witness So that's what our local counter sniper
- 5 teams, that's part of their planning. And I'm not a
- 6 counter sniper, so I don't get involved in their planning,
- 7 and I don't know what discussions that they have. And I
- 8 don't know their policies on whether, you know, they can --
- 9 I'm not sure what their policies are or what their
- 10 discussions they'd had about how they operate, or.
- 11 **HSGAC Majority** So, is it fair to say that the Secret
- 12 Service has to rely on its local partners to basically do
- 13 the job? In other words, you tell the locals, we need you
- 14 to cover a building, but it's up to the locals to figure
- out how to do that properly. Is that how it works,
- 16 generally?
- 17 Witness Again, I don't know how their operations
- 18 work. I would assume that they -- you know, I could assume
- 19 that they tell them what they would like them to do and
- they're relying on them. But I've never been part of those
- 21 discussions with those counterman teams.
- HSGAC Majority You said you've been the lead agent for
- events before, though, right?
- 24 Witness Correct.
- 25 **HSGAC Majority** And how do those conversations work when



- 1 you were the lead agent? In other words, how much
- 2 direction do you give the state or local assets in terms of
- 3 specifically how many officers you want, where you want
- 4 them, what roles you want them performing, et cetera, to
- 5 cover and identify vulnerability as opposed to just saying,
- 6 this is an identified vulnerability, you guys take care of
- 7 this?
- Witness Yeah. So, I mean, the tactical assets
- 9 are different. They do their own planning, but as far as
- 10 like the locals, you typically are working with. I mean,
- 11 there's a trust. There's a sense of trust between the
- 12 locals you're working with, usually their team leader or
- 13 whoever's in charge of that security for that day.
- So, you're usually working with whoever's in charge,
- and then they're really briefing their individual police on
- 16 the expectation. So, you know, you're not going around
- 17 briefing every single police entity individually. You're
- 18 really relying on your local team leader to do their job.
- 19 I mean, we have a lot of trust in on our locals and how
- they operate.
- 21 And again, I mean, if you think about it, I mean,
- 22 these guys are getting their photo with their weapon at
- their side with, you know, a President, with former
- 24 President. You have to have trust in somebody to allow
- 25 somebody to be getting a photo with their weapons on them.



- 1 So there's just a level of just a mutual understanding, I
- 2 think.
- But again, to specifically talk about those tactical
- 4 teams, I don't have knowledge of how that's all
- 5 coordinated.
- 6 HSGAC Majority So with respect to the assailant,
- 7 Crooks, ability to get onto the roof undetected with enough
- 8 time to fire a shot at the former President, who do you
- 9 attribute fault with not having that roof covered? Is it
- 10 the locals or the Secret Service?
- 11 Witness So, again, I don't know the facts. So
- 12 without the facts of what was said, or what was determined,
- or whose area of responsibilities, I don't think I could
- 14 properly answer that.
- 15 HSGAC Majority What facts would you need to answer
- 16 that.
- 17 Witness The discussions that were had between two
- 18 teams? Did the Secret Service give the locals direction?
- 19 Did they know what their area of responsibility was? Did
- 20 they know how they were operating? Did they know their
- 21 training? Were they operating as snipers or were they
- operating as counter snipers? So, all of those. There's a
- lot of factors that come into play, and I don't know any of
- 24 those factors to be able to answer.
- 25 HSGAC Majority Question is, does the Secret Service, to



- 1 your knowledge, have the ability at the Butler site or at
- 2 any site it is securing to make changes to any plan that
- 3 local assets provide?
- 4 Witness I guess they could give their guidance,
- 5 but whether the locals, you know, do what they say, I don't
- 6 think, you know.
- 7 HSGAC Majority So my ultimate question is whether
- 8 there's a chain of command, and whether the top of that
- 9 chain of command is the Secret Service?
- 10 Witness On a specific entity.
- 11 HSGAC Majority For the former President at Butler on
- 12 the 13th.
- 13 Witness So yeah, it would fall under the Secret
- 14 Service, Yeah, it's the Secret Service's event. So the
- 15 locals are supporting the Secret Service.
- 16 HSGAC Majority So, I'm going to introduce to you
- 17 Exhibit 4. Take a look at that. Let me know if you're
- 18 familiar with it.
- 19 [Exhibit No. 4 was
- 20 marked for identification.]
- 21 Witness Yeah. So this is just the preliminary
- 22 survey that the lead is responsible for putting together.
- HSGAC Majority What is the preliminary survey?
- 24 Witness It's just basically what the lead puts
- 25 together and distributes to anybody participating in the



- 1 event so that they can refer to it quickly if they need
- 2 to, you know, get a phone number, or.
- 3 HSGAC Majority What information does it include?
- Witness So, it includes advance teams, it
- 5 includes the timeline, it includes the sites, the
- 6 locations, the sequence of events,
- 7 LES
- 8 , and then telephone numbers that you
- 9 may want to call.
- 10 HSGAC Majority Is this the main document that the
- 11 Secret Service would use to populate the assets, support
- 12 manpower, and contact information for a particular event?
- 13 Witness This is not the manpower request
- 14 document.
- 15 HSGAC Majority Separate from the manpower request. Is
- 16 this site survey, the document that would be used to
- identify the agents involved in the advance planning, the
- 18 local assets that would be involved and relevant
- 19 information for each?
- 20 Witness I mean it will show your tactical -- it
- 21 shows like the tactical teams, and the CS teams, and I
- 22 guess their location, the advanced team.
- HSGAC Majority On page 1 of the document among the
- 24 offices and responsibilities listed is site counterpart.
- 25 Is that you?



- 1 Witness Yes.
- 2 HSGAC Majority Did you have input into this document?
- Witness No. I did not do the document.
- 4 HSGAC Majority You did not do the --
- 5 Witness I didn't know. I didn't fill out this
- 6 document at all.
- 7 HSGAC Majority And did you have any involvement in
- 8 helping populate this document?
- 9 Witness No.
- 10 **HSGAC Majority** Last question from me, and then we're
- 11 going to pause. You testified earlier with respect to the
- 12 perimeter that the perimeter can be as big as the bodies
- 13 you have to secure it. By that, you mean the more
- 14 resources you have, the larger a perimeter you can secure?
- Witness Yes.
- 16 HSGAC Majority Do you feel that you had a sufficient
- 17 number of Secret Service resources that day?
- Witness Yes. I mean, yeah, I think, it's like
- 19 the normal number, right? I could say I want 🗷 Secret
- 20 Service, but I know what a reasonable number is. I've been
- in the job long enough, so I know a reasonable number.
- 22 With that being said, though, I also knew that most of the
- 23 Secret Service agents weren't Secret Service agents, right?
- 24 They were support, they were HSI agents. So, you know, I
- 25 asked for a few extra bodies just to supplement for -- you



- 1 know, there's a very important post that an HSI agent may
- 2 not be familiar with.
- 3 **HSGAC Majority** How many did you request?
- 4 Witness So they provided LES extra USS agents.
- 5 HSGAC Majority Did you request LES
- 6 Witness I just said I would like a couple more.
- 7 **HSGAC Majority** And how many HSIs?
- 8 Witness HSI there was LES
- 9 Witness And there was LES Secret Service.
- 10 HSGAC Majority In respect to the local assets, did you
- 11 feel there was a sufficient number of local assets to
- 12 secure the site that day?
- Witness I mean, again, I would've loved to have
- 14 more local assets, but you know, being in Pittsburgh for,
- 15 you know, two and a half years, and I was the lead agent
- when he came the last time in, you know, May of 2022. And
- 17 I know that going to these like small townships and these
- 18 small areas of outside of the city that we're not -- they
- don't provide us a lot of assets.
- 20 So I wasn't expecting a lot of assets. I don't know
- 21 if it is a political thing. I don't know if it's because
- 22 it falls on a Saturday and that becomes overtime. I know,
- 23 you know, sometimes they're looking for, you know -- they
- 24 might want us to pay for their overtime. So I don't know
- 25 the reasonings behind it, but I knew that we don't get a



- 1 lot of local support. So, you know, I was just working
- 2 with what I was given.
- 3 HSGAC Majority Recognizing in your experience realized
- 4 resources that were constrained, working with what was
- 5 given, did it raise concerns for you what you were doing?
- 6 Witness I think that we had -- I think that we
- 7 had a good security plan. I didn't go in thinking, "Oh my
- 8 gosh, like our security plan's no good." You know, I went
- 9 in thinking, "Okay, we have a good security plan."
- 10 HSGAC Majority So we're a little over the hour mark,
- and we're happy to pause if you would like to take a few
- 12 moments break. And we're happy to keep going. In the
- interest of time, we'll defer to you.
- 14 Witness Maybe just a quick restroom room.
- 15 **HSGAC Majority** Of course.
- Witness Thank you.
- 17 [Recess.]
- 18 HSGAC Minority Okay. Hi, there. HSGAC Minority ,
- 19 again. Thank you for being here with us today. So we're
- 20 going to jump around a little bit. So, bear with me. But
- 21 it's helpful to have your notes and hear answers to some of
- 22 the questions. So, I just introduced an exhibit. I
- 23 believe it's Exhibit 5.
- 24 [Exhibit No. 5 and 6 were
- marked for identification.]



- 1 HSGAC Majority Yes.
- 2 HSGAC Minority Do you know what these -- are you
- 3 familiar with these documents?
- 4 Witness So, I didn't do these documents, but I
- 5 know what it is. Yes.
- 6 HSGAC Minority So these are the manpower requests.
- 7 Witness Correct.
- 8 When are these created, typically? Because we talked
- 9 about, you know, trying to determine what assets are
- 10 needed. Is this the form, the request that goes up the
- 11 chain to give final say of what's going to be sent out for
- 12 an event?
- Witness Correct. Yeah. And there's like a
- 14 timeline that Lead Agent sent out, like she sent out on like
- 15 Sunday, like a welcome email. And usually, I believe she
- 16 like put like when paperwork was due. So I'm not sure what
- 17 time the manpower request is due, what specific day that it
- is due, but I want to say it would be due this week.
- 19 HSGAC Minority And, and so is there typically --
- 20 there's typically one manpower request for an event and
- 21 it's not amended, or there sometimes be like a preliminary
- 22 request that's then followed up with a final? I'm just
- 23 trying to get a better understanding of -- because I know
- 24 we heard that for the preliminary survey, that there
- 25 sometimes is a final survey that's submitted.



- 1 Witness Yeah. After the visit is a final
- 2 survey.
- 3 HSGAC Minority So, does that ever happen, to your
- 4 knowledge, with the manpower requests?
- 5 HSGAC Minority And if you don't know --
- Witness Yeah. I'm not sure. I'm not like super
- 7 familiar with the -- you know, if there's ways that you can
- 8 get manpower again -- like, we got manpower that wasn't --
- 9 we didn't request it. So, I'm sure that there's other ways
- 10 to obtain assets that aren't part of this form. But I
- 11 think they just use this as a standard for most visits.
- 12 **HSGAC Minority** Okay. And if you look -- so I just want
- 13 to make sure, because I think we handed out two different -
- 14 there's technically two manpower requests there. I want
- 15 to make sure that we're looking at right now, the one for
- 16 Candidate Donald Trump.
- Witness Yes.
- 18 **HSGAC Minority** In the corner. Is that right?
- 19 Witness I think so. Isn't it the second one
- 20 you're saying on -- this is the -- and then this is Jill
- 21 Biden.
- HSGAC Minority So, first, looking at the one for
- 23 Candidate -- it says it's labeled, "Candidate Donald
- 24 Trump." If you look down, in the middle, I see CS, which I
- 25 assume is counter snipers. Is that right?



- 1 Witness Yeah.
- 2 **HSGAC Minority** So it seems like there was a request
- 3 made. I'm just trying to figure out when this was in the
- 4 timeline. So you said you think it was midweek?
- 5 Witness So I guess I guess it probably would've
- 6 been Tuesday. Tuesday, sniper came on Wednesday. So I'm
- 7 guessing that this would've been on Tuesday.
- 8 HSGAC Minority Okay. Tuesday. So, at this point, you
- 9 believe that you are -- and it was Lead Agent that filled
- 10 this out?
- 11 Witness Correct.
- 12 **HSGAC Minority** You believe she already knew that there
- were going to be counters snipers assigned, or do you think
- 14 she was requesting them hoping --
- Witness Again, yeah, I don't know. I don't know
- 16 whether she already -- I think that she already knew that
- 17 they were being assigned so she put them. But I can't
- 18 speak to her.
- 19 HSGAC Minority And so, typically, for these request
- 20 forms, I know we talked about it a little bit before, but
- 21 you all know what the standard -- I guess manpower is for a
- 22 protectee. Are these request forms kind of just putting in
- the numbers of what you already think you're going to get?
- 24 Witness I would say so.
- 25 HSGAC Minority And then, you may potentially request



- 1 more, but --
- 2 Witness Or I think some people, again, I want to
- 3 say that they tried to request it and it got denied. And
- 4 especially now, I think that's what people are probably
- 5 going to be doing moving forward because of what happened.
- 6 But, you know, again, like it's this is -- there's a lot to
- 7 do and this is a short timeline, it's a lot to do in a
- 8 couple of days, so, you know.
- 9 HSGAC Minority And if you look at to the right, I think
- 10 over, right above the CS, it says CSU. Is that the counter
- 11 surveillance unit we were talking about earlier?
- Witness Yes.
- 13 **HSGAC Minority** And so that here we see number of teams
- 14 and number of operators, zero.
- 15 Witness Yeah. I don't know. Mine is LES
- 16 **HSGAC Minority** For CSU.
- 17 Witness Oh, okay. I'm looking at CAT. Okay.
- 18 Yeah. CSU. Okay. Yeah, zero.
- 19 HSGAC Minority Okay. That says zero. And you
- 20 mentioned that you had worked an event in May of 2022 for -
- 21 is that for Trump?
- Witness Yes.
- HSGAC Minority And in May of 2022, he was not
- 24 President. Okay. I'm just trying to --
- Witness Yes.



- 1 **HSGAC Minority** -- remember the time.
- Witness No.
- 3 HSGAC Minority Okay. He was not. So, he was a former
- 4 President at that point? Do you recall if you had counter-
- 5 surveillance units there?
- Witness We did not.
- 7 HSGAC Minority You did not? Okay. And you were the
- 8 lead for that event?
- 9 Witness Correct.
- 10 HSGAC Minority And do you recall if you requested CSU?
- 11 Witness I do not believe I requested CSU.
- 12 **HSGAC Minority** And then if you turn to the other
- 13 manpower request, that one is for First Lady Jill Biden.
- 14 So to our knowledge, both Trump and Biden were in the area.
- 15 First Lady Biden was in the area --
- 16 Witness Yes
- 17 **HSGAC Minority** -- that day?
- Witness Yes.
- 19 HSGAC Minority So who handled the Biden event?
- 20 Witness So they sent a lead out from the First
- 21 Lady's detail, and he would be the one that would be
- 22 filling out the manpower request.
- HSGAC Minority And do you recall who that was?
- 24 Witness I want to say his name was First Lady detail
- HSGAC Minority Okay. First Lady detail



- 1 Witness I think from the President's detail.
- 2 HSGAC Minority Okay. That sounds familiar. And was
- 3 there someone from your -- the field office assigned to
- 4 that?
- Witness Yeah. There's what they call a field
- 6 office counterpart. His name was Senior Special Agent
- 7 Field Office Counterpart
- 8 HSGAC Minority And he was in charge of that? He was
- 9 the site counterpart for the --
- 10 Witness The field office counterpart. Like the
- 11 lead counterparts, yeah.
- 12 **HSGAC Minority** And it looks like for that event, there
- 13 was a CSU?
- Witness Yes.
- 15 HSGAC Minority And is that typical for the First Lady's
- 16 t.eam?
- 17 Witness So, at some point when I was on the
- 18 detail, it typically was not a standard for the First Lady.
- 19 And you know, at some point it was formulated. I don't
- 20 know if there was something that happened along the
- 21 if, you know, there was a problem or something
- 22 where they -- maybe they hit construction or something like
- 23 that. I don't know the details. But at some point,
- 24 something happened and then they created CSU for the First
- 25 Lady and it's kind of stuck ever since. So instead of it



- 1 being like a case-by-case, it's just kind of, like, now
- 2 here's what the First Lady requests every time so, yeah,
- 3 so.
- 4 HSGAC Minority And so, you were -- you used to be on
- 5 the -- you served on the President or the First Lady's
- 6 detail previously?
- 7 Witness No. I was on the counter surveillance
- 8 unit team for the -- when I was on the President's detail.
- 9 **HSGAC Minority** For the President's detail. When was
- 10 that?
- 11 Witness So, I was on the President's detail from
- 12 2015 to 2021.
- 13 **HSGAC Minority** So you were on President Trump's detail.
- Witness So I started with President Biden, did
- 15 four years on President Trump, and then ended with
- 16 President -- or sorry. Started with President Obama, four
- 17 years with President Trump, and then ended with President
- 18 Biden. So sometime after 2021, CSU became standard for the
- 19 First Lady's detail. It became like a norm when I was on
- 20 CSU, which probably would've been 2017, maybe like 2018, or
- 21 something like that. I don't know exact.
- HSGAC Minority And so, there were two events in the
- 23 area that the field office covers on July 13th. Did you
- 24 attend a police meeting that occurred on -- I think it, it
- was July 8th?



- 1 Witness Yes.
- Okay. So you attended. So our understanding is there
- 3 was a planning meeting for the First Lady's detail and then
- 4 there was the Trump one right after. They were back-to-
- 5 back.
- 6 Witness Correct.
- 7 HSGAC Minority Did you attend both meetings?
- Witness No.
- 9 HSGAC Minority Do you know if anyone did from the field
- 10 office?
- 11 Witness I think Field Office Counterpart did. I
- 12 think SAC, and stayed for the second meeting.
- HSGAC Minority And do you know if anyone else did?
- 14 Witness I don't know if -- maybe the staff did,
- 15 but I'm not sure. I only got there after the first meeting
- 16 is over.
- 17 HSGAC Minority Okay, that's helpful. So I think now
- 18 we're going to -- if you don't mind, we're going to go to
- 19 your typed notes. I think that it was Exhibit 1. So, I'm
- just going to use this as a reference point to kind of go
- off of, and you may ask questions, but that way it's kind
- of organized by date to keep your thoughts together and our
- thoughts.
- 24 So it starts with -- and there are some redactions
- 25 here. So I'm going to ask you, if you can tell us, too,



- 1 what's under the redactions? Did you make the redactions
- 2 that appear here?
- Witness No.
- 4 HSGAC Minority Okay. So I'm just going to ask you if
- 5 you recall what it originally said in your notes on some of
- 6 these. So for the Thursday or Friday, it says that you
- 7 discussed with someone on the First Lady detail. Do you
- 8 recall who that was?
- 9 Witness So that was at ATSAIC
- 10 **HSGAC Minority** And was that the first redaction there?
- 11 Witness Yes, correct.
- 12 HSGAC Minority Okay. So you discussed with ATSAIC who
- was available to work? Who is ATSAIC again?
- Witness He is my boss.
- 15 HSGAC Minority And what was his role for the event, the
- 16 Butler event?
- 17 Witness He was the site supervisor.
- 18 **HSGAC Minority** And what does that mean for -- just help
- 19 us understand what that means, what his responsibilities
- 20 were.
- 21 Witness So he would be the person supervising
- 22 that Butler Farm Show event that day.
- HSGAC Minority And how does he work with Lead Agent So
- 24 ultimately, do they both have -- Lead Agent was the one
- 25 filling out the request form? Does he have input into the



- 1 request?
- 2 Witness I guess a boss would -- could have input
- 3 into anything.
- 4 HSGAC Minority So you found out from him that you would
- 5 be working the event?
- 6 Witness So he was just kind of like, it was just
- 7 like a casual conversation of who was available. And then
- 8 the SAC sent an email the next day on Saturday to Lead Agent
- 9 and Special Agent saying, here's your team. This is
- 10 your team that's going to be working the two visits.
- 11 HSGAC Minority And then you mentioned -- and then
- there's some redactions here, conversations with blank and
- 13 blank, lead for First Lady detail. Can you fill those in
- 14 for us?
- Witness So Lead Agent would ve been under the
- 16 impression she was the lead from conversations with it
- 17 would've been our ASCAC , who's not no longer
- 18 here. He just retired, but he was around. I think it was
- 19 like his last day, or something, or he had come back or
- 20 something, and he had just basically said to her that she
- 21 was going to be the lead. And then I said Special Agent
- 22 Field Office Counterpart would probably be good with doing the lead for
- the First Lady because he was on the First Lady's detail.
- 24 So I thought, you know, he'd be fine with that.
- 25 HSGAC Minority And then if we go down a little bit, if



- 1 we go down to Monday the 8th. It says blank, "Met blank
- 2 there for the first time."
- Witness Met special site Agent Site Agent
- 4 **HSGAC Minority** So you met site Agent Site Agent for the
- 5 first time on the 8th at the Butler Farm?
- 6 Witness Correct.
- 7 **HSGAC Minority** And you'd never met her before?
- Witness No.
- 9 HSGAC Minority And then below that it, it says, "USSS"?
- 10 Witness Yeah. So it was Special Agent Site Agent
- 11 myself, and Special Agent at that initial walkthrough.
- 12 HSGAC Minority Okay. And then if you go down, it says
- 13 you really only dealt with blank.
- 14 Witness I mainly just dealt with Campaign Staff Lead
- 15 Campaign Staff Lead , who was the staff lead for like the Trump campaign
- 16 the entire time for the site.
- 17 **HSGAC Minority** So he's with the campaign? He's not
- 18 with the Secret Service detail?
- 19 Witness Correct.
- HSGAC Minority
- 21 Witness Yeah. And then the lead assist, whose
- 22 name was Campaign Lead Assist, I believe.
- 23 **HSGAC Minority** And the lead assist is what?
- 24 Witness Is the Trump campaign's lead assist. Is
- 25 what they called themselves.



- 1 HSGAC Minority Okay. And then if you go down, blank,
- 2 "started the conversation early."
- Witness That would be Special Agent Lead Agent
- 4 HSGAC Minority And then what is LOS?
- 5 Witness Line of sight?
- 6 HSGAC Minority Line of sight. Okay. What line of
- 7 sight concerns were there?
- Witness I mean, there was 360-degree line of
- 9 sight concerns everywhere. And, and it's anytime you're
- 10 really going out into an outdoor event, especially some
- 11 type of fairgrounds, there's pretty much going to be 160-
- 12 degree line of sight concerns.
- HSGAC Minority Were there line of sight concerns at the
- 14 AGR building?
- Witness Yes.
- 16 **HSGAC Minority** Were those discussed at that July 8th
- 17 meeting?
- Witness Yes.
- 19 **HSGAC Minority** What specifically?
- Witness The initial meeting, Special Agent Lead Agent
- just said, hey, when you're planning, when you're deciding
- where you're going to put the stage, just remember, you
- 23 know, line of sight concerns is going to be a big thing
- 24 Secret Service and especially supervisor to supervisor.
- HSGAC Minority And so, the stage had not been set.



- 1 There were two different stage locations. Do you know
- which locations the AGR-specific concerns were discussed in
- 3 terms of line of sight?
- 4 Witness I mean, I don't know that we said like
- 5 specifically AGR, but we were just saying like looking
- 6 around going, there's line of sight concerns everywhere.
- 7 But that would've been where the stage ended up being.
- 8 HSGAC Minority Okay. And then the police meeting, it
- 9 says, blank, "gave the entire briefing."
- 10 Witness Lead Agent
- 11 HSGAC Minority Okay. Blank, "took the main site."
- 12 Witness Special Agent Site Agent
- 13 HSGAC Minority And then tactical assets.
- 14 Witness It would've been ATSAIC
- 15 HSGAC Minority And then TS counterparts?
- 16 Witness Special Agent Lead Agent
- 17 HSGAC Minority And what is TS?
- 18 Witness The transportation section.
- 19 HSGAC Minority And then, blank, "met with
- 20 Intelligence."
- 21 Witness Special Agent Intel Advance Agent .
- HSGAC Minority So I'd like to pause here. So what
- intelligence team or what is that referring to?
- Witness The protective intelligence agent?
- 25 HSGAC Minority So who was the protective intelligence



1	agent?
2	Witness Special Agent Intel Advance Agent .
3	HSGAC Minority Intel Advance Agent . Okay. And what are the
4	responsibilities of this?
5	Witness So, he basically does like all the name
6	checks. I don't know if you're familiar with the name
7	checks?
8	HSGAC Minority Of People who are attending?
9	Witness Yeah. People who are attending. Anyone
10	that's going to come into close contact with our protectee.
11	They'll run name checks which is kind of like a background.
12	LES
13	LES
14	you know, somebody showing up
15	to our site that would create a problem.
16	They also are kind of communicating with the locals on
17	any intelligence that, you know, may be received in the
18	local community or social media, like how much whether
19	protestors might be showing up. So, they're basically like
20	the main intelligence person, and they're responsible for,
21	you know, passing on any pertinent information to, you

HSGAC Minority Okay. And they're meeting with locals or met with intelligence? I'm just trying to understand.

Witness So they meet with like the police.

know, the lead, or the boss, or addressing any concerns.



22

- 1 Usually, it's like the plain clothes units, like the
- 2 intel units for the police departments.
- 3 HSGAC Minority Do they meet with like Fusion Center
- 4 representatives or anything like that?
- Witness No. I mean, like we have like a JTTF
- 6 representative in our office that, you know, coordinates
- 7 everything with the FBI. So, if the FBI had some
- 8 intelligence, you know, they need to pass, we typically go
- 9 through like a JTTF representative, but I don't know that
- 10 Special Agent Interview with anything like
- 11 that.
- 12 HSGAC Minority And so when you guys do receive
- intelligence, it typically comes from JTTF?
- 14 Witness I don't know. I don't know if it goes,
- but yeah, I mean that's one way to do it. I think he has
- 16 some sort of clearance set up for that specifically.
- 17 HSGAC Minority Do you all have a SCIF in your office
- 18 here? Is this the main field office?
- 19 Witness I don't know if this is considered a
- 20 SCIF.
- HSGAC Minority It has windows, so I imagine it wouldn't
- 22 be, and we have cell phones. And so, we talked a little
- 23 bit earlier about how you were surprised to learn about the
- 24 Iranian threat. That was after you learned about it after
- 25 the event July 13th?



- 1 Witness Yeah. And I still don't know really is
- 2 was it a real threat? I don't know. I still don't know
- 3 anything. I was never briefed, I was never told anything.
- 4 I don't know.
- 5 HSGAC Minority And I mean, I think it's been made
- 6 public that there is a threat. I think it's been made
- 7 public in court documents, arrests that have been made by
- 8 DOJ that there is a threat. So you've never been briefed.
- 9 You have a security clearance, right?
- Witness Yeah.
- 11 **HSGAC Minority** And what level?
- 12 Witness Top secret.
- 13 **HSGAC Minority** Top secret. And have you been briefed
- on intelligence specific to a protectee in the past?
- 15 Witness It's usually more of like your protective
- 16 intelligence agent is usually briefed by a supervisor. So
- 17 a lot of times it's never getting trickled down to my
- 18 level.
- HSGAC Minority And so, would Intel Advance Lead have been
- 20 responsible for any threat intelligence?
- 21 Witness I think that the detail was the one that
- 22 was aware of the intelligence, and I don't know whether
- they told anyone from the Pittsburgh. I mean, it sounded,
- 24 like speaking with Lead Agent like she knew of a
- 25 threat, but she didn't know specifics like an Iranian



- 1 threat or anything like that.
- 2 HSGAC Minority Did she mention at all knowing about any
- 3 threat that was communicated on July 9th at the Doral
- 4 Florida rally?
- Witness No.
- 6 HSGAC Minority Okay. It's been reported that right
- 7 before Trump's rally in Doral, Florida on July 9th, that
- 8 Secret Service communicated to the Trump detail that there
- 9 was a specific threat and that they would be seeing
- 10 additional assets. Now, I don't have any additional
- information, but you've never heard that?
- 12 Witness No, I did not know, I was not aware of
- 13 that.
- 14 HSGAC Minority And so, was there only one
- 15 representative from protective intelligence at the event?
- Witness We had a site protective intelligence and
- that's just like a post standard that comes and then
- 18 they're like the site agent for the day.
- 19 HSGAC Minority Okay. And so, what is their role on the
- 20 day of the event?
- 21 Witness They're basically there to support the
- intelligence agent because he's at the airport at the time,
- 23 and he's not coming until later. So if there's, you know,
- 24 a suspicious person at a site or if there's somebody that
- 25 needs to be interviewed at a site, that site agent usually



- 1 is the one to do that type of interview.
- 2 **HSGAC Minority** And who was the site agent?
- Witness Protective Intel Agent .
- 4 HSGAC Minority Do you happen to know the spelling for
- 5 that?
- 6 Witness Protective Intel Agent .
- 7 HSGAC Minority Okay. And is that someone from the
- 8 field office or is that someone from the detail?
- 9 Witness No. She was just somebody from out of
- 10 town that came for the day.
- 11 Witness I don't know what field office she's
- 12 from.
- 13 **HSGAC Minority** So is there always someone, an
- 14 intelligence agent, LES ?
- 15 Witness Yea. Typically, there's always an
- 16 intelligence agent LES .
- 17 HSGAC Minority And do you know if you said it was
- 18 PII
- 19 Witness Yeah. Protective Intel Agent was the site protector,
- 20 and so she was just at the site the entire time.
- 21 HSGAC Minority And then do you know if she interviewed
- 22 anyone?
- 23 Witness I do not know.
- HSGAC Minority And where was she seated? Where was she
- 25 situated? Did she move around or?



- 1 Witness Yeah. She was all over the place. I
- 2 gave her like a golf cart and basically gave her free reign
- 3 to get familiar with the site. And she was with a PSP
- 4 counterpart. We typically link up with police counterpart
- 5 for doing their assistance in case you need to, you know,
- 6 make any arrests, or detain anyone, or.
- 7 HSGAC Minority And who communicated with her? Was it
- 8 everyone had -- was she on a radio with everyone on Secret
- 9 Service? Were only certain people passing her information.
- 10 How was information related to protective intelligence or
- 11 the intelligence agent?
- 12 Witness Yeah, I mean, a lot of times -- like, I
- 13 quess it just depends. If I'm doing protective
- 14 intelligence, I typically send out an email to everybody in
- 15 the advance team and I say, this is a protective
- intelligence router, please pass pertinent information
- 17 along on this router that's relevant. Special Agent
- 18 Intel Advance Lead did not do that. So that wasn't established.
- So, there's a multitude, I guess, ways that you could
- let a protective intelligence person know. I mean, you
- 21 could go over the radio, I guess you could call, you could
- 22 put it out in email. I don't know. I was not made aware
- of any communications to the protective intelligence agent.
- HSGAC Minority So you said that you don't believe any
- 25 email was sent out kind of telling everyone how to contact



- 1 that person on that day. Did you feel like you knew how
- 2 to contact that person?
- Witness Oh, you're saying for other people, how
- 4 to contact that person?
- 5 HSGAC Minority For you?
- 6 Witness I mean, how I knew because, you know, I
- 7 was the one that put the site posts instructions together,
- 8 so I knew who my site PI was, and I also sent her contact
- 9 information to Special Agent Intel Advance Agent who was the in charge
- 10 of the visit for them to link up and kind of communicate
- 11 with each other on the plan.
- 12 HSGAC Minority Okay. And does the protective
- intelligence agent, do they have a direct line of
- 14 communication with the counter snipers?
- 15 Witness So the counter snipers typically are
- 16 monitoring the radios that the channels that we're on, so
- they should be monitoring all the radio channels that we're
- 18 working off of.
- 19 HSGAC Minority So does the protective intelligence
- 20 agent have a separate line?
- Witness No. They're just on the same channels.
- 22 You know, there's usually a frequency for the post
- 23 standards, so that's what Protective Intel Agent would be on, the site PA
- 24 would be on the frequency of the post standards at the
- site, and then there's usually a separate frequency for the



- 1 shift agents.
- 2 HSGAC Minority Okay. And so, if the counter snipers
- 3 saw something suspicious as they're looking out doing their
- 4 overwatch, would they be communicating that directly to
- 5 protective intelligence, or?
- 6 Witness So, they normally communicate that to
- 7 what we call a CS response, a counter sniper response. So
- 8 there's a dedicated team that's supposed to -- if the
- 9 counter snipers say, you know, there's somebody you know in
- 10 this window or there's somebody on this roof, typically,
- 11 they would reach out to CS response and CS would respond,
- 12 would go then and investigate it, or.
- HSGAC Minority And so, who was on the CS response on
- 14 July 13th?
- Witness Yeah. It was a guy named CSRT Agent I
- 16 believe.
- 17 HSGAC Minority So was there only LES on the CS
- 18 response team?
- Witness So, yeah. So there's LES team and then
- 20 LES paired with, again a local, like a PSP counterpart.
- 21 **HSGAC Minority** Is it typical that there's only **LES**
- 22 Secret Service agent?
- Witness Yes.
- HSGAC Minority Okay. So it doesn't change depending on
- 25 the area of the site, how many people are going to attend?



- 1 Witness I've only seen LES for these types of
- 2 sites. I mean, maybe if it's like an NSSE, or something,
- 3 you know.
- 4 **HSGAC Minority** Okay. Did they have a golf cart?
- 5 Witness They had a vehicle. I made sure it was
- 6 somebody that had a vehicle.
- 7 HSGAC Minority So was that a Secret Service vehicle?
- 8 Witness It was a rental car that they had, but
- 9 yeah, it was a specific service.
- 10 HSGAC Minority And then were they posted in a specific
- 11 location or are they also roving?
- 12 Witness So usually they're like a relief because
- our counters sniper teams LES before
- 14 they hit, or that the LES . So I
- 15 said, you know, to walk around familiarize yourself with
- 16 the site and all the posts you're kind of like a relief if
- 17 anybody needs a push or to take a break. And I had said,
- 18 you know, you could just use your car and, and stay at the
- main gate as you wish, you know, to be able to respond
- 20 quickly to a situation.
- 21 But I also put in Technician C/S Team Lead phone number
- 22 and said, please reach out to Technician C/S Team Lead and make
- 23 sure that he gives you paperwork and that you guys work out
- 24 the plan amongst yourself. So, I believe that's what
- 25 happened.



- 1 HSGAC Minority And so that conversation happened
- 2 when?
- Witness So it was in the site post instructions,
- 4 and then that conversation happens when we we're posting
- 5 up. So probably around 11 o'clock that morning the day of.
- 6 HSGAC Minority Was that the briefing or was C/S Team Lead
- 7 supposed to give an actual briefing?
- 8 Witness So I think they actually met separately
- 9 and C/S Team Lead met with him separately. My understanding is
- 10 that they met around 1 o'clock or so, and he provided him
- 11 like a survey they could countersign, a survey. And it's
- 12 basically like a grid so he would say it's B4 or something
- 13 so they know exactly where they need to respond to. And
- 14 then at that point, you know, I don't know the word like
- 15 what was exchanged between the two. So I don't know if
- 16 Technician C/S Team Lead said, I would like you to be here. So
- 17 I don't know.
- 18 HSGAC Minority And then did you communicate with
- 19 CSRT Agent after the event had started?
- 20 Witness After President Trump arrived?
- 21 HSGAC Minority Or people started coming in, I guess
- 22 when quests --
- Witness I didn't.
- HSGAC Minority Is that your only communication that day
- 25 with **CSRT Agent**?



- 1 Witness Yes.
- 2 HSGAC Minority Okay. So, did you hear any radio
- 3 traffic to **CSRT Agent** that day? Anything over the radio?
- 4 Witness I did not.
- 5 HSGAC Minority Is CSRT Agent was his -- did he have a
- 6 perimeter or could he kind of go wherever?
- 7 Witness He could go wherever.
- 8 **HSGAC Minority** Okay. So outer perimeter?
- 9 Witness Yeah. I mean, like CS usually is, you
- 10 know, you're talking about they're looking at LES
- 11 yards out. So it could be as far out as they see
- 12 something.
- 13 **HSGAC Minority** So AGR building would've been an
- 14 appropriate place for them to cover?
- Witness Mm-hmm.
- 16 HSGAC Minority Are they responsible for kind of going
- 17 about and monitoring the site as the event's going on, or
- is there a preference for them to be --
- 19 Witness Not really. A lot of times they're just
- 20 sitting in a car waiting for -- to reach out to the
- 21 services for a problem, and a lot of times they never have
- 22 to do anything.
- HSGAC Minority And does while we're talking about
- 24 surveillance, does Secret Service have any video or photo
- 25 surveillance systems so that they deploy or can deploy at



- 1 an event to monitor in real time?
- Witness Like a drone?
- 3 HSGAC Minority A drone, or I don't know, camera system
- 4 that you post?
- 5 Witness So I know TSD has certain
- 6 equipment LES . I don't even know what
- 7 you call, but like if you LES , you
- 8 know, it would alert. And when I was on the detail, I
- 9 don't believe they were using drones, but it's my
- 10 understanding that they might be using drones now, and they
- 11 have the capability to use that as more of a surveillance,
- 12 or.
- HSGAC Minority And what about like pole cams, or.
- 14 Witness The only time I've heard of pole cams is
- 15 **LES**
- 16 HSGAC Minority And do you know if any surveillance
- video photo were deployed on that day?
- 18 Witness It's my understanding that the -- had
- 19 deployed a drone on that day.
- 20 **HSGAC Minority** But not Secret Service?
- 21 Witness Correct.
- HSGAC Minority Is that typical that there wouldn't be
- 23 some kind of surveillance?
- Witness Yeah, I mean, that's typical. But again,
- like maybe they do it now, but when I was on the detail,



- 1 they didn't use drones for air events. If you're talking
- 2 about the LES they were using helicopters, LES
- 3 LES .
- 4 HSGAC Minority And what kind of helicopters?
- 5 Witness It would be like the Coast Guard or
- 6 whatever your local police are providing.
- 7 HSGAC Minority Okay. So if you don't have like live
- 8 real time, do you have agents that are kind of walking post
- 9 standards or walking the event, taking pictures of areas?
- 10 We've seen some pictures that appear to be the vendor site
- 11 folks were sharing pictures of the vendor site. I don't
- 12 know.
- Witness What do you mean the vendor site?
- 14 **HSGAC Minority** We will introduce it as an exhibit,
- 15 Bates number -- I apologize. You can jump in with a
- 16 question a question while I find this. I think you should,
- 17 HSGAC Minority
- 18 **HSGAC Minority** Oh, okay. First of all, pardon this.
- 19 In baseball terms, I was expecting a fastball when we got a
- 20 curve ball today. So we'll be like water and adapt.
- So, first of all, you know, I consider you a subject
- 22 matter expert. You've done this for 17 years, so we're
- 23 heavily relying on you, maybe as you've already done
- 24 opening up some, I guess or answering some questions on the
- 25 process that we might not understand.



- And I'm not going to go deep into my questions yet,
- 2 but I do want to say on the onset it's refreshing to
- 3 finally interview someone that's willing to give a candid
- 4 answer. Because what I wrote when I first saw your notes
- 5 was this, it's interesting that many of these same concerns
- 6 that you put on here are the same concerns that I and
- 7 millions of Americans have today.
- And that's concerning. And the thing that I think
- 9 when I ask my questions that you'll notice is the
- 10 difference in you questioning that you having these
- 11 questions that millions of Americans have was you were on
- 12 site with other agents that had these same questions, but
- 13 yet a lot of things went unnoticed and/or unattended to.
- 14 HSGAC Minority Okay. So, I just passed out Exhibit 7,
- and I'll let you look at that. Are you familiar with this?
- 16 It appears to be a text from a chat group, the first
- 17 document and it's Bates 705.
- Are you familiar with this in the corresponding
- 19 attachment pictures?
- 20 [Exhibit No. 7 was
- 21 marked for identification.
- Witness Okay. So I mean, I know the sixth rep.
- 23 Yeah, I may have been on that text. I don't know.
- HSGAC Minority Okay. So do you know who it would be
- 25 from?



- 1 Witness It would've been from Special Agent
- 2 Lead Agent who Special Agent Site Agent asking for the sit rep, the
- 3 situation report, for the day of the visit, which is very,
- 4 you know, standard practice.
- 5 HSGAC Minority Is that something that's done throughout
- 6 the day?
- 7 Witness A lot of times they want to know how many
- 8 people are through the mags throughout the day. So usually
- 9 the sit rep is, you know, when you're getting, you know,
- 10 five minutes out you provide a sit, you know, maybe 10
- 11 minutes out you provide a sit rep and then you'll say, you
- 12 know, updated situation report maybe five minutes out. But
- 13 yeah, for an event this large or for this type of event,
- 14 they typically want to know how many people, are into the
- 15 site and how many people are still waiting to get mag.
- 16 **HSGAC Minority** Okay. And then the picture, so there
- 17 were two pictures it looks like attached to that. 706 is
- 18 the first one and 707. And do you recognize these photos?
- 19 Witness I guess that this is what I'm guessing
- 20 that this is what Special Agent Site Agent sent to Special Agent
- 21 Lead Agent but I, you know, I, again, I, this is just, yeah, I
- 22 would have to
- HSGAC Minority And do you recognize these areas?
- 24 Witness Yeah. So this would've been the
- 25 magnetometer line. And this would've been the crowd from



- 1 like the back of the event.
- 2 HSGAC Minority So these were outside the secure inner
- 3 perimeter.
- 4 Witness The people in line would've been, but the
- 5 people -- the crowd is inside. This is where they're --
- 6 **HSGAC Minority** That's inside.
- 7 Witness This is the rally.
- 8 HSGAC Minority And that truck that's there, is that a
- 9 vendor?
- Witness Yes.
- 11 **HSGAC Minority** So there were vendors inside the
- 12 perimeter?
- Witness Yes.
- 14 **HSGAC Minority** Okay. How many?
- 15 Witness I don't know. Just a couple.
- 16 **HSGAC Minority** Did they have to be like pre-approved?
- 17 Witness I think there were vendors outside the
- 18 perimeter too?
- 19 **HSGAC Minority** Yeah. I knew about the ones outside. I
- 20 guess I didn't really realize they were inside the
- 21 perimeter as well. Did they have to get --
- Witness No, that's common. They have to be there
- at a certain time, and then they have to go through the
- 24 security. They have to go through like a sweep.
- 25 **HSGAC Minority** So is it typical that these sit reps



- 1 have photos?
- Witness Yeah, I would say that.
- 3 **HSGAC Minority** I'm just trying to get a better
- 4 understanding since there's it doesn't seem like there's
- 5 video surveillance of what's going on if kind of pictures
- 6 are taken. Do you know if anyone in Secret Service
- 7 encountered or saw the suspect, Crooks, that day?
- 8 Witness Not to my knowledge of anyone who
- 9 encountered him. You mean like in line or something?
- 10 **HSGAC Minority** Or just, you know, walking in the area.
- 11 Witness Nothing was passed to me about Crooks.
- 12 **HSGAC Minority** Did you receive other pictures that day
- 13 from around the rally that you recall?
- 14 Witness I took pictures before of like -- not the
- 15 rally, but I took pictures of, like, the vendors that had
- 16 been lined up on Friday night and I think I sent it to
- 17 Special Agent Lead Agent I didn't know that these guys were
- 18 doing that.
- 19 HSGAC Minority And who would be responsible for the --
- or dealing with the vendors?
- 21 Witness It was the staff. The staff sets all
- 22 that up.
- HSGAC Minority The campaign staff?
- Witness Mm-hmm.
- 25 **HSGAC Minority** So you took some pictures. Did you take



- 1 any pictures on the day of the event?
- Witness No, I don't believe so.
- 3 HSGAC Minority Okay. And then did you -- so you sent
- 4 pictures on Friday
- 5 Witness And it was like, like look at all these
- 6 people lining up already because I wasn't made aware that
- 7 they were all going to be there.
- 8 HSGAC Minority And did you send those pic or did you
- 9 provide those pictures to the inspections division?
- 10 Witness They didn't ask me about any photos.
- 11 **HSGAC Minority** Okay. Did you provide those to the FBI?
- Witness No.
- HSGAC Minority Have you been interviewed by the FBI?
- 14 Witness Yeah. They didn't ask me about anything.
- 15 HSGAC Minority Do you recall when you were interviewed
- 16 by the FBI?
- Witness Why?
- 18 **HSGAC Minority** When?
- 19 Witness Oh, and I can assume why.
- 20 **HSGAC Minority** Was it before or after the Secret
- 21 Service Inspections interview?
- Witness Before.
- HSGAC Minority Before.
- 24 Witness It was the first interview I had.
- 25 HSGAC Minority And do you recall, was it the night of



- 1 the event?
- Witness No.
- 3 **HSGAC Minority** Was it --
- Witness It was much later. A week, I would say.
- 5 I would say probably a week.
- 6 **HSGAC Minority** And where was that meeting?
- 7 Witness Here.
- 8 **HSGAC Minority** Was it just FBI?
- 9 Witness No, PSP.
- 10 HSGAC Minority Again, apologize for jumping around. So
- 11 how many times -- I'm going to go back to the advance. How
- 12 many times did you visit the AGR property or were you on
- 13 the AGR property, would you say?
- 14 Witness I didn't go over to the AGR property at
- 15 all. I just was along the fence looking at it.
- 16 HSGAC Minority Okay. So, when you all were doing the
- 17 walkthrough?
- 18 Witness Yeah. And then, I guess I did go over
- 19 there after it all happened, you know, after the shooting
- 20 and everything?
- 21 **HSGAC Minority** You did?
- Witness Mm-Hmm.
- HSGAC Minority Did you go up on the roof after?
- 24 Witness Not that day. I went up on the roof
- later, like weeks later when Director Rowe came out.



- 1 HSGAC Minority When you said you went over up to the
- 2 AGR property after, that's the night of the event?
- Witness Yes.
- 4 HSGAC Minority And what was the purpose for going over
- 5 there?
- 6 Witness So technical security division was on the
- 7 roof and they were kind of sorting out like who that bike
- 8 belonged to and the backpack. And so, they had somebody
- 9 detained over there. And so TSD Advance Agent was the TSD guy.
- 10 And so, he just wanted his Secret Service representative
- over there to, to say whether, you know, they could release
- 12 witnesses. So, I just went over there, and he asked me to
- 13 come over there. So, I was just trying to kind of sort out
- 14 what exactly was happening.
- 15 HSGAC Minority So were you responsible for securing the
- 16 crime scene?
- 17 Witness I mean, we have like, you know, federal
- 18 presence, so we kind of held our posts until -- the FBI was
- 19 calling me saying they were on their way. So, we kind of
- 20 held our posts until the FBI kind of showed up and took
- 21 over the scene.
- 22 HSGAC Minority And do you recall who from FBI came and
- 23 took over?
- Witness There was so many agents everywhere. But
- 25 I spoke to BBI , but I don't think -- he wasn't



- 1 the one that came.
- 2 HSGAC Minority And is he from the field office?
- 3 Witness The FBI field office in Pittsburgh. He
- 4 used to be a former service agent, so I have a relationship
- 5 with him.
- 6 HSGAC Minority Okay. And did FBI have a presence at
- 7 the rally prior to this shooting? Shots fired?
- 8 Witness Not my knowledge.
- 9 HSGAC Minority Okay. Would you have knowledge if there
- 10 were --
- 11 Witness I should.
- 12 **HSGAC Minority** -- other federal agencies that were
- 13 present?
- Witness I should.
- 15 HSGAC Minority Okay. Did you have knowledge of any
- 16 other federal agencies?
- 17 Witness So I was made aware at some point that
- 18 there was an ATF agent, but I did not know that he was
- 19 coming to the site, so I had no idea who coordinated that
- or why he was on site.
- 21 **HSGAC Minority** And when did you find that out?
- 22 Witness I found that out probably around 4
- o'clock p.m. that day.
- 24 HSGAC Minority And how did you find out?
- 25 Witness I believe he was one of -- there was a



- 1 few people that were -- that were saying, you know, hey,
- 2 we're concerned about this bike rack this bike rack that
- 3 was like on, on the outer on the -- like that the staff put
- 4 for, to keep the crowd contained. And he was concerned
- 5 that people, it might fall over, that people might, you
- 6 know, be able to, to get, you know, get over it. And so
- 7 then he kind of brought it to my attention. I was like,
- 8 "Well, who are you?"
- 9 HSGAC Minority Oh, so it was the ATF agent that brought
- 10 it to your attention?
- 11 Witness Yes.
- 12 **HSGAC Minority** Do you recall his name?
- Witness No. I was like, "Who are you?" He said,
- 14 "ATF."
- HSGAC Minority And did he, like, have identifying --
- 16 was he in plain clothes?
- Witness Yeah.
- 18 **HSGAC Minority** He was in plain clothes. Did he show
- 19 you his credential?
- Witness No.
- 21 HSGAC Minority So he just came up to you and said, "I'm
- 22 an ATF agent?"
- Witness Well, he was talking to me about, you
- 24 know, he just was acting like part of the plan. And I was
- just, "Well, who are you?" And he just said, "I'm ATF."



- 1 And then I just, I didn't ask any further questions. I
- 2 mean, at that point I was just like, okay. I don't know.
- 3 HSGAC Minority Did you talk to anyone else about that,
- 4 either that day or later?
- 5 Witness I may have said to someone else, like,
- 6 did you like -- why was ATF -- I may have said to somebody
- 7 else, like, "Did you know ATF was coming?" Or, you know,
- 8 but I don't know.
- 9 **HSGAC Minority** So you still don't know?
- 10 Witness I still don't know why ATF was there or
- 11 who asked them to be there or what their role was.
- 12 HSGAC Minority Okay. And what other federal agencies -
- 13 -
- 14 Witness That's the only one that I know of that
- 15 was that was there.
- 16 **HSGAC Minority** Did DOD have some?
- 17 Witness Oh, the military?
- 18 **HSGAC Minority** Yeah.
- 19 Witness Yeah. the military, the canines and UDS.
- HSGAC Minority And then HSI.
- 21 Witness And then HSI, yeah. And then was
- 22 supplementing of course.
- HSGAC Minority And how many HSIs?
- Witness LES
- 25 HSGAC Minority LES And how many Secret Service?



- 1 Witness LES
- 2 **HSGAC Minority** Is that a normal ratio?
- Witness I would say no.
- 4 HSGAC Minority Okay. What is --
- 5 Witness But they call -- so they have like what
- 6 they call jump teams, so and this is for like campaign, so
- 7 this is like, because he was candidate Trump, and this is a
- 8 campaign they've created these jump teams, so I don't know
- 9 exactly if it's LES you know, the numbers, but usually
- 10 it's like Secret Service agent would be considered like
- 11 a jump team leader, and then you have maybe LES HSI agents
- 12 underneath you, so they get, you know, activated as a jump
- 13 team. So that's kind of what I guess had taken place for
- 14 that day.
- 15 **HSGAC Minority** And is that a new practice or?
- 16 Witness No, I don't think it's new.
- 17 **HSGAC Minority** Okay.
- Witness No.
- 19 **HSGAC Minority** So it's typical for campaign --
- Witness I guess, yeah.
- 21 HSGAC Minority -- protection? Okay. So just want to
- 22 get back. So remind me, you were on the AGR property
- 23 before, or you were not?
- Witness No, I never like -- no, just that after
- 25 the event I was.



- 1 HSGAC Minority So you never walked the property the
- 2 day of, you were up against the fence line?
- Witness Yeah.
- 4 HSGAC Minority Who were you walking up against the
- 5 fence line with? Who was present that?
- 6 Witness Oh, you mean the day of?
- 7 HSGAC Minority Not the day of. During the walkthrough.
- 8 Witness So is myself, Special Agent Site Agent and
- 9 then a multitude of different locals. It was, the ones
- 10 that I recall would've been Lieutenant PSP Officer in Charge and
- Butler Township Chief of Police
- 12 HSGAC Minority PII Okay. And --
- Witness And I think Lieutenant -- I want to say
- 14 Lieutenant -- oh, I don't know. I don't want to -- those
- 15 are the two that I recall. And I know there was others,
- 16 but I'm not sure of any.
- 17 HSGAC Minority Were there concerns brought up about
- 18 either the fence line, or the roof, or the AGR building
- 19 during that conversation?
- 20 Witness So, yeah, I mean the AGR was definitely a
- 21 concern. So we put posts along the fence line, you know,
- looking at the AGR. And it was, you know, to be so that
- 23 nobody would come up on the fence line and there wouldn't
- 24 be foot traffic along that property.
- 25 HSGAC Minority And was there any discussion about



- 1 putting some kind of sheeting or anything on the fence
- lines so folks couldn't see through it and you didn't have
- 3 people gathering there public that weren't part of the
- 4 rally to watch?
- 5 Witness So originally I had suggested that to
- 6 this campaign staff, you know, I want to put the porta
- 7 potties along the fence line, I want to put the FES along
- 8 the fence line. And they did not want that because I think
- 9 their reasoning was that they want as many people in that
- 10 area as possible, so they didn't want anything in that area
- 11 because it would take up their space.
- 12 **HSGAC Minority** Okay. So you don't recall any, you
- 13 know, conversation about opaque material being put up on
- 14 the fence?
- 15 Witness No, no. I mean we said that we had
- 16 banners large banners, we had things that we could use for
- 17 different lines of sight. But had said, you know, no,
- 18 to everything that we suggested.
- 19 **HSGAC Minority** Campaign Staff Lead And that Campaign Staff Lead is the?
- Witness The staff lead.
- 21 **HSGAC Minority** The staff lead. So do you all typically
- you know, defer to the staff? I mean, obviously I assume
- the staff lead doesn't necessarily have security expertise,
- 24 do they? I don't know. Is it like a security person?
- Witness No, I wouldn't say no. They are not



- 1 security.
- 2 HSGAC Minority So does Secret Service usually defer to
- 3 them on these decisions? I mean --
- 4 HSGAC Majority: I'm sorry, HSGAC Minority do you mind getting
- 5 into the mic a little bit more?
- 6 HSGAC Minority Okay. Sorry. Can you hear me better
- 7 now?
- 8 HSGAC Majority: Yes, thank you.
- 9 HSGAC Minority Okay. I was asking if the Secret
- 10 Service typically defers to campaign staff about the
- 11 security decisions or recommendations?
- 12 Witness Yeah, so I mean, typically the campaign
- 13 staff and the details have, you know, a working
- 14 relationship and a mutual respect and understanding. So
- 15 typically, you know, the Secret Service, you know, these
- 16 are the needs of the Secret Service you know, X, Y, and Z
- 17 and the staff, these are the needs of the staff, you know,
- 18 and that's kind of already set in place.
- 19 So I would've thought that these would've been already
- 20 established, this type of, these security concerns that
- 21 the, the staff would be, well, you know, aware of these
- 22 concerns, that it wouldn't be something that would have to
- 23 be discussed on a daily basis during the week. So I was
- 24 kind of shocked that they weren't kind of you know -- I was
- 25 shocked to see that they were pushing back.



- 1 And so, you know, on that walkthrough, specifically
- 2 on that walkthrough with Agent Site Agent when she was giving
- 3 her briefing to her supervisors that again, that line of
- 4 sight was discussed, especially, you know, at the HR area.
- 5 And I pulled in specifically, that's the only time I
- 6 chimed in. It wasn't my briefing or anything, but I chimed
- 7 in at that point because I'm like, look, this is the staff
- 8 detail, this is the staff supervisors. You guys, you know,
- 9 can discuss, you know, the plan moving forward and you
- 10 know, what you are coming to terms with here and the
- 11 agreements that are made. Because, you know, I tried to
- 12 address the issue over and over and I wasn't getting
- 13 anywhere with it.
- So yeah they were well aware of the concerns, and I,
- 15 again, I put them into contact with one another. I stepped
- out of the conversation, they continued their walkthrough
- 17 and nobody ever asked me after that to do anything about
- 18 that line of line of sight. No one asked me to put
- 19 anything there. I was kind of hoping that somebody would
- 20 maybe pull me aside and say, "Hey, don't worry about what
- 21 staff says. It doesn't matter what staff says. Like, I
- 22 want you to put, you know, whatever you can find, or I want
- you to put, you know, farm equipment."
- We had plenty of things that we could have put. But
- 25 that was never -- nothing was ever discussed with me after



- 1 that, or nobody asked him to do anything after further.
- 2 HSGAC Minority Was C/S Team Lead doing a walkthrough
- 3 the same day that you did a walkthrough?
- 4 Witness He did a walkthrough with SAIC Agent
- 5 Site Agent on Wednesday, and then yeah, that morning he walked
- off with the, the Butler ESU teams that morning. Yeah.
- 7 HSGAC Minority Was anyone else present at the
- 8 walkthrough that he did with Site Agent the day before?
- 9 Witness I do not know.
- 10 HSGAC Minority Okay. Do you know if he got on the AGR
- 11 roof?
- 12 Witness I do not know.
- 13 HSGAC Minority Do you know if he physically got on the
- 14 barn roofs where the counter snipers were?
- Witness I don't know.
- 16 **HSGAC Minority** Typically, when the counter snipers
- 17 advance does a walkthrough, do they typically get on the
- 18 roof where it's --
- 19 Witness Yes. Every time I've dealt with CS,
- 20 that's pretty much the only question that they ask me is
- 21 how do I get to onto the roof.
- 22 HSGAC Minority And have you talked to C/S Team Lead since
- 23 the event?
- 24 Witness I emailed him one time and asked what
- 25 time the local CS team was supposed to be posted. And he



- 1 responded with an email.
- 2 HSGAC Minority And what time were they supposed to be
- 3 posted?
- 4 Witness He said that he didn't know, but it was
- 5 his understanding that they were getting there around 9:30
- 6 or something, early in the morning.
- 7 HSGAC Minority And so you emailed him after the event
- 8 to ask him that?
- 9 Witness Mm-hmm.
- 10 **HSGAC Minority** Why did you email him that?
- 11 Witness Because the higher ups and headquarters
- were asking all these specific questions to the SAC, and
- the SAC was asking me, and then, so then I was like, "Well,
- 14 I have to ask him when it was." You know, I wasn't part of
- 15 his plan, so I asked him.
- 16 **HSGAC Minority** Was that part of like an formal
- 17 interview or were they --
- 18 Witness I think they were just trying to get all
- 19 the information. The headquarters was trying to get
- 20 briefed up on the situation.
- 21 HSGAC Minority Okay. And do you recall when that was?
- Witness Probably was like one or two days later.
- HSGAC Minority Okay. And it was staff from the higher
- 24 up Secret Service staff or?
- 25 Witness Secret Service, yeah. I think they were



- 1 trying to brief the director.
- 2 HSGAC Minority Okay. And then just really quick before
- 3 I passed it on to HSGAC Minority, I don't know how I'm doing
- 4 on time. I don't know if anyone can give me a time check?
- 5 HSGAC Majority Seven minutes.
- 6 **HSGAC Minority** Seven minutes? Okay. Where was the
- 7 security room?
- 8 Witness It was like at the main entrance.
- 9 HSGAC Minority What building was it in? Was it in a --
- 10 Witness I think it said like, maybe like LES
- on it. It's like a LES building. It says like LES on
- 12 it. And it was like right when you come in through the
- 13 main gate of the compound.
- 14 **HSGAC Minority** Was it the USDA office?
- Witness LES .
- 16 **HSGAC Minority** LES . Okay. So is it private
- 17 building?
- Witness Yeah, yeah.
- 19 HSGAC Minority Okay. Do you know what --
- 20 Witness It's their, like, where the reception
- 21 would be or their office. The receptionist would sit, I
- 22 guess, you know.
- HSGAC Minority Do you know if they had any security
- 24 cameras in that building?
- Witness I do not know.



- 1 HSGAC Minority How much time do we have?
- 2 HSGAC Majority Seven minutes.
- 3 HSGAC Minority I've got four hours of questions, so I'll
- 4 never get through them. I'm sorry. Two things. I'm just
- 5 going to make a couple statements, because I could ask
- 6 questions on your notes all day long.
- 7 Witness Okay.
- 8 are you aware of the term, see something, say something?
- 9 Witness Yeah.
- 10 HSGAC Minority Is that something that the Department of
- 11 Homeland Security pushes out to the public pretty hard?
- 12 Witness I would think so.
- 13 HSGAC Minority Matter of fact, they actually have a whole
- 14 webpage dedicated to that.
- Witness Okay.
- 16 HSGAC Minority The reason I brought that up is that's
- 17 basic, very, very basic Security 101. And I'm just going
- 18 to say for the record, because I do not have time to ask
- 19 questions, it's extremely concerning that through your
- 20 testimony, it appears that your concerns were dismissed by
- 21 someone. We still don't know who. And I also want to say
- that I understand that everybody has a role and you've have
- 23 to trust other people's roles.
- But are you allowed to discuss and speak out about
- your issues you've identified? I think your answer was,



- 1 yes. You did bring them up. You identified some
- 2 concerns. And then last thing I will say I have to ask the
- 3 question. The photos that you said you took, do they still
- 4 exist?
- Witness Yeah.
- 6 HSGAC Minority So you still have those photos?
- 7 Witness Mm-hmm.
- 8 HSGAC Minority And you provide them to Secret Service?
- 9 Witness So it is my understanding that the Secret
- 10 Service just can pull the everything from your phone. So I
- 11 don't know what --
- 12 HSGAC Minority Can we request that?
- 13 HSGAC Majority If I could interject? I just wanted to
- 14 clarify. The photos that you're asking about are the
- 15 photos from the Friday as opposed to the Saturday?
- 16 **HSGAC Minority** We would like all photos.
- HSGAC Minority Yes.
- 18 HSGAC Minority Anything on her device that is relevant to
- 19 the rally should be produced to us. It would be
- 20 encompassed by the letters that were sent.
- 21 HSGAC Minority And I say that because I don't think we
- 22 have all -- I didn't see vendor photos in this production
- in terms of the Friday, like I assume it was at night, it
- 24 sounded like, or. So I didn't see any nighttime pictures.
- 25 So it does --



- 1 HSGAC Minority And specifically the ones you were
- 2 talking about of people coming in, you said you had
- 3 multiple photos of setups and things like that?
- 4 Witness Yeah, I think I had two photos of just
- 5 like, people that were selling apparel or things like that.
- 6 HSGAC Minority And photos maybe during the event rally
- 7 that you may have taken.
- 8 Witness I didn't take any photos during the
- 9 event.
- 10 HSGAC Majority Our poll for this, just for your awareness for
- 11 purposes of the discussion. The poll of communications
- that you have is just the 13th, so we can go back and pull
- 13 a broader date range for photos.
- 14 HSGAC Minority For photos.
- 15 HSGAC Majority For sure. And for everything, you just
- 16 did this as an expedited slice for today.
- 17 HSGAC Minority I just want to make sure we're clear, not
- 18 just photos. That would include messages that would
- 19 include --
- 20 HSGAC Majority Understood.
- 21 HSGAC Minority -- phone call logs, that would include
- 22 emails, anything related to the planning or the rally
- 23 itself should be produced to us as responsive to the
- 24 letters.
- 25 HSGAC Majority Yes, understood.



- 1 HSGAC Majority Okay. It's been an hour, we're going to
- 2 break and I know your counsel wants to speak to you, so
- 3 we'll plan five minutes, but just let us know.
- 4 [Recess.]
- 5 HSGAC Majority Ready whenever you are counsel, can you
- 6 hear us on Teams?
- 7 MR. Witness Counsel Yes.
- 8 HSGAC Majority Okay. Thank you.
- PSI Majority Hi, Senior Special Agent Witness Thank
- 10 you. I know it's a long day. I want to start by asking a
- 11 few follow up questions from your notes. Exhibit 1, you
- write CUAS, "Why wasn't I told that it wasn't properly
- 13 working?" So is it accurate to say you were not aware the
- 14 entire day that the CUAS system was not functional? Is that
- 15 correct?
- Witness Correct.
- PSI Majority When did you learn that it was
- 18 functional?
- 19 Witness I was never told that it was or was not
- 20 functional. I just assumed it was functional the entire
- 21 day.
- PSI Majority And is that something that should have
- 23 been relayed to a site counterpart site agent like
- 24 yourself?
- Witness Yes.



- 1 Page 2 of your notes you write under PSI Majority 2 communications, "Why wasn't anything relayed to me so that 3 I could address it?" I'd like to take a step back and 4 first ask, what radio frequencies were you on that day? 5 So the post standards were on, they Witness 6 started on Channel and the shift was on Channel 7 PSI Majority And why did they switch 8 Around I want to say around 4:30 p.m., I Witness 9 received a phone call from my supervisor saying that there 10 was some kind of bleed over. They were hearing bleed over 11 on the radio and that yeah, the post standards were to 12 switched to Channel 13 PSI Majority What does that mean push to Channel? 14 Switch to -- switch frequencies. Witness 15 PSI Majority Oh, switch? 16 To Channel Witness Yeah. 17 PSI Majority And I didn't I missed the Channel 18 Witness Channel Yeah. Channel 19 **PSI** Majority 20 Witness To Channel Yeah.
- 21 PSI Majority Understood. Who's your supervisor?
- 22 Witness It was s SAIC Pittsburgh that made the call to
- 23 me.
- 24 PSI Majority Is that common for the radio systems to
- 25 have interference or not function?



- 1 Witness Yeah, I mean it would be common to have
- 2 bleed over. But you know, when I went back and looked,
- 3 they weren't operating -- the first lady, it didn't show
- 4 that they were operating on this frequency. So I don't
- 5 know if that was truly what they were hearing.
- PSI Majority And I'm showing you what's been marked as
- 7 I believe Exhibit 8. Do you have an Exhibit 8? Are we at
- 8 8 or 9, Brad?
- 9 MR. Witness Counsel 8.
- 10 PSI Majority I'm showing you what's been marked as
- 11 Exhibit 8 and 9. Bate stamped 669 and Bates stamped 716.
- 12 Do you recognize these documents? And HSGAC Majority can put
- 13 them up on the screen. On the first document, 669 is this
- 14 an email that --
- 15 [Exhibit No. 8 and 9 were
- marked for identification.]

17

- 18 Witness This was a text message that I believe I
- 19 sent to Special Agent Lead Agent.
- PSI Majority And this is at 9:30 in the morning. So
- 21 what happened?
- 22 Witness So typically you like, it's best practice
- to be able to scan both channels, right? I am telling you
- 24 that code centers operate on one frequency, shift operates
- on another frequency. In an ideal world, you're going to



- 1 want to listen to be able to listen to both frequencies.
- 2 So when I try to set up the security -- I was setting up
- 3 the security room in the morning when I tried to do the
- 4 comms of the scanning. I couldn't get it to scan properly,
- 5 so I was on the phone with radio communications person
- 6 trying to address this issue.
- 7 **PSI Majority** Who was that?
- 8 Witness I don't know. I don't know who it was.
- 9 PSI Majority Was it someone with the Secret Service
- 10 or?
- 11 Witness Yes.
- 12 PSI Majority Okay. And who is responsible for all of
- 13 the Secret Service communication systems on the day of the
- 14 rally?
- Witness So there's a security room, it's just a
- 16 standard security room that's set up. It was, you know,
- 17 the site agent's really responsible for making sure that
- 18 the security room's set up and that there's communications.
- 19 PSI Majority And that would be Special Agent Site Agent
- 20 Witness Correct. But, you know, she's not in
- 21 charge of the radios or, you know, functioning of the
- 22 radios or anything like that. She's not like a radio
- 23 expert. So CIO would be in charge of any issues you know,
- 24 the radios may be having.
- 25 PSI Majority And is CIO remote, were they on site that



- 1 day?
- Witness No.
- 3 PSI Majority And what other radio frequencies did you
- 4 have the ability to tap into, such as state and local
- 5 frequencies?
- 6 Witness We don't have the ability to tap into
- 7 state and local frequencies.
- 8 PSI Majority Were you ever offered, or did you receive
- 9 a you know, radio from either the state frequency or the
- 10 local frequencies, PD ops four or three?
- 11 Witness Was I personally, no.
- PSI Majority Do you know if Site Agent Site Agent was?
- 13 Witness I do not know, but typically that would
- 14 be something that would be between like tactical teams or
- 15 counter sniper teams.
- PSI Majority Who is responsible for ensuring the
- 17 interoperability of communications that day to ensure
- 18 locals can communicate with state and state can communicate
- 19 with Secret Service. Who oversees that from Secret
- 20 Service?
- 21 Witness So it's just part of the security plan.
- 22 It's the security room it's set up by the site agent.
- 23 PSI Majority And when you mentioned the security plan,
- 24 is that a document?
- Witness I mean, there's a site diagram, but.



- 1 PSI Majority But is there a document that you know?
- Witness No.
- PSI Majority No. So are there any other documents
- 4 like that detail, the site security other than the
- 5 preliminary survey, the manpower request, the manpower
- 6 brief, the police brief? Any other documents that are used
- 7 in preparation for advanced planning to secure the July
- 8 13th rally site?
- 9 Witness I mean, there could be documents such as,
- 10 you know, whatever the supervisors are requesting the site
- in it. So I know, you know, the DT you know, Site Agent
- 12 Site Agent told me that she takes photos of, you know, the
- 13 walking path of, you know, former President Trump and maybe
- 14 photos of the stage looking out or photos looking into the
- 15 stage, which is kind of a standard practice that you do
- 16 when you're on the president's detail. And the supervisors
- 17 from Donald Trump's detail were part of the president's
- detail, so I think they kind of took that practice.
- 19 PSI Majority Did you take any notes that day?
- 20 Contemporaneous notes, notes as you're securing the site?
- 21 Witness I think I jotted down like site post,
- 22 like a site post log.
- 23 **PSI Majority** And what did you do with that?
- 24 Witness I'm sure I have it. It would be like the
- 25 same though as the site post log that I've like -- that



- 1 would be, I don't know if you have the site post log.
- 2 PSI Majority Are there any other documents? Such as -
- 3 –
- 4 Witness I did the site post log and the site post
- 5 instructions
- 6 PSI Majority And the site post instructions. And you
- 7 took notes on those documents that day?
- 8 Witness I didn't take notes, I was just writing
- 9 my site posts.
- 10 PSI Majority Understood. And did you provide those
- 11 documents to Secret Service?
- 12 Witness I have them.
- PSI Majority You have them?
- Witness Yeah.
- 15 PSI Majority I mean, and we will follow up. We'd like
- 16 a copy of those documents. Referring back to Exhibit 1 the
- 17 second page of your notes page 791. We spoke about the
- 18 beginning of the last paragraph when you mentioned how you
- 19 weren't aware of threats. But I'd like to focus on the
- 20 second part of that where you say, "Why did they feel that
- 21 only one part of SOD was sufficient to cover it instead of
- 22 the entire package?" What do you mean by that?
- 23 Witness I was just basically saying like they
- only sent out counter snipers. Why didn't they send out a
- 25 CAT element? Why didn't they send out CSU?



- 1 PSI Majority And these, these are the assets you
- 2 raised in advance as well of the rally?
- Witness Yeah, yeah, I mean, I said CAT L and O, I
- 4 mean.
- 5 **PSI Majority** Right.
- 6 Witness Yeah.
- 7 PSI Majority And moving forward I'd like to talk about
- 8 the week of July 8th and the walkthroughs that you did. Do
- 9 you recall when you did the first walkthrough of the site?
- 10 Witness It would've been Monday.
- PSI Majority Monday July 8th?
- 12 Witness Correct.
- PSI Majority And who did you do that walkthrough with?
- 14 Witness Special Agent Site Agent and Special Agent
- 15 Lead Agent and the Trump campaign.
- PSI Majority And what vulnerabilities did you identify
- 17 during that walkthrough?
- Witness We just basically stood on the ground and
- 19 looked around 360 degrees and just said, you know, there's
- 20 line of sight problems everywhere.
- 21 PSI Majority And can you be more specific? Was the
- 22 water tower something you identified?
- 23 Witness I don't recall whether we discussed the
- 24 water tower.
- 25 PSI Majority Do you recall any specific



- 1 vulnerabilities that --
- 2 Witness I mean, you could see -- yeah, you could
- 3 see like businesses you knew, you could see you know, main
- 4 Streets 68, you could see neighboring, you know,
- 5 residences. You had all these hangers. So there was a lot
- of rooftop buildings that were in close proximity.
- 7 PSI Majority And that includes the AGR building?
- Witness Correct.
- 9 PSI Majority And did you memorialize this walkthrough
- 10 at all in your findings? You and/or special Agent Site Agent or
- 11 Lead Agent ead Agent?
- Witness Well, I'm not sure wat --
- 13 PSI Majority After you did the walkthrough or while
- 14 you did the walkthrough, did you memorialize your findings?
- 15 Did you fill out a form, take notes, anything like that?
- 16 Witness No, I mean, this was all an initial
- 17 walkthrough. This is, we didn't even know at the time what
- 18 the Trump campaign, where they were going to put the stage.
- 19 So they choose where they put the stage.
- PSI Majority Was this the walkthrough you used to
- 21 determine the varying perimeters, the inner middle and
- 22 outer perimeter?
- Witness No.
- 24 PSI Majority So throughout the week of the 8th, you
- 25 had a series of meetings, a planning meeting on July 8th.



- 1 And did anyone take -- did anyone take notes?
- 2 HSGAC Minority Did anyone take notes? You said you
- 3 didn't take notes during the walkthrough. Did anyone take
- 4 notes? Did you see anyone with a pen and paper?
- 5 Witness During the initial walkthrough on Monday?
- 6 I'm sure people took notes, I'm sure probably Agent Site Agent
- 7 I'm sure, probably took notes. I'm sure Special Agent Lead Agent
- 8 probably took notes. I know when we did the police
- 9 walkthrough, I was going to get a pen and paper to take
- 10 notes and Lieutenant PSP Officer in Charge said, you know, no, he's
- 11 taking the notes for the police post, so don't, like, I
- 12 didn't have to worry about taking the notes, so I didn't
- 13 take the notes of that walkthrough.
- PSI Majority And the police walkthrough, was that the
- 15 July 11th walkthrough you're referring to?
- Witness Thursday.
- PSI Majority So before we get there, there's a
- 18 planning meeting on July 8th when you have these types of
- 19 meetings. The planning meeting included officials from the
- 20 Secret Service state and local law enforcement. Is there a
- 21 sign in sheet or is there a --
- 22 Witness Are you talking about the police meeting
- 23 on --
- 24 PSI Majority The planning meeting on Monday, July 8th
- 25 at Allegheny County Emergency?



- 1 Witness So that's the police meeting. Yeah,
- 2 there's a sign in sheet.
- 3 **PSI Majority** So there's a sign-in sheet. At that
- 4 meeting, is there a readout or summary of the meeting?
- Witness No.
- 6 **PSI Majority** During that meeting, was there any
- 7 discussion of potential threats and vulnerabilities for the
- 8 rally site?
- 9 Witness I don't recall that. I don't think that
- 10 -- I don't think that occurs at those meetings.
- 11 PSI Majority Did anyone mention the AGR building at
- 12 that meeting to your knowledge, if you recall?
- 13 Witness Not to my knowledge, no.
- PSI Majority At that meeting or throughout the week,
- did state or local law enforcement offer resources or
- 16 support that Secret Service declined to your knowledge?
- 17 Witness Not to my knowledge.
- 18 PSI Majority So moving forward, on July 9th Secret
- 19 Service requested two snipers from Butler County. Were you
- 20 aware of that?
- 21 Witness Secret Service requested two snipers?
- PSI Majority Yes.
- 23 Witness So Special Agent Site Agent is the one that
- 24 was in contact with the Butler, ESU. I never was in
- 25 contact with them, so I was not made aware that that Secret



- 1 Service requested that. She had actually told me that
- 2 they didn't -- that they originally told her they didn't
- 3 have local CS. So again, that might be why, you know,
- 4 Secret Service was in my mind why Secret Service came out.
- 5 PSI Majority When you have local snipers at an event
- 6 based on your experience and professional, you know,
- 7 expertise, does that raise the threat level to you?
- 8 Witness No. It would help the -- it would help
- 9 mitigate threats if you have snipers that are able to take
- 10 higher ground and look at the buildings.
- 11 PSI Majority I'll rephrase the, the question. The
- 12 fact that snipers are being brought in, does that imply to
- 13 you that there is a greater level of threat -- potential
- 14 threat? I think I'll ask more directly. Did you receive
- 15 any new information of potential threats that week?
- Witness No.
- 17 PSI Majority Were you aware that local law enforcement
- 18 did a preliminary walkthrough of the site the evening of
- 19 Tuesday, July 9th?
- 20 Witness I seen them. If you were talking about
- 21 the same people, I saw local law enforcement at the site
- 22 and we convened and then we went to the police barracks,
- 23 but I don't know whether you were talking about the same
- 24 entity.
- PSI Majority When was that?



- 1 Witness Tuesday.
- 2 **PSI Majority** Tuesday?
- Witness Is that what you're asking me? Tuesday?
- 4 PSI Majority Yes. So on Tuesday, was this in the
- 5 evening?
- 6 Witness Mm-hmm.
- 7 PSI Majority And you did a walkthrough of the site
- 8 with, were you doing a walkthrough of the site with local
- 9 law enforcement?
- 10 Witness Yeah, so we were kind of like, you know,
- on the grounds looking around and that's when I said, "Hey,
- 12 like it'd be easier if we could get an overview map sit
- down and like, you know, put it on screen and discuss it
- 14 because it's such a large area." And then, so that's what
- we did, but I don't know if we're talking about the same
- 16 people.
- 17 PSI Majority And so do you recall who you met with
- 18 from local law enforcement?
- 19 Witness Yes, it was Lieutenant PSP Officer in Charge and
- 20 Lieutenant PSP Lieutenant .
- 21 PSI Majority And did you ultimately go to the barracks
- and pull up a map and look at everything?
- Witness Mm-hmm.
- 24 PSI Majority And tell me about that meeting.
- 25 Witness So yeah, it was Special Agent Lead Agent



- 1 Special Agent Site Agent myself PSP Officer in Charge ,
- 2 PSP Lieutenant , and three Butler Fire, EMS personnel, or
- 3 sorry, Butler, EMS personnel. So yeah, we just pulled it
- 4 up on the, they had like a smart screen and we just, you
- 5 know, he tried to outline like, the perimeter of the site.
- 6 And then we just kind of talked about, you know, where we
- 7 could put different assets, you know, where could the
- 8 firetruck go, where could a hazmat go? Where could we put
- 9 police vehicles where could post be?
- 10 PSI Majority Did you discuss who was responsible for
- 11 the AGR building?
- 12 Witness So that's when the conversation took
- 13 place where PSP Officer in Charge said that he knew the owner,
- 14 he spoke with the owner. The owner said that they were
- 15 going to close business for the day. It was going to be
- 16 locked, secured, and posted.
- PSI Majority And so who was responsible for covering
- 18 that building?
- 19 Witness I didn't ask specifically who was posting
- 20 that building. I just, he told me it was being posted and
- 21 I took that to mean that it's covered.
- 22 PSI Majority Do you know --
- 23 Witness I also know that we had, you know, it
- 24 wasn't just those, you know, those particular posts. We
- 25 had, you know, four posts in front of the building. We



- 1 had, we had a **LES** posts on the other side of the
- 2 building. We had, at this point, I'm told we have four CS
- 3 teams inside the building. So I'm thinking we have
- 4 coverage everywhere.
- 5 PSI Majority And moving forward to July 11th where there is
- 6 a USS held a walkthrough of the rally site, did any local
- 7 law enforcement approach you and Special Agent Site Agent to
- 8 raise specific concerns about the AGR building?
- 9 Witness Nobody approached me. Are you talking
- 10 about Thursday?
- PSI Majority Yes.
- 12 Witness Nobody approached me to raise --
- PSI Majority So you don't recall a conversation where
- 14 local law enforcement made it clear they did not have the
- 15 manpower to lock down the AGR building?
- 16 Witness That was not a conversation I took part
- 17 of.
- PSI Majority If Secret Service is aware that local law
- 19 enforcement does not have the manpower to lock down the
- 20 building in the outer perimeter, whose responsibility is it
- 21 to ensure coverage of that building?
- 22 Witness Sorry, could you repeat the question?
- 23 PSI Majority If Secret Service is aware that local law
- 24 enforcement does not have the manpower to lock down a
- 25 building that is a potential threat, whose responsibility



- 1 is it to ensure coverage of that threat?
- Witness Well, they would just have to find other
- 3 means. Whether it's who --
- 4 PSI Majority Who's they?
- 5 Witness This, I guess the site agent would have
- 6 to find --
- 7 PSI Majority The Site Agent and that would be Site Agent?
- 8 Witness Correct.
- 9 PSI Majority And prior, you mentioned in your notes
- 10 the million-dollar question is why wasn't anyone on the
- 11 roof of the AGR building. Prior to the event, was your
- 12 understanding that law enforcement would be on the roof of
- 13 the AGR building?
- 14 Witness Again, I found out that the day before
- 15 that, in the instructions that the CS advanced sent out,
- 16 C/S Team Lead sent out, it said that they were going to be
- 17 located inside the AGR building. So at that time, I knew
- that they were going to be inside the AGR building. I did
- 19 not know why. It's not something I've seen in the past. I
- 20 didn't question it but I still thought that the roof was
- 21 still covered. You know, I didn't think, "Oh, now that
- they're going to drop coverage because they're inside." I
- 23 still thought they have that responsibility or somebody is
- 24 covering that.
- 25 PSI Majority Were you in any conversations where



- 1 Secret Service considered stationing post standards at
- 2 or near the AGR building?
- Witness I was not part of conversations. I mean,
- 4 I was part of conversations with Special Agent Lead Agent and
- 5 Site Agent about, you know, what gets approved in the past as
- 6 far as like post standing. Because again, as I've
- 7 explained, that's typically not a USS post standing
- 8 position because it's non-discretionary. You know, it's
- 9 more of a general observation. It's, you know, nobody's
- 10 walking through that post in terms of, you know, Secret
- 11 Service and pins and who can I identify. So it's not
- 12 typically something that would get approved. And I've even
- 13 had the conversation with Lead Agent and she said, yeah, that
- 14 wouldn't get approved.
- PSI Majority Why wouldn't it get approved if it's a
- 16 security threat?
- 17 Witness It would be a police post. It would be a
- 18 police post that they would expect to be covered by police.
- 19 PSI Majority But what if the police did not have the
- 20 manpower to secure the building? Whose responsibility is
- 21 it then to ensure coverage?
- 22 Witness I guess then you would have to go back
- and justify and say, "Hey, police does not have the
- 24 manpower to insure it. So now we are going to request a
- 25 Secret Service body there."



- 1 PSI Majority And do you know if that happened for
- 2 the July 13th rally?
- Witness To my knowledge that AGR building was
- 4 covered, so I do not think that that would've happened.
- 5 PSI Majority To your knowledge, based on what you know
- 6 now, was the AGR building covered in the way that you
- 7 thought it was?
- 8 Witness To my knowledge, the AGR building was
- 9 covered. Yeah, I don't know that it was -- like if you're
- 10 telling me that it wasn't covered --
- PSI Majority Well, I guess so. Saying it's covered
- 12 is very vaque.
- Witness Mm-hmm.
- PSI Majority And so you testified that you understood
- 15 the AGR building was covered. There was a security failure
- 16 at the event that occurred on the roof of the AGR building.
- 17 Based on what you know now and where everyone was
- 18 positioned in your view, based on your professional
- 19 experience, was that building covered?
- Witness Well, if we're talking about the rooftop
- 21 --
- PSI Majority That would be the building and the roof,
- 23 because the shooter used the area around the building to
- 24 access the roof.
- Witness Yeah. So you, again, like, I don't know



- 1 how many people at that time, you know, it could be that
- 2 he just slipped through a crack and got managed to get on
- 3 the roof. So I can't say whether how many people were
- 4 around the perimeter of the building.
- 5 PSI Majority Based on the operation plans that you
- 6 reviewed, the Pennsylvania State operation plan that shows
- 7 all the post standards, the preliminary survey, the site
- 8 diagram, Secret Service site diagram, based on all of that
- 9 information that lays out the planning, in your view, was
- 10 that building covered?
- 11 Witness The building should have been covered,
- 12 yes.
- PSI Majority Was it covered?
- 14 Witness I don't know. Did they drop posts? Did
- 15 they -- I don't know that question, but the building should
- 16 have been covered.
- PSI Majority And you mentioned Special Agent Site Agent
- 18 determined to the perimeter for the event. How is that
- 19 reviewed? Who signs off on that?
- 20 Witness It would be her supervisors.
- 21 PSI Majority And who's her supervisors?
- 22 Witness At the time the supervisors came and did
- the walkthrough would've been DTD 2nd Sup. , ASAC, DTD 2nd Sup.
- 24 DTD 2nd Sup. and ASAC, DTD 2nd Sup.
- 25 PSI Majority And when those two individuals approved



- 1 the perimeter, they were on site? It's not like they're
- looking at a diagram, they're physically on site. Is that
- 3 correct?
- 4 Witness Correct.
- 5 PSI Majority Okay. Have you participated in any after
- 6 action reviews of what went wrong that day?
- 7 Witness No.
- 8 PSI Majority Are you aware of any ongoing after-action
- 9 reviews of what went wrong that day?
- 10 Witness I'm not aware of. I'm sure there's lots
- of after action, but I haven't partaken in any.
- 12 PSI Majority Did you contribute to the final site
- 13 survey?
- 14 Witness The final site survey?
- 15 PSI Majority Our understanding is that after every
- 16 event, a final site survey is created.
- 17 Witness You're saying site survey?
- 18 **PSI Majority** Correct.
- Witness That's confusing me. I think it would
- just be a final survey.
- 21 PSI Majority Okay. Final survey. I apologize. Final
- 22 survey.
- 23 Witness So a final survey is the responsibility
- of the lead agents to complete. So that would not be,
- yeah, that would be special agent.



- 1 PSI Majority Fine. Do you know if that survey is
- 2 complete?
- Witness I have no idea.
- 4 PSI Majority Under Secret Service processes and it
- 5 sounds like you've done many of these final surveys before
- 6 as a lead agent. Do you fill out the survey and submit it
- 7 or do you circulate it for review?
- 8 Witness I think you usually just upload some
- 9 documents.
- 10 PSI Majority Okay. To your knowledge, have any Secret
- 11 Service personnel involved in the July 13th event been
- 12 removed from duty reassigned, placed on leave, or
- 13 terminated?
- 14 Witness I do not know. I only know can speak of
- 15 Pittsburgh. We are just told that we're not supposed to
- 16 come into the field office.
- PSI Majority And have you personally received any
- 18 disciplinary actions?
- 19 Witness Not like, I don't know. Disciplinary --
- 20 I haven't really been --
- PSI Majority It's a vague question. I don't, I guess
- 22 --
- Witness No one's really explained.
- PSI Majority What discussions had Secret Service had
- with you after the event, if any?



- 1 Witness You know, I was just told, you know,
- 2 not for a while. I was just told recently within a couple
- days, my staff had reached out and said, "Hey, you know,
- 4 nobody's to do any investigations or any protection. You
- 5 still, you know, have your gun and badge and or still
- 6 working, but you're working from home." And you know, this
- 7 is just a standard disciplinary action that, you know,
- 8 that's what I'm being told, that this is the disciplinary
- 9 action that working from home. But I don't know what any
- 10 of that means. I haven't seen anything in an email. I
- 11 haven't -- I don't know if there's like a file.
- PSI Majority Did you ask any follow up questions?
- Witness I did not.
- PSI Majority What happened at the July 13th rally was
- 15 a, you know, near miss. And our understanding it's what
- 16 Secret Service refers to as a, "unusual protective event or
- 17 incident." Are you aware of any other near misses or such
- 18 incidents in past Secret Service events?
- 19 Witness I'm not aware.
- 20 **PSI Majority** After the July 13th rally and shooting,
- 21 do you know if anyone completed a SSF 4386 form? It's the
- 22 unusual protective event form.
- 23 Witness So that would fall under the
- 24 responsibility of the protective intelligence agent. Okay.
- 25 And I do not know if he completed something like that.



- PSI Majority And who was that?
- Witness Special Agent Intel Advance Agent .
- PSI Majority To your knowledge, have there been any
- 4 reports or memoranda documenting the circumstances of what
- 5 happened?
- Witness Not to my knowledge.
- 7 PSI Majority Is there anything we haven't -- we've
- 8 talked a lot about the day but you've been doing this job
- 9 for nearly two decades in a number of different capacities.
- 10 We are trying to quickly learn as much as we can. And are
- 11 there things that you think are important for us to know
- that you think we should be aware of that we haven't talked
- 13 about?
- 14 Witness I mean, you have my notes, you have my
- 15 concerns. I think that, you know, everybody involved
- doing, you know, any type of plan would want as many assets
- 17 given them to them as possible. I mean, I know that
- 18 there's things out there why they aren't being used, I
- 19 don't know. Like we have glass that could be used, you
- 20 know, in front of the Protectee. That's again, probably an
- 21 asset that I would assume would be the lead that would
- 22 request through TSD or Technical Security Division.
- So I quess, you know, if you're asking me my opinion
- or speculate, you always want, you know, as many assets as
- you can, especially for this type of rally, you know. And



- in hindsight you think, well, you know, maybe Secret
- 2 Service, maybe they should have input into the type of
- 3 venue. Or if you're having this type of venue at such a
- 4 large event maybe you should be given assets that maybe you
- 5 wouldn't normally be given for, you know, a former or a
- 6 candidate or things like that. Instead of just being like,
- 7 okay, the first lady gets this and this person gets this
- 8 and this person gets this, like, you know, to me it doesn't
- 9 make much sense to have the first lady have a counter
- 10 surveillance unit that day and not candidate Trump, because
- 11 the first lady went to like an indoor dinner at like a
- 12 casino.
- I don't know that that would've been relevant to have
- 14 counter surveillance for that. I think it would've been
- much more relevant to have it at a huge rally with 15,000
- 16 people. But those decisions aren't from me. Those are,
- 17 you know, something that I guess is established. And
- 18 again, I don't think that it typically, it's like a let's
- 19 evaluate things on a case by case. I think it's kind of
- 20 something that like, is established and then it just kind
- of sticks. So that's just something that I think hopefully
- 22 may change.
- PSI Majority Thank you. And anything else about that
- 24 day that, that you are aware of that you think should be
- 25 brought to our attention that we haven't discussed here



- 1 today? And not just the day, but the proceeding weeks
- 2 just, just anything, you know, involving planning, you
- 3 know, things that, that you think went, went wrong. Just
- 4 things that you think that we should be aware of.
- Witness Yeah, I would just say that, that there
- 6 was so many -- that there was an overwhelming amount of
- 7 staff concerns. I think that I don't know if it was people
- 8 that have never worked, you know, the event before, but I
- 9 think that that was a problem. I think in the, you know,
- 10 everything that I was trying to address with staff was just
- 11 immediately shut down. And I think that the whole event
- 12 could have gone a lot better.
- And I'm not really saying like, in terms of security,
- 14 but it could have maybe relieved some other problems in
- 15 terms of like, there was over, you know, 100 medical
- 16 issues. They didn't have any shoots. It just wasn't a
- 17 proper build out. And I think that's something that moving
- 18 forward, that needs to be addressed between the detail and
- 19 the staff.
- Because you know, when President Trump was the
- 21 president that there was, I think a very -- I think the
- 22 staff had a very good idea, you know, and it's different
- 23 because he did a lot of -- it was COVID, right? And he did
- 24 these airport rallies. And so, but they were pretty much
- like the same, you know, you knew what you, the build was



- 1 going to be, you knew what it was going to look like.
- 2 You knew what to expect. There was an expectation.
- 3 So I think, you know, working this, it didn't look
- 4 like that expectation was met on the staff side of things.
- 5 I don't know why. I don't know if that relationship isn't
- 6 built between the details or if it was a new whole new
- 7 group. I know was not new because he was on, you
- 8 know, a staff chart face sheet so.
- 9 **PSI Majority** When you say Campaign Staff Lead
- 10 Witness The staff lead.
- PSI Majority Lead Agent ?
- 12 Witness No, Campaign Staff Lead, the staff lead, yeah.
- PSI Majority Was Special Agent Lead Agent new?
- Witness No, no. No.
- PSI Majority And when you just mentioned you know, an
- 16 overwhelming number of staff concerns what were the -- can
- 17 you talk about what those concerns were?
- 18 Witness Yeah. I mean, I wrote them down here in
- 19 my notes here. So it was just like a lot of medicals. It
- 20 was that there wasn't -- you know, when I met with Butler,
- 21 EMS, you know, we wanted shoots for the -- because they had
- 22 UTVs to be able to if somebody falls out of the heat, you
- 23 know, it was like 90 some degrees. If somebody is falling
- out, like we want to be able to get to them, we want to be
- 25 able to pull them out. There was medical treatment tents,



- 1 there was cooling tents.
- 2 You know, if there's a problem in the crowd, we want
- 3 to be able to address the problem. We need to get to this
- 4 problem. And they didn't have any type of shoot, they
- 5 didn't have any type of like, you know, lanes for us to be
- 6 able to walk through like the crowds. So everybody was
- 7 like jammed in. And to me that was a huge concern. So I
- 8 would hope that maybe moving forward that some of these
- 9 concerns maybe get addressed.
- 10 HSGAC Majority Special Agent Witness just a few follow
- 11 up questions. Where were you when shots were fired?
- 12 Witness In the security room.
- 13 HSGAC Majority Okay. Did you leave the security room
- 14 after shots were fired?
- Witness I did.
- 16 **HSGAC Majority** When did you leave the security room?
- 17 Witness As soon as I heard shots fired.
- 18 HSGAC Majority Could you tell where the shots were
- 19 coming from?
- 20 Witness I didn't hear the shots itself, but I was
- 21 just, I just went directly to the crowd and then you could
- 22 hear people screaming and looking. So at that point, when
- I went through the crowd, I kind of assumed that, yeah, I
- 24 kind of knew the direction that they were coming from.
- 25 HSGAC Majority Did you observe Secret Service counter



- 1 snipers fire their weapon?
- Witness I did not.
- 3 HSGAC Majority Did you observe any local law
- 4 enforcement fire their weapon?
- Witness No.
- 6 HSGAC Majority Have you since learned that local law
- 7 enforcement did fire their weapon?
- 8 Witness I heard that, yes.
- 9 HSGAC Majority You heard that, but did you receive
- 10 confirmation of that?
- 11 Witness I did not receive confirmation of that.
- 12 **HSGAC Majority** Regarding the questions my colleague was
- 13 asking about the AGR building and what you understood to be
- 14 covered or not? So clearly the former president was shot.
- 15 Former director Sheetal testified that this was a failure
- 16 by the Secret Service. Acting Director Roe testified that
- 17 this was a failure by the Secret Service. Do you agree
- 18 that there was a failure by the Secret Service?
- Witness Yes.
- 20 **HSGAC Majority** You also testified today that you felt
- 21 you had a good security plan going into the event?
- Witness With the assets given.
- HSGAC Majority Understood. And you also said today
- 24 that you thought AGR was covered by the locals. You didn't
- 25 know exactly how, but your understanding was it was



- 1 covered. So if you agree there was a failure, but you
- 2 believe you had a good security plan and you thought AGR
- 3 was covered, what do you think was the failure?
- 4 Witness I think the failure was that somebody
- 5 wasn't on the roof. Obviously my understanding was that
- 6 the roof was covered, but it appears that it wasn't
- 7 covered. And I think there was also like a big
- 8 communication breakdown. It appears that, you know, the
- 9 word wasn't getting out to the right entities. And again,
- 10 to me as well, I wasn't made aware that anything, I never
- 11 was made aware that there was even a suspicious person.
- 12 That's a problem.
- I should be made aware on everybody at the site should
- 14 be made aware of these concerns. It's everybody's
- 15 responsibility. We're, one unit. We're one team, one
- 16 mission. Everybody has a responsibility that's there. So
- 17 everybody needs to know everything that's going on.
- 18 HSGAC Majority Do you have any personal lessons learned
- 19 from that day and again, the failures that happened?
- 20 Witness Yeah, I mean, I guess you can't rely on -
- 21 you can't just rely on local counterparts. You can't
- 22 just rely -- I don't know. I think it's going to be, you
- 23 know, if I'm given -- again, I don't know if I'm now given
- 24 a tactical plan, I'm not a tactical person, but am I going
- 25 to have to -- I guess I'm going to have to maybe dive a



- 1 little deeper into their plan and maybe ask questions.
- 2 And again, like I think it's a little bit different
- 3 because this isn't like the president's detail you do. It
- 4 is more thorough. It is, you know, you do have more
- 5 meetings, you do have more meetings with staff, meetings
- 6 with all the entities in a group. So I think moving
- 7 forward, you know, I'm going to say, "Hey, we have to all
- 8 meet, as, you know, as one team. We all are going to have
- 9 to go through each area of responsibility and discuss it
- 10 and analyze as one unit to make sure that we're all on the
- 11 same page here."
- 12 And again, like they had a briefing and I don't know
- 13 why or how it got missed, or they were supposed to be, or
- 14 not twisted, but CS was not part of that briefing. So
- 15 maybe if they were, maybe there could have been a different
- 16 outcome. I don't know. You know, it's hard to say.
- 17 **HSGAC Majority** But just to clarify, if you agree with
- 18 Directors Cheadle and Roe, that there was a failure
- 19 specifically by the Secret Service, are you saying that you
- 20 think that Secret Service failure was the mistake to assume
- 21 that your local counterparts were going to do their job?
- 22 Or is it something specific that Secret Service either
- failed to do or did improperly?
- 24 Witness I think it was a totality of a lot of
- 25 different things.



- 1 HSGAC Majority Does that include something specific
- 2 that the Secret Service failed to do other than make
- 3 assumptions about the locals?
- Witness Well, yeah, moving forward. I mean, you
- 5 can't assume that, you know, Secret Service can't assume
- 6 that, that the locals are covering something. Right.
- 7 Because, you know, I don't know. I don't know what the
- 8 conversations were to be had, but if the locals are saying
- 9 they weren't covering it, then yeah, moving forward, then
- 10 yeah, we need to clarify. Maybe it needs to be more in
- 11 writing, maybe it needs to be -- you know, but yeah,
- 12 everything needs to now be more clarified because clearly
- 13 there's a miscommunication here.
- 14 You know, Secret Service may be saying that they
- 15 thought the locals had a locals may be saying, you know,
- 16 no, we thought Secret Service had it. Yeah. So, yeah,
- 17 there's a breakdown here and it certainly needs to change
- 18 moving forward.
- 19 HSGAC Majority Have you provided these opinions or
- 20 assessments to anyone in the Secret Service? I know you
- 21 mentioned, you know, possible ongoing after-action reports,
- 22 but in any of your interviews or any of your conversations
- 23 since the event, have you provided this input about your
- 24 lessons learned?
- 25 Witness I think it's -- I don't know that I've



- 1 specifically provided my input. I think it's just
- 2 pretty common knowledge that there's breakdowns here. I
- don't know that anyone specifically asked me what you're
- 4 asking me, but.
- 5 HSGAC Majority You had talked about resource
- 6 constraints. Do you think Secret Service resource
- 7 constraints contributed to any of the failures at that
- 8 rally? Such as having to rely on HSI?
- 9 Witness I don't know that I could say
- 10 specifically that. I don't know that I could answer
- 11 specifically like that. I think, you know, obviously you
- 12 want as many assets as you can, but I can sit here and say,
- 13 you know, anything's like you're saying, I can't say HSI
- 14 had anything to do with this, you know.
- 15 **HSGAC Minority** In events you've previously staffed,
- 16 have you been in situations where Secret Service did not
- 17 have sufficient staff to staff an event?
- 18 Witness Staff, like the campaign staff or?
- 19 HSGAC Minority Like, to secure an event, any.
- Witness Happens all the time.
- 21 HSGAC Minority And what happens when there's not
- 22 sufficient staff?
- 23 Witness It just becomes chaotic.
- 24 HSGAC Minority And you've been doing this for
- 25 approximately 17 years. How often do you face staffing



- 1 challenges when securing events? POTUS, FLOTUS, former
- 2 POTUS?
- 3 Witness Just about every time.
- 4 HSGAC Majority Was the Butler site, the farm show site,
- 5 the first choice for this event on the 13th?
- 6 Witness So my understanding is that they already
- 7 like paid the money in advance. So I think it was already
- 8 reserved coming in that first day. Like, I don't know if
- 9 they've looked at other venues.
- HSGAC Majority Who was they?
- 11 Witness So it's the staff that chooses the venue.
- 12 HSGAC Majority At what point in the timeframe, in the
- 13 week prior where you first notified that Butler would be
- 14 the site?
- Witness I don't think I was notified till
- 16 Lead Agent sent out an email, like a welcome email on
- 17 Sunday, and it showed the site in the address.
- 18 HSGAC Majority Was there ever any discussion of holding
- 19 the event at the airport?
- 20 Witness Not to my knowledge. Not with me, but I
- 21 think that would've been much better.
- HSGAC Majority With respect to your notes exhibit 1, if
- you could look at those, page 3 at the bottom on Tuesday,
- 7/9, there's a discussion about, and there's a redaction
- 25 here, "Blank Bodies is a good number." Do you recall what



- 1 Bates number the right number would've been for that?
- 2 It's Bates number 796 is the page number at the bottom.
- 3 **Witness** 20.
- 4 **HSGAC Majority** 20?
- 5 Witness Mm-hmm.
- 6 HSGAC Majority And it says you only had around blank
- 7 bodies. How many was that?
- 8 Witness So we, the last time, yeah, this was, I
- 9 had about -- I had **E** bodies the last time, and this
- 10 would've been in 2022 for very similar rally.
- 11 HSGAC Majority And what was the total number of bodies
- 12 that you ended up here?
- Witness At this site, 21.
- 14 HSGAC Majority On Bates, page 799, 4-mark down.
- 15 "Police posts are around the entire perimeter, every **E**
- 16 yards or so. Easy fence to jump." What were you trying to
- 17 convey in these notes here?
- 18 Witness I was just saying that we are not relying
- on this fence to be like a hard security for anything. We
- 20 still have to, you know, man the whole, the entire fence
- 21 line because anyone can jump over a wired fence.
- HSGAC Majority And then two dashes down. "I asked how
- 23 far out he intended to sweep. He didn't want to sweep the
- 24 entire site where all the hangers and warehouses are, but I
- 25 said, I'm very concerned about that area and I need a



- 1 sweep. He asked for, it will be posted. And I said, I
- 2 can't post every hanger, but we'll have posts there to
- 3 ensure people aren't trespassing and hiding out around the
- 4 property after these sweeps." Where does this relate in
- 5 the planning?
- 6 Witness So this is just a conversation with the
- 7 technical security division. TSD Advance Agent who was the
- 8 advance because he decides what, you know, how far out he's
- 9 going to sweep. And again, like, you know, if he were to
- tell me that he was going to sweep the AGR building, then
- 11 maybe I could have justified -- maybe we could have
- 12 justified, hey, he's sweeping that. Because a lot of
- 13 times, like the perimeter, right, that you keep talking
- 14 about the perimeter is kind of established by PSD, and how
- 15 far out did they think this LES need to be, just
- 16 based on their expertise of, you know, you know,
- 17 **LES** .
- 18 So he had said that he, you know, I asked him, how far
- out are you going to sweep? Because I was very concerned
- 20 about the hangers. I don't know that we knew who owned,
- 21 some of them were private hangers. We didn't know who
- 22 owned them. So I just wanted to make sure that he was
- 23 going to sweep every single building on, you know, the
- 24 south side to make sure that nobody was like, hiding out or
- 25 that, you know, we were going to miss something.



- 1 HSGAC Majority To your knowledge, was the AGR
- 2 building itself swept by Secret Service?
- Witness Like a bond sweep? To my knowledge, no.
- 4 HSGAC Majority And you testified earlier that to your
- 5 knowledge, Secret Service personnel did not examine the
- 6 inside of the A GR building in advance of the 13th. Is
- 7 that right?
- 8 Witness Inside the building, correct. To my
- 9 knowledge.
- 10 HSGAC Majority So picking up my colleague's questions
- 11 about --
- 12 Witness I mean, I don't know what CS did if they
- 13 went inside the building.
- 14 HSGAC Majority With respect to the questions about what
- went wrong that day, that contributed to the ability of the
- 16 assailant to fire shots of the former president, in your
- 17 view is the planning aspect, and again, as you said, you
- 18 have to take it in its totality that resulted in the AGR
- 19 building, being beyond the interior perimeter, it not being
- 20 examined from the inside and reliance on the locals for
- 21 that building. Is that combination something that you
- 22 believe contributed to the failures that day?
- 23 Witness I think larger than that is that the
- 24 concerns, you know, weren't relayed. So if there was a
- 25 crowd building over there, then if it was relayed, you



- 1 know, somebody could have addressed it. If there was a
- 2 suspicious person over there, if it was relayed, somebody
- 3 should have went and interviewed the suspicious person. If
- 4 there was somebody on the rooftop, if it was relayed,
- 5 there's a bearcat right there, an armored truck, it could
- 6 have been moved to be in the middle of the rooftop and the
- 7 president, you know, former president. There's a lot of
- 8 things that could have been done, but it has to be relayed.
- 9 It has to be communicated in order for those to be put in
- 10 place.
- So, you know, I think that assets were there, but were
- 12 they at the right place at the right time? I guess not
- 13 because, you know, for me, I didn't know anything was going
- on. I can't put out fires that I don't know exists. So I
- think that it's more of passing the information, like he
- 16 said, like very simply, like you, I don't know, what was
- 17 the phrase he used?
- 18 HSGAC Majority See something, say something,
- 19 Witness See something, say something. Exactly.
- 20 I think it was just comes down to just very simply, if you
- 21 see something that's fishy, you say something, you pass it
- 22 up, make sure everybody knows about it. Yeah,
- HSGAC Majority I am going to pass to my colleagues to
- 24 keep going. In the interest of time, unless you'd like to
- 25 take a quick break here.



- 1 Witness Sure.
- PSI Minority Witness my name is PSI Minority . I
- 3 work with Senator Ron Johnson, the ranking member of the
- 4 permit investigation. Thank you for your time.
- Witness Yes, of course.
- 6 PSI Minority I want to start off by going back to
- 7 something that you said and I just wanted to get a little
- 8 clarity on it. Are you on admin leave?
- 9 Witness I don't know what they're calling this.
- 10 I'm not sure what I'm on. I don't know. It's not really
- 11 clear to me what I'm on. I'm just told not to come to
- work, but I'm still working, but not come to work.
- PSI Minority Has this ever happened to you before?
- 14 Witness No, I have never been in --
- 15 PSI Minority Have you ever been put on admin leave?
- Witness No.
- PSI Minority So you, this situation that you're
- 18 currently in is unique?
- Witness Yes.
- PSI Minority Out of 17 years?
- Witness Yes.
- 22 **PSI Minority** You've never been in this situation
- 23 before?
- Witness Correct.
- 25 PSI Minority Are you aware of other Secret Service



- 1 agents or anyone else in your position or senior to your
- 2 position that is facing similar disciplinary actions?
- 3 Witness So I guess the whole Pittsburgh Field
- 4 office.
- PSI Minority Please don't talk over each other.
- 6 Okay. Thank you. Please repeat.
- 7 Witness The Pittsburgh Field Office, everybody
- 8 that was at involved on the advance team is now placed on
- 9 whatever this is called admin leave, I guess.
- 10 PSI Minority The, the entire Pittsburgh office that
- 11 was involved. So that includes Ms. Site Agent?
- 12 Witness No, she's part of the Donald Trump
- 13 detail. So she's not out of the Pittsburgh Field office.
- PSI Minority And is she to your knowledge facing any
- 15 type of disciplinary?
- 16 Witness Not to my knowledge.
- 17 PSI Minority Who senior to you is who was in the
- 18 Pittsburgh field office is facing similar disciplinary
- 19 action?
- Witness The SAC.
- PSI Minority And who is that?
- Witness SAIC Pittsburgh and then ATSAIC .
- 23 And then Special Agent Lead Agent
- PSI Minority Have you been in contact with any of
- 25 those people to discuss this disciplinary action?



- 1 Witness I mean, I've checked in on people, but
- 2 not specifically. I'm still kind of unsure of what -- like
- 3 I asked my SAC, "Am I allowed to go to training next week?"
- 4 I have a training and he hasn't gotten back to me. He
- 5 seems unsure.
- 6 **PSI Minority** Who's your SAC?
- 7 Witness SAIC Pittsburgh
- 8 **PSI Minority** Who was also on disciplinary?
- 9 Witness Yeah.
- 10 PSI Minority Okay. Were you made aware of this and
- 11 I'll just call it disciplinary action, without knowing
- 12 whatever the official term is. I don't know if there is
- one. Were you made aware of this disciplinary action
- 14 before or after you created these notes?
- Witness After.
- 16 PSI Minority After. Okay. Approximately when were
- 17 you made aware?
- 18 Witness I was just made aware like a few days
- 19 ago.
- 20 **PSI Minority** This week?
- 21 Witness I think it was, yeah, maybe last week.
- 22 **PSI Minority** Okay. And who made you aware?
- Witness SAIC Pittsburgh
- 24 PSI Minority And is that when he informed you that
- 25 everyone who was involved would also face similar?



- 1 Witness Mm-hmm.
- 2 PSI Minority And as far as, you know, what he
- 3 communicated to you is accurate that everyone involved is
- 4 facing this?
- 5 Witness As far as I know.
- 6 PSI Minority Okay. I want to go back to Exhibit 4.
- 7 That's the exhibit that's titled Preliminary Survey. But
- 8 before we turn to that document, I just want to again, just
- 9 make sure that I understand regarding your awareness of
- 10 threats prior to the event. I think you had testified that
- 11 I think it was Lead Agent communicated to you that there were
- 12 threats and that is why the counters sniper team was added?
- 13 Witness No, I did not know about any threats
- 14 until I seen it on TV. And then I later had asked, you
- know, did anyone know about threats, because I was like,
- 16 why, why didn't I know about threats? Who else knew about
- 17 threats? And I believe Special Agent Lead Agent said that she
- 18 knew there was of a threat and that's why they were
- 19 providing counter snipers.
- But she didn't know specifics about the details of the
- 21 threat. And I do not believe that anyone from the
- 22 Pittsburgh Field office to include my staff was briefed
- about any type of threat.
- PSI Minority And just so I understand, so Lead Agent
- 25 told you after the event that she had found out after the



- 1 event?
- 2 Witness No, I think she -- I don't know when she
- 3 found out, but she told me after the event because I was
- 4 like, you know, concerned, like, why am I hearing about
- 5 threats on TV? And I don't know about it. So you know,
- 6 she had said to me that that's why CS was brought out.
- 7 That's why DTD requested CS. So that's the first time I
- 8 found out, I just assumed it was because of the rally and
- 9 the type of event, and I didn't know that whether we were
- 10 getting local CS. So that's why I, the whole time, that's
- 11 what I thought that we were getting CS for, but apparently
- 12 it was because of this threat.
- PSI Minority And were you aware of Secret Service
- 14 deploying counter their own counter snipers to former
- 15 President Trump's events prior to this event?
- 16 Witness I know that they did not have counter
- 17 snipers in 2022 when I did the last event with president or
- 18 with former President Trump.
- 19 PSI Minority So now going to Exhibit 4, the
- 20 preliminary survey. I want to go to page 10. It's the
- 21 last page. And the box that is labeled intelligence, and
- just let me know if you see that.
- Witness Mm-hmm.
- PSI Minority And it says SA redacted. And again,
- 25 these redactions are, were applied to this document. We



- 1 did not apply them. Is the intelligence advance for
- 2 this event, "At this time, no adverse intelligence has been
- 3 developed concerning this visit. Any adverse intelligence
- 4 that may arise will be passed on to all working
- 5 supervisors." When did you first see this preliminary
- 6 survey?
- 7 Witness I don't know what day it was sent out.
- 8 It was emailed.
- 9 **PSI Minority** But you saw it prior to the event?
- 10 Witness I don't know that I read through the
- 11 preliminary survey prior to the event. I don't know that I
- 12 read through it, but I know that it's part of the approved
- 13 documents that get somehow.
- 14 PSI Minority Is it typical for you to -- or I guess
- is it expected of you to read through these types of
- 16 documents?
- 17 Witness Yeah, probably. I mean, I was the only
- 18 concerned about my site, so I knew everything I think I
- 19 should know about my site. So this is, you know, more of
- 20 an overall visit document, I think.
- PSI Minority For this intelligence section if there
- 22 was adverse intelligence that was known at the time that
- this document was finalized, would it be your expectation
- that that intelligence would be added or incorporated in
- 25 this section of this type of document?



- 1 Witness If it's found out after this was
- 2 produced?
- 3 **PSI Minority** No, in real time?
- 4 Witness In real time, yeah. It should be okay.
- 5 Unless it's some sort of like, security, I don't know, like
- 6 top secret thing or something that was briefed by like, you
- 7 know, you know, a skiff or something. And if they didn't
- 8 want to put it on paperwork, but I would think that, yeah,
- 9 it would be in there if it was not significant.
- 10 PSI Minority I want to go now to, in the same
- 11 document, Exhibit 4, page 5. We've spent a lot of time
- 12 talking about where snipers, counter snipers were going to
- 13 be posted on the day of the event. And in this document it
- 14 appears to explain certain locations of Secret Service
- 15 counter snipers, as well as local counter snipers. And I
- 16 want to turn your attention to I guess it's towards the
- 17 bottom of the page, there's a category that says CS and it
- 18 says, "Two two man Hercules elevated 4 o'clock and 8
- 19 o'clock." Do you see that box?
- 20 Witness I see two, two man local CS, you're
- 21 saying Hercules.
- 22 PSI Minority On page 5 at the top of the page, does
- 23 it say site two of two?
- Witness Yeah,
- 25 PSI Majority Scott, I believe it's under the CS box.



- 1 PSI Minority Yes. On the --
- Witness Oh, okay. Yeah. Okay. Yeah. Sorry to
- 3 interrupt.
- 4 PSI Minority And to your understanding is that, was
- 5 that the position of Secret Service snipers on the day of
- 6 the event?
- 7 Witness Yes.
- 8 **PSI Minority** I want to go now on the right hand side
- 9 of the document, even further down where it says other
- 10 assets. The second row in that box says, "Two, two man
- 11 local CS team elevated 4 o'clock and 8 o'clock barn roof."
- 12 Witness Yes. So that would've been a typo
- 13 because that was where this USSCS team was.
- PSI Minority So who would've made this typo?
- 15 Witness So site agent Site Agent fills out this
- 16 particular page, and then it goes to the lead to make
- 17 corrections, but then the lead sends it on to somebody else
- 18 to review. So it goes through layers, multiple layers of
- 19 review.
- 20 **PSI Minority** I think it would be helpful if you can
- 21 to walk us through those layers.
- 22 Witness Yeah. So this preliminary survey is
- 23 made up of like site surveys? So there site survey one
- 24 would be the airport site survey, two would be the Butler
- 25 Farm show site. So site two of two would be, the person



- 1 that would fill this out would be Site Agent . And
- then she would submit it to Lead Agent, who would then fill
- 3 out the rest of the document and then submit it on to ops,
- 4 DTD ops or Scene ops? I think it goes to both.
- 5 PSI Minority And are there specific individuals in
- 6 those positions that would've approved this?
- Witness Yeah, it would get approved through,
- 8 yeah. I don't know who those people are in those positions
- 9 that, that review the paperwork.
- 10 PSI Minority So as in terms of your chain of command,
- it, your awareness ends at Lead Agent, is that correct?
- 12 Witness Correct.
- PSI Minority Do you know when you learned that Secret
- 14 Service would be sending counter snipers to the event?
- 15 Witness So it would've been Tuesday night. I
- 16 learned that and the Secret Service sent out an advance
- 17 agent on Wednesday.
- 18 PSI Minority I want to turn now to the next exhibit
- 19 that I'll enter as Exhibit 10. And we're going to hand
- 20 this to you shortly.
- 21 [Exhibit No. 10 was marked
- for identification.]
- PSI Minority This document has images of two
- 24 different sites. One appears to be the airport the other
- 25 appears to be the farm show site. And then there's a



- 1 diagram of what appears to be the setup around the stage
- 2 at the event. Are you familiar with this document?
- Witness Yeah.
- 4 PSI Minority When did you first see this document?
- Witness Well, I produced the diagram of the
- 6 airport.
- 7 PSI Minority Oh, okay. And when did you create this
- 8 diagram?
- 9 Witness I believe I would have to look back at my
- 10 emails, but I believe I sent it out to Lead Agent maybe
- 11 Wednesday night?
- PSI Minority Wednesday?
- 13 Witness It might be in my timeline. I think it's
- 14 probably in --
- PSI Minority Wednesday, the 10th of July.
- 16 Witness Yeah, it's probably in my timeline.
- 17 PSI Minority Yeah, it would've been Wednesday the
- 18 10th.
- 19 Witness Yeah. On Wednesday I sent it to Special
- 20 Agent Lead Agent .
- 21 PSI Minority And you mentioned that you were, you
- 22 created the diagram of the airport, is that correct?
- Witness Correct.
- PSI Minority Who created the diagram of on page 2 of
- 25 3 of the Farm Show.



1	Witness	Site Agen

- 2 PSI Minority Do you know when Ms. Site Agent created this
- 3 diagram?
- 4 Witness I don't know specifically. I think there
- 5 was -- she sent it via email at some point, and then she
- 6 sends it to Ops to get approved. I don't know when it was
- 7 due, but I would say it was probably Thursday. But a
- 8 guess.
- 9 PSI Minority And for your diagram, your section, how
- 10 around what time or a point in time, a date if you can
- 11 recall, did you begin working on that diagram?
- Witness Well I did a walkthrough of the airport
- 13 Tuesday morning, and then I had like a rough draft of where
- 14 the planes were going to be. Both former President Trump's
- 15 plane as well as the first lady's plane. So I was using
- 16 that diagram that was sent to me by airport operations to
- 17 coordinate assets for the airport. And then the next day
- on Wednesday, I worked on this at the field office for the
- 19 duration of the evening.
- 20 **PSI Minority** Do you know when Ms. Site Agent began her
- 21 work on her diagram?
- Witness I do not, no.
- 23 PSI Minority Could you explain why you sort of took
- the lead on one diagram and she took the lead on the other?
- 25 Witness So we did not have a site agent for the



- 1 airport. When the assignments came out on Saturday
- 2 before the initial walkthroughs from SAIC Pittsburgh, it said
- 3 INV for airport, meaning like an IMV body. So to me that
- 4 means, you know, some, somebody, they're going to request
- 5 somebody from like the investigation. So somebody from
- 6 another field office would potentially be coming to be the
- 7 site agent. In the email it said that I was to take care of
- 8 the, the airport.
- 9 I guess at the police meeting I was, when we broke up
- into groups, I was to take care of the airport section of
- 11 it. So I just, from that point on, I just kind of figured
- 12 that we weren't going to get another body just because of
- 13 me being around long enough to know that we're short
- 14 manpower and we're short resources. And so I just went
- 15 ahead and continued to do the planning for the airport to
- 16 help out Special Agent because they knew that there
- 17 wasn't an advanced agent.
- 18 **PSI Minority** And did you coordinate with Ms. Site Agent at
- 19 all that you would do that and she would do the diagram of
- 20 the farm?
- 21 Witness So Ms. Site Agent was only responsible for the
- 22 Butler Farm Show. So I did not coordinate anything. I
- 23 mean, I let her know that I was going to be taken care of
- 24 the airport as well, but I didn't coordinate any of that,
- 25 the airport stuff with her at all.



- 1 PSI Minority And for these documents, could you
- 2 explain to us what level of approval these plans have to go
- 3 through?
- 4 Witness So it's the same approval. I send this
- 5 to the lead and the lead sends it on to DTD ops and CNS
- 6 ops.
- 7 PSI Minority So you sent it to Lead Agent. Did you
- 8 send it to Ms. Site Agent first and then send it to Lead Agent?
- 9 Witness Not my airport. I just sent that
- 10 directly to Lead Agent.
- 11 PSI Minority Did Ms. Site Agent share with you her plan
- 12 prior to the finalization of this document?
- 13 Witness Yeah, I think when she finished her
- 14 diagram, she sent it to me.
- 15 PSI Minority Okay. and then she also went through
- 16 the same level --
- 17 Witness And sent it to Lead Agent as well.
- 18 **PSI Minority** Okay. I want to turn your attention on
- 19 page 2 of 3. Under assets it says again, "Two, two man
- local CS team elevated 4 o'clock and 8 o'clock barn roof."
- 21 Is that accurate?
- 22 Witness That would not be accurate.
- 23 PSI Minority So this is another mistake?
- Witness Yeah.
- 25 PSI Minority And this document was done by Ms. Site Agent



- 1 Witness Correct.
- 2 PSI Minority And approved by Lead Agent?
- Witness Correct.
- 4 PSI Minority And anyone else up the chain that you
- 5 can't recall the names?
- 6 Witness Yeah, and seen U.S. Ops and TTD ops.
- 7 PSI Minority Was this document finalized before or
- 8 after the preliminary survey?
- 9 Witness I think it's all like, at the same time,
- 10 the paperwork it probably would've all been approved at
- 11 once. It all comes back, it's like approved documents and
- 12 it's like one big PDF of everything.
- PSI Minority And so these documents, so I understand
- 14 these documents are shared at, at the same time with --
- 15 Witness Yeah, like once, once they get the final
- 16 approval gets sent out and then it gets forwarded on to
- 17 everybody on the advance.
- PSI Minority Do you know if anyone pointed out these
- 19 typos?
- 20 Witness I don't. Not to my knowledge.
- 21 PSI Minority Do you know whether the local CS teams
- 22 were originally assigned to this position and then changed
- once Secret Service counter snipers were going to --
- 24 Witness I wasn't part of any of it was Site Agent
- 25 Site Agent that made contact with that was in contact with



- 1 Butler ESU. I never was in contact with Butler ESU for
- 2 the entire duration of the visit. So it would be better
- 3 answered by her of whether they, what they were telling her
- 4 in terms of what, what they could provide.
- 5 PSI Minority Ms. Site Agent ?
- 6 Witness Ms. Site Agent.
- 7 PSI Minority Okay. I am going to turn to the next
- 8 exhibit which will be marked as Exhibit 11. And we'll give
- 9 you a copy shortly. This document is titled Site Post
- 10 Instructions. It has Bates number 219 through 225.
- 11 [Exhibit No. 11 was marked
- for identification.]
- PSI Minority Witness are you familiar with this
- 14 document?
- Witness Yes.
- 16 **PSI Minority** I know that in the notes that you handed
- 17 us earlier in Exhibit 1 that on the document that is marked
- 18 page 8 in Exhibit 1 towards the top of that page you wrote
- 19 "Very late night, very late that night, I found his CS
- 20 email so that I could copy and paste into my site post
- 21 instructions under CS so that all the post standards were
- 22 aware of where the CS teams would be. That's when I read
- that it said inside the AGR building." Is that a reference
- 24 to this document Exhibit 10? The site post instructions?
- Witness Yes.



- 1 PSI Minority When did you receive the site post
- 2 instructions?
- Witness I had created the site post instructions.
- 4 PSI Minority You created this?
- 5 Witness Mm-hmm.
- 6 **PSI Minority** And when was this document finalized?
- 7 Witness I don't know that it goes through a
- 8 review process like the other documents. It's just kind of
- 9 what gets briefed to the post standards when they arrive.
- 10 I'm not sure that it gets scrutinized like the other
- 11 paperwork. I send it to the lead and the site agent
- 12 though, to scrutinize.
- 13 **PSI Minority** So when you send it to the lead and the
- 14 site agent, do they approve or?
- 15 Witness Yeah, they can absolutely make changes.
- 16 Tell, you know, say make suggestions. You know, they're
- the ones in charge of the overall plan so.
- PSI Minority And when did you send this document to
- 19 those individuals?
- 20 Witness So it would've been, I guess Thursday
- 21 into Friday morning, like Thursday at like, maybe like
- 22 after midnight, whatever. I wrote almost one in the
- 23 morning, maybe.
- 24 PSI Minority So approximately Friday, July 12th at
- 25 1:00 in the morning is when you sent this document?



- 1 Witness Mm-hmm.
- 2 PSI Minority By that point had you received the
- 3 preliminary survey?
- 4 Witness I don't believe so. I don't recall when
- 5 exactly I received the preliminary survey.
- 6 PSI Minority And had you received the final copy of
- 7 the diagrams that we had discussed earlier?
- 8 Witness I don't believe I got the approved
- 9 paperwork but I would have to look back at emails, but I
- 10 don't believe I got that yet.
- 11 PSI Minority Had you at this point when you sent the
- 12 Site Post instructions up your chain of command, had you
- 13 seen earlier drafts of the preliminary survey or the --
- 14 Witness No, it's all done in like an advanced
- 15 doc. So no, I didn't go. I guess I could have gone in
- there and looked at it if I wanted to, but I didn't go do
- 17 that.
- 18 PSI Minority So in the site post instructions, I want
- 19 to turn to the page marked Bates number 224 under the
- 20 section that's labeled Counter Sniper. Do you see that
- 21 section in there?
- Witness Mm-hmm.
- PSI Minority What information did you rely on for
- 24 this section of the site post instructions?
- 25 Witness So technician, C/S Team Lead sent an email



- 1 with his diagrams that he does for his portion of CS,
- 2 and then in the synopsis of the email he wrote where these
- 3 teams were going to be. And so I just copied and pasted
- 4 directly onto this document.
- 5 PSI Minority And was this the first time that you saw
- 6 in writing the position of the Butler County ESU sniper
- 7 teams?
- 8 Witness I believe so.
- 9 PSI Minority And that position is, and I'm quoting
- 10 the document, "Inside AGR building at three o'clock off
- 11 dais." Is that correct?
- 12 Witness Correct.
- 13 **PSI Minority** Is that the position that the Butler
- 14 County ESU sniper teams were in on the day of the rally?
- 15 Witness To my knowledge, yes.
- 16 PSI Minority So we've discussed what you indicated in
- 17 the site post instructions as their position being inside a
- 18 GR building, and then we also discussed two other documents
- 19 that had incorrect positions for the local sniper teams.
- 20 Did you see any documents that stated that this local
- 21 sniper teams would be on the roof of the AGR building?
- Witness Yeah.
- 23 PSI Minority So you knew, now looking back, you knew
- 24 that the incorrect positions of the local sniper teams?
- 25 Witness I didn't, no, I never looked over the



- 1 paperwork that you showed me with the incorrect stuff.
- 2 PSI Minority But now you --
- Witness But now you're telling me. Yeah, now I'm
- 4 seeing it.
- 5 PSI Minority But so at the time that you created the
- 6 site post instructions, you learned that they would be
- 7 inside the AGR building?
- Witness Correct.
- 9 PSI Minority So can you help us understand why or if
- 10 you believed that the roof of the AGR building would be
- 11 covered?
- 12 Witness Because they told me that it was covered
- 13 with the team, and I mean --
- 14 PSI Minority That the roof was covered?
- Witness Well, they said that that area was
- 16 covered. I mean, if you're a counter sniper, what area
- 17 would you be talking about aside from the roof of a
- 18 building? They just said there was a team there, so
- 19 automatically I'm taking the roof is covered if you're
- 20 talking about a counter sniper team. But, so yeah, I mean,
- 21 I didn't -- I see that it's inside the building. Again,
- 22 yeah, I didn't question. I still thought -- I didn't
- think, oh, now the roof's not covered or anything like
- 24 that.
- I just thought there must be a reason that they're



- 1 inside as opposed to on the roof. And I just thought
- 2 maybe, you know, maybe it was due to, you know, if the
- 3 U.S.S. team had to take a shot or something, they were
- 4 maybe afraid that they'd be in the line of sight or
- 5 something like that, or in there. So I didn't know how
- 6 that -- I didn't know how the area of responsibility was
- 7 divided, but I most certainly did not think that that roof
- 8 would not be covered with two sniper teams with the roofing
- 9 in between two sniper teams.
- 10 PSI Minority Did you, when you were finalizing the
- 11 site post instructions was it your understanding that the
- 12 roof of the AGR building would be covered?
- Witness Yes.
- PSI Minority And so --
- Witness When you say covered, yes, but at that
- 16 time, I know that now they're not on top of the roof, so I
- 17 still thought it was going to be covered, but now I'm
- 18 knowing, now I know that they're not on top of the roof.
- 19 And that's again, a decision that I just relied on their
- 20 expertise and their training.
- 21 PSI Minority And when you saw -- and just to clarify,
- they, your reference today, who was that?
- Witness The counters sniper teams,
- 24 PSI Minority The local --
- Witness The, well, the U.S.S Counter Sniper team,



- 1 and they're playing with the locals.
- 2 PSI Minority Okay. Did you have any concern when you
- 3 saw that of the location of the Butler County sniper teams
- 4 was inside the AGR building?
- Witness I didn't really have concern until after,
- 6 in hindsight, after I kind of seen or, you know, saw what
- 7 may have happened. But you know, I thought it was a bit
- 8 odd but I thought there would be a good reason for it. I
- 9 didn't really, you know, again, I was dealing with other
- 10 things, so I just, I didn't question it at all.
- 11 PSI Minority I want to turn your attention to a
- 12 couple lines above. The note where the Butler County ESU
- 13 Sniper team is. It says, It's still in that section under
- 14 counters Sniper, it says, "U.S.S blank one," and this is a
- redaction. "Elevated on roof of barn 14 at 4:14, at 8
- 16 o'clock off days." There may be a redaction in there that
- 17 appears to indicate that those locations are on the roof of
- 18 the barn. To your understanding, were those the locations
- 19 of those teams?
- Witness Yes.
- 21 PSI Minority The Secret Service counter sniper teams?
- Witness Yes.
- 23 PSI Minority And here it indicates that they were on
- the roof of the barn but below it says that the Butler
- 25 County Sniper teams are inside the AGR building.



- 1 Witness Correct.
- 2 **PSI Minority** So as it was your assumption that the
- 3 roof would still be covered?
- 4 Witness Correct.
- 5 PSI Minority On July 13th, what was your awareness of
- 6 the assets that had a line of sight on the roof of the AGR
- 7 building, whether it be Secret Service or local law
- 8 enforcement counter snipers?
- 9 Witness What did I -- I'm sorry?
- 10 PSI Minority I'll repeat the question. On July 13th
- 11 what was your awareness of the local and Secret Service
- 12 counters sniper assets that would have a line of sight of
- the roof of the AGR building?
- 14 Witness So my understanding would be that the
- 15 teams on the roof would be able to see that AGR building
- 16 mainly the closer team to the roof.
- PSI Minority And just to be clear, you're referring
- 18 to the Secret Service --
- 19 Witness The Secret Service.
- 20 **PSI Minority** -- on the roof of the barn?
- 21 Witness Correct. And my understanding as well
- 22 would be that the locals would have line of sight as well.
- 23 I would've thought that both of them would have line of
- 24 sight to that roof. But again, this is just what, this is
- just what I didn't go into the inside the A GR building to



- 1 specifically, you know, or to specifically know which
- 2 window or anything like that.
- 3 PSI Minority What about the barn? Did you --
- 4 Witness I didn't go up on top of the barn.
- 5 PSI Minority From the ground, did you note at any
- 6 point in time prior to the rally that from that location
- 7 there, there should be line of sight to the roof of the AGR
- 8 building?
- 9 Witness You mean from like a sniper standpoint?
- 10 **PSI Minority** Or just from your position on the
- 11 ground? Did you note to yourself whether someone in an
- 12 elevated position would be able to have line of sight to
- 13 the AGR building?
- 14 Witness Yeah, I mean, it would be hard to say
- 15 without going onto the roof, because I knew that there, you
- 16 know, I don't know if I thought about it at the time, but I
- 17 know that there's trees there. So yeah, I think without
- 18 going -- I think you would need to go to the position to
- 19 see whether you have that line of sight.
- PSI Minority Besides the documents that we've
- 21 discussed -- so I'll be specific. The site post
- instructions, the preliminary survey and the diagrams, are
- there any other documents that described or noted the
- 24 positions of counter snipers, whether it be local or
- 25 whether Secret Service counter snipers that --



- 1 Witness The counters sniper documents.
- 2 PSI Minority I'll just finish the question.
- Witness Sorry.
- 4 PSI Minority Just for the record that describe the
- 5 positions of those individuals?
- Witness Yeah, just the counter sniper documents.
- 7 **PSI Minority** Any other documents?
- 8 Witness Not to my knowledge.
- 9 PSI Minority Did you speak with the Secret Service
- 10 counters snipers following the rally?
- 11 Witness Just the email that I sent to the advance
- 12 agent asking what time the locals were posted.
- PSI Minority And when was that email sent?
- 14 Witness It was a couple days after this.
- 15 Headquarters was asking specific questions, and I didn't
- 16 know the answers to.
- PSI Minority Besides the email, did you have any
- 18 other communication with them?
- 19 Witness I did not.
- 20 PSI Minority You mentioned before the names of law
- 21 enforcement officials, PSP Lieutenant, Officering and PSP Lieutenant Are those
- 22 individuals affiliated with state police?
- Witness Pennsylvania State Police.
- PSI Minority Okay. Thank you. We previously
- 25 discussed local law enforcement whether or not there were



- 1 requests made by local law enforcement for or counters
- 2 snipers. I want to generalize it and ask were there any
- 3 requests made by local law enforcement for any more
- 4 manpower?
- 5 Witness Made to local law?
- 6 PSI Minority Or made by local law enforcement to
- 7 Secret Service for any additional manpower?
- 8 Witness Repeat the question.
- 9 PSI Minority Sure. What are you aware of any
- 10 requests made by local law enforcement to Secret Service
- 11 for more manpower for the event?
- 12 Witness Okay. The local law enforcement
- 13 requesting from Secret Service?
- PSI Minority Mm-hmm.
- Witness No, I'm not aware of that.
- 16 PSI Minority I want to turn back to Exhibit 5.
- 17 That's the manpower request document.
- Witness Okay.
- 19 PSI Minority I believe this is entered into the
- 20 record for candidate Donald Trump as the protectee?
- 21 Witness That was 5?
- PSI Minority 5.
- Witness Okay.
- 24 PSI Minority At the bottom of this document under the
- 25 category police CS assets available, do you see that



- 1 category?
- Witness Mm-hmm.
- 3 **PSI Minority** The first line says, "Two, two man local
- 4 CS teams at airport shared by DTD and FLD visit." Could you
- 5 tell us what DTD and FLD stand for?
- 6 Witness Donald Trump Detail and First Lady
- 7 detail.
- 8 PSI Minority Are you aware whether local counter
- 9 sniper teams were shared by DTD and FLD?
- 10 Witness Yes. They went from -- so there was like
- 11 an hour difference in the timing. So they went from one
- 12 area of, you know, the one location to another? I'm trying
- 13 to think who was first. Yeah, there was like, I think, I
- 14 can't recall now. I'd have to look at the timing, but one,
- one of the protectees came first. So they were using those
- 16 assets for the first protectee, and then they were going to
- 17 move on to the next protectee, because there was an hour
- 18 timeframe. And then same thing on the opposite end, the
- 19 first lady left prior to -- well, would've been left prior
- 20 to the President Trump leaving.
- 21 PSI Minority And is this a reference to shared assets
- 22 at the airport?
- Witness Yes.
- 24 PSI Minority Is it typical that protectees for two
- 25 separate events would've had to share assets?



- 1 Witness No. I don't know that we've ever had
- 2 somebody flying at the same airport on the same day.
- 3 PSI Minority Has former President Trump ever shared
- 4 assets with any other protectee besides July 13th?
- 5 Witness I mean, I guess -- I don't know. Not to
- 6 my knowledge, but I guess if you have two protectees in the
- 7 same site at the same time, they'd be sharing assets.
- 8 **PSI Minority** And just so I understand, would that be
- 9 in that scenario, it would be a POTUS and VPOTUS?
- 10 Witness Right, right. And I guess, you know,
- 11 scenario is just --
- PSI Minority But that would generally be for the same
- 13 event, correct?
- 14 Witness Correct. And again, it at the same site
- in it is the same location. We're using the same entities.
- 16 We'd be using the same entities. So it's not like they're
- 17 you know, they're trying to cover the same thing at the
- 18 same time.
- 19 PSI Minority Would sharing assets for two protectees
- 20 going to two different locations, could that put a strain
- 21 on resources,
- 22 Witness I guess if timing doesn't work out, sure.
- 23 I mean.
- 24 PSI Minority Were you concerned about there being a
- 25 resource issue with the assets prior?



- 1 Witness I was not concerned.
- 2 **PSI Minority** Why not?
- 3 Witness Because this was provided by Allegheny
- 4 County PD. They're very good. They're very good. They,
- 5 kind of like Pittsburgh PD, they work with us all the time.
- 6 They're very familiar with how we operate. I think it
- 7 would've just been a quick phone call, "Hey, this is the
- 8 situation, you know, we need, you know, to provide more
- 9 bodies or, you know." I think it would've been an easy and
- 10 quick adjustment if needed.
- 11 PSI Minority So I want to go to Exhibit 1, your
- 12 notes. And I want to go to page -- or I guess I'll say
- 13 Bates number 794 at the bottom of that page. And we've
- 14 discussed this before but I'll read it again. I believe
- 15 you mentioned that this is at the last entry, or I guess
- 16 second to last entry on that page, "Lead Agent" started the
- 17 discussion early." Is that?
- 18 Witness So that would've been, yes, definitely.
- 19 PSI Minority "Lead Agent started the discussion early
- 20 with staff to remember that we will need to deal with LOS
- 21 concerns wherever they decide to build the stage." And you
- 22 had mentioned before LOS is line of sight concerns. So in
- 23 what way were the line of sight concerns dealt with, if at
- 24 all?
- Witness Yeah, so it was talked about all week.



- 1 You know, there was vendors that were calling into the
- 2 Butler County Farm Show saying, "Hey, we'll donate farm
- 3 equipment. We have banners, we have this, we have that."
- 4 PSP Lieutenant, Officer in Charge had pictures from 2020 site at the airport that
- 5 I guess former President Trump attended the last time he
- 6 was in that area.
- 7 And he showed the staff lead these pictures and said,
- 8 "You know, we can get, this equipment just let us know."
- 9 Again, I had said, you know, we can put porta potties, you
- 10 know, the vendors over there along the fence line. And
- 11 everything that he said was, "No, no, no, you know, I have
- 12 a press shot. I want to get my press shot." He said,
- there will be bleachers to the left and right of the stage.
- 14 There'll be bleachers behind the stage. There'll be you
- 15 know, this combined -- there'll be things that are holding
- 16 up the speakers, some kind of cranes.
- 17 So he just basically said like he has things that he
- 18 will be putting there in place.
- 19 PSI Minority To deal with line of sight to deal with
- 20 line of sight. Okay. So that you noted was on Monday,
- July 7th, or excuse, excuse me, Monday, July 8th. As we
- 22 continue through your notes going to Bates number 799.
- Witness Which one?
- PSI Minority 799. And this would be on Wednesday,
- July 10th, you noted, "Again, LOS concerns everywhere. And



- 1 then blank said he was bringing farm equipment and he
- 2 turned down all the equipment that outside businesses
- 3 wanted to lend for that day.
- 4 Witness That would probably have been, I believe
- 5 that would've been Campaign Staff Lead. Yeah.
- 6 **PSI Minority** So by the 10th there were still line of
- 7 sight, line of sight concerns?
- Witness Yeah, I mean, there was line of sight.
- 9 Well, because he just kept saying what he was bringing, but
- 10 no one saw what he was bringing. Right. So he was just
- 11 kept saying, no, you know, he was going to bring this,
- 12 that, and the other, and we just kept trying to make
- 13 suggestions. We have this, we can get this, we can do that.
- 14 And he just kind of just kept saying no.
- And then Friday morning, finally Lead Agent had reached
- out and said, "Hey, Gampaign Staff Lead trying to put these trucks. He
- 17 has four trucks that you can use for line of sight." I
- 18 thought, "Oh, thank goodness. You know, I ran up to the
- 19 site and again, I said, Hey, there were these long Penske
- 20 trucks, and again, I tried to put them in those positions
- 21 that I wanted to block, you know, those AGR buildings. And
- 22 again, he said, "No, you know, it's in my press shot. And
- 23 you can move them further up then, you know, maybe the two
- o'clock," but he didn't want them on the shot.
- 25 PSI Minority On page Bates number 800. This is



- describing a 10:00 a.m. walkthrough on Thursday, July
- 2 11th. According to your notes you wrote, "Butler Township
- 3 would be on the outermost perimeter roving, " and I can't
- 4 tell if there is a redaction after roving. Is there more
- 5 to that sentence?
- Witness I do not know.
- 7 PSI Minority If Butler Township would be on the
- 8 outermost perimeter roving, does that mean that they
- 9 would've been in the vicinity of the AGR building?
- 10 Witness So yeah, they would've been right outside
- 11 it on Whitestown Road would've been -- yeah. One of their
- 12 areas of responsibility.
- PSI Minority So from your perspective, that would've
- 14 provided coverage for that area?
- 15 Witness From my perspective, yes.
- 16 PSI Minority Okay. And from your awareness, had
- 17 Butler Township seen anything as they were on the
- 18 patrolling the outermost perimeter, how would they have
- 19 communicated that to Secret Service?
- Witness To Secret Service, yes. So we have we
- 21 had Butler EMS in the security room, and they also have
- 22 communications with, with the police. So they could have
- communicated it through the security room, or they would've
- 24 communicated it through PSP, who was in our security room.
- 25 PSI Minority So it would've been a communication that



- was indirect?
- Witness Correct.
- 3 **PSI Minority** To Secret Service?
- 4 Witness Correct.
- 5 PSI Minority Has DHS or Secret Service instructed you
- 6 not to speak with Congress?
- 7 Witness No.
- 8 PSI Minority I'm going to turn it over to my
- 9 colleague, PSI Minority
- 10 PSI Minority I know you said you went to the
- 11 security room, or you were in the security room at the time
- 12 the shots fired. What time did you go to the security
- 13 room?
- 14 Witness I don't know exactly what time I went to
- 15 the security room. It was sometime after the arrival of
- 16 him coming on to site.
- 17 PSI Minority You were in the security room for the
- 18 entire time from the time he arrived until the time shots
- 19 were fired?
- 20 Witness At some point in between, I was probably
- 21 in the security room maybe 15 minutes before the shots
- 22 fired.
- 23 PSI Minority Okay. At any point that you were in
- 24 the security room, do you recall PSP alerting individuals
- in the security room that an individual had been spotted



- 1 either on the roof or an individual had been spotted
- 2 with a rangefinder and was headed in the direction of
- 3 sheets?
- 4 Witness I never heard that. But I wasn't --
- 5 like, no one said that to me. I didn't hear that
- 6 conversation going on. So, but I can't say whether it was
- 7 had or not had.
- 8 PSI Minority Are you aware that Secret Service
- 9 cameras --
- 10 Witness I didn't hear anything through the radio,
- 11 you know.
- 12 PSI Minority Nothing communicated over the radio?
- 13 Witness I didn't hear anything communicated.
- PSI Minority Are you aware that at 5:45 on the day
- of the rally, Secret Service counter snipers received a
- 16 text message with images of Crooks and a description of
- 17 Crooks using a rangefinder at the AGR building?
- 18 Witness I'm only aware of what I'm hearing
- 19 through media.
- 20 **PSI Minority** At the day of the rally, not aware?
- 21 Witness No, not aware at all.
- 22 **PSI Minority** Are you aware the day of the rally at
- 5:53 Secret Service counter snipers, sent to each other a
- 24 be on the lookout forwarding those same pictures and the
- 25 description of Crooks at the AGR building?



- 1 Witness I'm not aware.
- 2 PSI Minority Okay. I'm going to turn it over to my
- 3 colleague with Senator Paul's office.
- 4 HSGAC Minority We just have some quick hitters. Do you
- 5 recall what the ATF agent that you spoke to at the event
- 6 was wearing? And if you can't, that's okay.
- 7 Witness I don't recall.
- 8 HSGAC Minority Do you know who shot Crooks?
- 9 Witness I know -- I mean, no one told me --
- 10 **HSGAC Minority** You know the name?
- 11 Witness No, I do not know the agent name.
- 12 **HSGAC Minority** Do you know if he was on Hercules one or
- 13 Hercules two?
- Witness I was told, and I don't know, again, I
- don't know who it's all coming from, and you know,
- 16 conversations. My understanding is that it was the barn
- 17 that was further away.
- 18 **HSGAC Minority** Did, do you know if the counter snipper
- 19 that shot, did he stay at the barn or did he leave?
- Witness He left.
- 21 HSGAC Minority When?
- 22 Witness To go to the airport.
- HSGAC Minority Did he take his weapon with him?
- Witness My understanding, yes.
- 25 **HSGAC Minority** Is that typical in terms of evidence



- 1 collection?
- 2 Witness I guess I don't know what the --
- 3 HSGAC Minority Okay. When did FBI arrive on the scene?
- Witness Maybe four, five minutes later, maybe.
- 5 HSGAC Minority When you were securing the scene, did
- 6 you release any witnesses?
- 7 Witness I don't know if we -- there was like
- 8 probably over 40 witnesses, so we tried to contain them and
- 9 keep them there. Not to my knowledge. I didn't release
- 10 any witnesses.
- 11 HSGAC Minority And when headquarters was asking you
- 12 questions, how were they communicating those questions to
- 13 you? Was it by email?
- 14 Witness They were asking my SAC and my SAC was
- 15 asking me.
- 16 **HSGAC Minority** Do you know if it was by email or phone?
- 17 Witness I think they were talking.
- 18 **HSGAC Minority** They were talking. Can we go to your
- 19 typed notes? The last page, page 10. The second bullet
- 20 says you waited for volunteers, were gone. "Then I waited
- 21 for their security contractors to arrive. One male and one
- 22 female." This was the night before. Whose security
- 23 contractors?
- Witness The campaign staff hired private security
- 25 to secure the site.



- 1 HSGAC Minority Okay. So they also had security
- 2 contractors?
- Witness Yeah. So they had from 8 o'clock p.m. to
- 4 8 o'clock a.m. they had their own security to secure the
- 5 site, I believe Thursday and Friday.
- 6 HSGAC Minority And were you on ITAC?
- 7 Witness I was not on ITAC.
- 8 HSGAC Minority Has your private counsel reached out to
- 9 Secret Service about your whatever the disciplinary?
- Witness No.
- 11 **HSGAC Minority** Okay.
- 12 **PSI Minority** One last question from me. Are you
- aware that at approximately 5:51 on the day of the rally,
- 14 the counter sniper response team was deployed in the
- direction of sheets to look for a suspicious individual
- 16 using a rangefinder?
- 17 Witness The counter sniper team?
- 18 PSI Minority The counter sniper response team.
- 19 Witness I was not aware.
- 20 PSI Minority Good. Two questions. One I think, well
- 21 a statement. I think it's very disturbing from what you've
- 22 discussed and from your testimony that the item that was
- 23 discussed the most about your concerns 3:00 was ultimately
- 24 exploited by Crooks. I just think it's very disturbing.
- 25 And then the only question I have is, since we clearly



- 1 ID'd through your testimony from what you told us and
- 2 other things that through Operation Plan was flawed and
- 3 failed in some areas, from what you've told us, is July
- 4 13th ops an advance plan indicative of any current
- 5 practices or work product current or in the past from the
- 6 United States Secret Service? Is this the standard that is
- 7 produced from your knowledge?
- 8 Witness Are you talking about the paperwork that
- 9 --
- 10 **PSI Minority** The paperwork and the plan, the
- operation, the execute, the planning and execution of the
- 12 ops plan? Is that standard? Is this the product that we
- 13 get from the Secret Service, in your opinion, in your
- 14 experience?
- 15 Witness And what ops plan are you referring to?
- 16 **PSI Minority** The overall advance plan and the
- 17 execution of that, because if I'm not mistaken, deter,
- 18 detect, delay, defeat is your basic mission statement and
- 19 it failed.
- 20 So my question is, is what took place as far as the
- 21 planning and execution of that plan for July 13th, is that
- 22 current practices work product for the United States Secret
- 23 Service?
- 24 Witness I would say the Secret Service has zero
- 25 fail mission. So no, I would say that this is not a



- 1 typical practice of the Secret Service. And that I
- 2 think that this is a time where we're understaffed and
- 3 overworked.
- 4 PSI Minority That's all I have. Thank you.
- 5 HSGAC Minority And I just have a couple, just really,
- 6 really quick. You said there were lots of FBI after the
- 7 shooting. Did you recognize any of these agents when you
- 8 later had your FBI interview?
- 9 Witness I did not.
- 10 HSGAC Minority Were you aware of a call that came into
- 11 911 a threat to the venue?
- 12 Witness I was not aware.
- 13 **HSGAC Minority** Okay. So you're not aware of that being
- 14 communicated to Lead Agent ?
- Witness No. Okay.
- PSI Minority Two clarifications. You said private
- 17 security was hired by the Trump campaign. Did they
- 18 interact with Legal Secret Service at all?
- 19 Witness I interacted with them.
- MS. WITTMAN: Do you know if anybody else besides you
- 21 did?
- 22 Witness I do not know.
- PSI Minority How many individuals, if you know?
- 24 Witness One male and one female.
- 25 **HSGAC Minority** Do you know the name of the contractors?



- 1 Witness I do not know.
- 2 HSGAC Minority Is that documented anywhere?
- Witness Not in my documentation. I'm sure the
- 4 staff would know.
- 5 PSI Minority Second question. You said in response
- 6 to an earlier line of sight concern question that you were
- 7 raising that the concern was, "No. That's going to be in
- 8 my press shot." Who relayed that concern to you?
- 9 Witness Campaign Staff Lead .
- PSI Minority And who is Campaign Staff Lead
- 11 Witness He's the lead staff.
- PSI Minority Staff for the President's detail?
- 13 Witness The campaign. Sorry, Trump. Yeah.
- 14 PSI Majority Sorry. One follow-up question. How did
- 15 you interact with private security from former President
- 16 Trump's detail that they hired?
- 17 Witness I talked to them because I made sure that
- 18 I was waiting to leave the site until they got there and
- 19 that they were securing the site.
- 20 **PSI Majority** On email or phone?
- Witness No, in person.
- PSI Majority Oh, in person?
- Witness Mm-hmm.
- HSGAC Majority Okay. this concludes our interview. Ms.
- Witness I want to thank you very much. We greatly



- 1 appreciate your time today. I know this was lengthy.
- 2 Counsel, I want to extend our thanks to you and the counsel
- 3 on the line as well.
- I want to quickly make a couple of points. We were
- 5 given, as I said at the beginning new information and
- 6 documents 20 minutes before this interview started. We've
- 7 also requested of counsel both that they provide dates of
- 8 the interviews with the Secret Service Inspection Division,
- 9 photographs that Witness took and any other
- 10 communications that predate 7/13. We'd ask for those
- 11 expeditiously and any other responsive documents that are
- 12 responsive to our July 24th request.
- Given this outstanding information and the new
- 14 information we received in advance of this event, we
- 15 reserve the right to discuss additional questions we may
- 16 have with you and we'll contact DHS and Secret Service to
- 17 discuss that should the need arise.
- With that, this interview is concluded. Again, thank
- 19 you both.
