

## Homeland Security and Governmental Affairs Committee Advances Bipartisan Legislation

**WASHINGTON, D.C.** – U.S. Senators Gary Peters (D-MI) and Rand Paul (R-KY), Chairman and Ranking Member of the Senate Homeland Security and Governmental Affairs Committee, announced the committee advanced 10 bipartisan bills and 4 postal naming bills during a business meeting on Wednesday.
