7	(a) In General.—Section 1125 of title 31, Unite	ed
8	States Code, is amended—	
9	(1) by redesignating subsection (c) as sub-	<b>)-</b>
10	section (d);	

1	(2) by striking subsections (a) and (b) and in-
2	serting the following:
3	"(a) Definitions.—In this section:
4	"(1) Budget justification materials.—
5	The term 'budget justification materials' has the
6	meaning given the term in section 3(b)(2) of the
7	Federal Funding Accountability and Transparency
8	Act of 2006 (31 U.S.C. 6101 note; Public Law 109–
9	282).
10	"(2) RECURRING PLAN OR REPORT.—The term
11	'recurring plan or report'—
12	"(A) means any plan or report submitted
13	to Congress by not less than 1 agency on a re-
14	curring basis—
15	"(i) in accordance with Federal law;
16	or
17	"(ii) at the direction of a congres-
18	sional report; and
19	"(B) does not include any plan or report
20	that is required to be submitted to the Com-
21	mittee on Armed Services of the Senate.
22	"(3) Relevant congressional com-
23	MITTEE.—The term 'relevant congressional com-
24	mittee' means a congressional committee to which a
25	recurring plan or report is required to be submitted.

1	"(b) AGENCY IDENTIFICATION OF UNNECESSARY
2	Reports.—
3	"(1) In general.—The head of each agency
4	shall include in the budget justification materials of
5	the agency—
6	"(A) subject to paragraph (2), a list of
7	each recurring plan or report submitted by the
8	agency that the head of the agency determines
9	to be outdated or duplicative;
10	"(B) with respect to each recurring plan or
11	report described in subparagraph (A)—
12	"(i) a recommendation on whether to
13	sunset, modify, consolidate, or reduce the
14	frequency of the submission of the recur-
15	ring plan or report;
16	"(ii) a citation to each provision of
17	law or directive in a congressional report
18	that requires or requests the submission of
19	the recurring plan or report; and
20	"(iii) a list of the relevant congres-
21	sional committees for the recurring plan or
22	report; and
23	"(C) a justification explaining, with respect
24	to each recommendation described in subpara-

1	graph (B)(i) relating to a recurring plan or re-
2	port—
3	"(i) why the head of the agency made
4	the recommendation, which may include an
5	estimate of the resources expended by the
6	agency to prepare and submit the recur-
7	ring plan or report; and
8	"(ii) the understanding of the head of
9	the agency of the purpose of the recurring
10	plan or report.
11	"(2) Agency consultation.—
12	"(A) IN GENERAL.—In preparing the list
13	required under paragraph (1)(A), if, in submit-
14	ting a recurring plan or report, an agency is re-
15	quired to coordinate or consult with another
16	agency or entity, the head of the agency sub-
17	mitting the recurring plan or report shall con-
18	sult with the head of each agency or entity with
19	whom consultation or coordination is required.
20	"(B) Inclusion in list.—If, after a con-
21	sultation under subparagraph (A), the head of
22	each agency or entity consulted under that sub-
23	paragraph agrees that a recurring plan or re-
24	port is outdated or duplicative, the head of the

1	agency required to submit the recurring plan or
2	report shall—
3	"(i) include the recurring plan or re-
4	port in the list described in paragraph
5	(1)(A); and
6	"(ii) identify each agency or entity
7	with which the head of the agency is re-
8	quired to coordinate or consult in submit-
9	ting the recurring plan or report.
10	"(C) DISAGREEMENT.—If the head of any
11	agency or entity consulted under subparagraph
12	(A) does not agree that a recurring plan or re-
13	port is outdated or duplicative, the head of the
14	agency required to submit the recurring plan or
15	report shall not include the recurring plan or
16	report in the list described in paragraph (1)(A)
17	"(3) Government-wide or multi-agency
18	PLAN AND REPORT SUBMISSIONS.—With respect to
19	a recurring plan or report required to be submitted
20	by not less than 2 agencies, the Director of the Of-
21	fice of Management and Budget shall—
22	"(A) determine whether the requirement to
23	submit the recurring plan or report is outdated
24	or duplicative; and

1	"(B) make recommendations to Congress
2	accordingly.
3	"(c) Disposition of Recommendations.—
4	"(1) In General.—With respect to a rec-
5	ommendation on a recurring plan or report included
6	in budget justification materials by the head of an
7	agency under subsection (b)(1)(B)(i), the chair and
8	ranking member of each relevant congressional com-
9	mittee may—
10	"(A) in coordination with any other rel-
11	evant congressional committee, as necessary,
12	agree or disagree with the recommendation or
13	postpone a decision on the recommendation
14	and
15	"(B) notify each agency that submits a
16	recommendation of the disposition of the rec-
17	ommendation under subparagraph (A).
18	"(2) Legislative steps.—If a relevant con-
19	gressional committee agrees with an agency rec-
20	ommendation submitted under subsection
21	(b)(1)(B)(i), the relevant congressional committee
22	may take the necessary legislative steps to accom-
23	plish the recommendation, which may include con-
24	sulting with the agency that submits the recurring

1	plan or report that is the subject of the rec-
2	ommendation to prepare appropriate legislation.
3	"(3) Agency requirements.—Nothing in this
4	section shall be construed to relieve the head of an
5	agency from a requirement to submit a recurring
6	plan or report."; and
7	(3) in subsection (d), as so redesignated, by
8	striking "in the budget of the United States Govern-
9	ment, as provided by section 1105(a)(37)" and in-
10	serting "in the budget justification materials of each
11	agency".
12	(b) Budget Contents.—Section 1105(a) of title
13	31, United States Code, is amended by striking paragraph
14	(39).
