3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Fire Management As-

5 sistance Grants for Tribal Governments Act".

6 SEC. 2. INDIAN TRIBAL GOVERNMENT ELIGIBILITY.

7 (a) IN GENERAL.—Section 420 of the Robert T.
8 Stafford Disaster Relief and Emergency Assistance Act
9 (42 U.S.C. 5187) is amended—

10 (1) in subsection (a), by inserting ", Indian
11 tribal government," before "or local government";

1 (2) by redesignating subsections (b) through (e) 2 as subsections (c) through (f), respectively; 3 (3) by inserting after subsection (a) the fol-4 lowing: 5 "(b) PROCEDURE FOR REQUEST.—The Governor of a State or the Chief Executive of an Indian tribal govern-6 7 ment affected by a fire described in subsection (a) may 8 directly submit a request to authorize assistance under 9 this section."; and 10 (4) by adding at the end the following: 11 "(g) SAVINGS PROVISION.—Nothing in this section 12 shall prohibit an Indian tribal government from receiving 13 assistance under this section pursuant to an authorization made at the request of a State under subsection (b) if 14 15 assistance is not authorized under this section for the same incident based on a request by the Indian tribal gov-16 17 ernment under subsection (b).". 18 (b) REGULATIONS.— 19 (1) FIRE MANAGEMENT ASSISTANCE DECLARA-20 TION DEFINED.—In this subsection, the term "fire 21 management assistance declaration" means a dec-22 laration approved under section 204.21(a) of title 23 44, Code of Federal Regulations. 24 (2) UPDATE.—Not later than 1 year after the 25 date of enactment of this Act, the President shall

4	(3) CONTENTS.—In issuing the regulations re-
5	quired under paragraph (2), the President shall—
