On July 26, 2011, the Subcommittee on Contracting Oversight will hold a hearing on small business contracting. To assist the Subcommittee in preparing for this hearing, I request that you provide an anomaly report to the Subcommittee which compares the North American Industry Classification System (NAICS) code and the size determination in the Online Representations and Certifications Application (ORCA) database to the contract and the contracting officer's size determination in the Federal Procurement Data System (FPDS). Please provide this report for fiscal years 2005 through 2010.

I request that you provide this information as soon as possible, but in no case later than Tuesday, **July 8, 2011**.

The jurisdiction of the Subcommittee on Contracting Oversight is set forth in Senate Rule XXV clause 1(k); Senate Resolution 445 section 101 (108<sup>th</sup> Congress); and Senate Resolution 73 (111<sup>th</sup> Congress).
