The Subcommittee will review the information provided and will advise you on or before **Wednesday**, **April 16**, **2013** whether you will be invited to testify at the Subcommittee's hearing on April 24.

The jurisdiction of the Subcommittee on Financial and Contracting Oversight is set forth in Senate Rule XXV clause 1(k); Senate Resolution 445 section 101 (108th Congress); and Senate Resolution 64 (113th Congress). An attachment to this letter provides additional information about how to respond to the Subcommittee's request.
