Dear Admiral Greenert:

I am writing to request a briefing regarding contract management by the Navy's Space and Naval Warfare Systems Command (SPAWAR).

On December 7, 2012, I asked for information and documents regarding SPAWAR's management of the Smart/Jones Building contract and the software development contract for the Department of Defense Medical Review Board (DODMERB). On January 22, 2013, you informed me that the Navy has taken some concrete steps to address the management of these contracts. You also stated that SPAWAR is providing sustainment of the legacy system for DODMERB and is planning to develop an alternative proposal.

I remain concerned whether the Navy's response is sufficient to remedy the specific issues with the DODMERB contract, and the management challenges that were common to both contracts. I therefore request that Navy provide a briefing to the Subcommittee regarding SPAWAR and the DODMERB software development contract. At the briefing, the Navy should be prepared to discuss how it will address the DODMERB contract's cost overruns and the mediation requirements of the Interservice Support Agreement. The Navy should also be prepared to provide information regarding SPAWAR's status as a Navy Working Capital Fund activity and how this impacts how SPAWAR markets its services. I request that the Navy provide this briefing as soon as possible, but in no case later than **June 28, 2013**.

The jurisdiction of the Subcommittee on Financial and Contracting Oversight is set forth in Senate Rule XXV clause 1(k); Senate Resolution 445 section 101 (108th Congress); and Senate Resolution 64 (113th Congress).
