Dear Ms. Gustafson:

We are writing to invite you to testify before the Subcommittee on Financial and Contracting Oversight at a hearing entitled, "Oversight of Small Agencies." The hearing will be held on Thursday, April 10, 2014 at 10:00 A.M. in Room SD-342 of the Dirksen Senate Office Building.

Vigorous oversight by an independent inspector general is one of the federal government's most important tools to prevent and detect waste, fraud, and abuse of taxpayer dollars. The purpose of the hearing is to review the processes and mechanisms by which small agencies and other federal entities without statutory inspectors general receive oversight. The hearing will examine the process by which small agencies contract with independent inspectors general for services. The hearing will also explore the role of the Council of Inspectors General for Integrity and Efficiency (CIGIE) in ensuring that small agencies have adequate oversight. Finally, the hearing will examine potential legislative actions to improve the oversight of small agencies.

Your testimony should address the challenges faced by small agencies that do not have an inspector general. Your testimony should also address any resource and cost concerns for offices of inspector general that provide services to other agencies. In addition, your testimony should outline the role played by CIGIE in assisting small agencies with oversight requirements.

The Subcommittee requests that you summarize your testimony in 5 minutes, although a longer written statement may be submitted for the official record. This will allow adequate time for you to engage in questions and answers with members of the Subcommittee. **Subcommittee rules require that your testimony be submitted by no later than 10:00 A.M. on Tuesday, April 8, 2014.** Please send an electronic copy of your written statement and a brief one page biography to Subcommittee Clerk, Kelsey Stroud, at [Kelsey\\_Stroud@hsgac.senate.gov](mailto:Kelsey_Stroud@hsgac.senate.gov).
