Dear Mr. Fugate:

On Tuesday, September 9, 2014, the Committee on Homeland Security and Governmental Affairs will hold a hearing to examine the numerous programs that have allowed local law enforcement agencies to acquire military-grade equipment. To assist us in preparing for the hearing, we are writing to request information and documents regarding grant programs administered by the Federal Emergency Management Agency (FEMA) that may be used to fund state and local police agency equipment procurement. Specifically, we request that you provide the following:

- For the State Homeland Security Program (SHSP) and Urban Areas Security Initiative (UASI), a breakdown of the funding by states or designated regions for FY2011-FY2014;
- (2) Policies and procedures for the DHS grant programs. Please include guidance regarding what law enforcement agencies need to do to request funding, what items are eligible for purchase with the funding, how spending is tracked after funds distribution, oversight of the grant programs, and consequences for misuse of the programs;
- (3) A list of the every state agency or official who coordinates SHSP and UASI grants for its state or urban area;
- (4) A breakdown of the amount and percentages of grant money spent on planning, organization, equipment, training, and exercises;
- (5) An accounting of any monies recovered and returned to the U.S. Treasury from SHSP and UASI grant recipients for FY2008-20014, including the reason for recovery;
- (6) The amount of SHSP and UASI grant money assigned for FY2011-FY2014 to requests for the following items from the Authorized Equipment List: Body Armor 01LE-01-ARMR, -Ballistic Helmets 01LE-01-HLMT, Ballistic Shields 01LE-01-SHLD, Battle Dress Uniforms 01LE-02-BDUS, Boots 01LE-02-BOOT, Padding 01LE-02-PRPD, Mobile Command Vehicles 12VE-00-CMDV, Specialized Mission Vehicles 12VE-

- 00-MISS, Specialized Emergency Management Vehicles 12VE-00-SPEC, Tactical Entry Equipment 20TE-00-NTRY;
- (7) For FY2011-FY2014, the percentage of SHSP and UASI grant money that went towards sustaining existing state and local programs and the percentage used for the creation of new state and local programs;
- (8) For FY2011-FY2014, the percentage of applications for SHSP and UASI funding denied by FEMA or for which FEMA requested additional clarification before awarding funding. Please identify the percentage that were applications for equipment funding and whether the application included a request for relevant training as opposed to other program funds;
- (9) A description of how improvement in gaps found in the 31 core capabilities is assessed after the award of a grant. Please include in this description how an improvement in a core capability would affect FEMA's assessment of applications for future grants relating to the same capability;
- (10) A description of the new project-based requirements for grant requests;
- (11) A description of the past requirements for grant requests, prior to the implementation of project-based requirements;
- (12) A list of any equipment purchases granted outside of the Authorized Equipment List using SHSP or UASI grant funds for FY2011-FY2014, including the purchaser, quantity and type of equipment, and the justification for each exception;
- (13) For the SHSP and UASI grant offices, the number of FEMA full time employees, the number of contractors (if any) and the contract number under which they are employed, and a description of any disciplinary actions taken against FEMA employees or contractors for improper administration of grants, for FY2011, FY2012, and FY2013.

We request you provide this information as soon as possible, but no later than Wednesday, September 3, 2014. If the best available responsive document to any request above is available online, please provide URLs to those documents. If you determine that you will be unable to make a complete production by this date, please contact the staff named below to discuss possible modifications to this schedule. An attachment to this letter provides additional information about how to respond to the request.

The jurisdiction of the Subcommittee on Financial and Contracting Oversight is set forth in Senate Rule XXV clause 1(k); Senate Resolution 445 Section 101 (108th Congress); and Senate Resolution 64 (113th Congress).
