Dear Mr. Linick:

I am writing to request that you review the Central America Regional Security Initiative (CARSI).

As you are aware, CARSI was established in 2008 to support anti-corruption and counternarcotics initiatives, judicial reform, corrections reform, and crime prevention in Central America. The State Department and the U.S. Agency for International Development (USAID), which jointly manage CARSI, have allocated over \$642 million since its inception to support programs in Belize, Costa Roca, El Salvador, Guatemala, Honduras, Nicaragua, and Panama.²

In 2013, the Government Accountability Office (GAO) found that U.S. agencies, including the State Department, had failed to implement assessment measures to evaluate the effectiveness of CARSI initiatives.³ In response to this report, the State Department and USAID began developing a "comprehensive results framework" to compile results and evaluate the effectiveness of CARSI.⁴

I request that you assess the progress of the State Department's and USAID's efforts to implement measurable goals and metrics to understand the effectiveness of individual programs within CARSI. In particular, I request that you examine whether the goals and metrics are sufficient to measure the effectiveness of CARSI programs, whether the State Department and USAID are ending programs determined to be ineffective, and whether the CARSI program is effectively and judiciously allocating funds to support the Central American countries benefiting from CARSI.
