Dear County Executive Alsobrooks:

On May 16, 2019, authorities arrested Josue Rafael Fuentes-Ponce and Joel Ernesto Escobar—MS-13 gang members who entered the United States unlawfully—for the murder of a 14-year-old girl that was perpetrated with "extreme violence." Yesterday, the Department of Homeland Security revealed that, before this murder, Immigration and Customs Enforcement (ICE) officers asked local law enforcement to detain both individuals when they were arrested on other charges, including attempted murder, but local authorities instead released them back into the community without notifying ICE. I write to request additional information about these detention requests, and detainer requests generally, to better understand the failure of local law enforcement to honor ICE detainers and the potentially tragic effects that those decisions have on our communities.

Fuentes-Ponce is in the U.S. illegally.<sup>2</sup> Border Patrol apprehended Fuentes-Ponce in December 2015 as part of a family unit.<sup>3</sup> According to ICE, an immigration judge ordered Fuentes removed in absentia in March 2017, but he did not leave.<sup>4</sup> Border Patrol apprehended Escobar in August 2016 when he entered the U.S. unlawfully as an unaccompanied minor.<sup>5</sup> He was released to a family member in the Washington, D.C. area pending resolution of his immigration claims.<sup>6</sup>

On May 11, 2018, Prince George's County Police Department (PGCPD) arrested Fuentes-Ponce, Escobar, and others for attempted murder, kidnapping, attempted robbery, and gang activity.<sup>7</sup> ICE officers lodged a detainer with local authorities for both Fuentes-Ponce and

Escobar, but local authorities released both individuals "on an unknown date and time and without notification to ICE."

After their release, in April 2019 these MS-13 gang members, along with Ariana Funes-Diaz and at least one other person, kidnapped and robbed an unidentified man in the District of Colombia. Then, out of fear that Funes-Diaz may talk to law enforcement about the kidnapping, Fuentes-Ponce and Escobar murdered the 14-year-old girl. On May 16, 2019, PGCPD arrested Fuentes-Ponce and Escobar for the murder. I

To better understand the circumstances that led to this murder, please provide responses to the following no later than June 11, 2019:

- 1. When did Prince George's County (PG County) receive the detainer requests for Escobar and Fuentes-Ponce?
- 2. What did PG County do, if anything, after it received these requests? Did County officials forward the requests to other entities/facilities to which it sent Escobar and Fuentes-Ponce?
- 3. Provide all documents related to the arrest, detention, and transfer of Escobar and Fuentes-Ponce.
- 4. After receiving the detainer requests for Escobar and Fuentes-Ponce, did PG County respond to ICE? If not, why not?
- 5. What policy did PG County follow in allowing the county to release Escobar?
- 6. After this incident, is PG County reviewing that policy?
- 7. Since 2015, how many detainers has PG County received? Of those, how many did PG County grant or deny?

The Committee on Homeland Security and Governmental Affairs is authorized by Rule XXV of the Standing Rules of the Senate to investigate "the efficiency, economy, and effectiveness of all agencies and departments of the Government." Additionally, Senate Resolution 70 (116th Congress) authorizes the Committee to examine "the efficiency and economy of operations of all branches and functions of the Government with particular
